- Avoid using other non-standard adapters for this product,


Introduction

Pairing Your Light with Govee Home App

What You Need

- AWFi router supporting the 2.4GHz and 802.11b/g/n bands.
 5GHz s not supported.
- 1. Download Govee Home App from the App Store (10S) or Google Play (Android). Log in with your account (new users need to create an account)
- 2. Turn on the Bluetooth on your smartphone.
- 3. Open the app, tap the "+" ican in the top right corner and search for "H608C".
- 4. Tap the device icon and follow the on-screen instructions to complete pairing.



Controlling the Light with Your Voice

- 1. Open the app, then tap the device icon to enter the details page.
- 2. Tap the settings icon in the top right corner.
- 3. select "User Guide" and follow the on-screen instructions to control the device using your voice.

Troubleshooting

- 1. Cannot connect to Govee Home App.
 - a. Check if the light has been powered on.
 - b. Checkif your smartphone's Bluetooth has been turned on or try connecting the light to another smartphone.

- c. Ensure that your smartphone is near the light when connecting for the first time.
- d.Ifthe problem persists, go to the "My Devices" page to delete the device and follow the previous instructions to reconnect.
- 2. Cannot connect to Wi-Fi.
 - a. Checkif the light has been powered on.
 - b..Do not skip connecting to Wi-Fi during the pairing process.
 - c. Ensure that your Wi-Firouter is 2.4GHz capable (SGHz is not supported)
 - d. Ensure that you entered the correct WiFi password during. the Wi-Fi connection process,
 - e . Shorten the distance between the device and the Wi-Fi outer to less than SOft then try reconnecting.
 - f. Use another smartphone to pair with the device to check your Wi-Fi network is working.
- 3. Cannot pair or connect with Alexa or Google Assistant.
 - a. Ensure that the WI-Fi connection is stable.
 - b.Gotothe app's Settings page and follow the instructions under "User Guide" to pair the light again.
- 4. The light does not fully display the selected color/some LED beads do not light up.
 - a. Please contact the Govee support team for rapid product replacement.
