- IV Pole Warranty: 1 year
- All other components Warranty: 6 months

Product Information

The product is an IV Pole Mounting plate designed to be installed on the metal armrest mounting plate of a recliner. It includes a plastic cover plate for additional protection and aesthetic alignment. The product comes with a limited warranty that covers defects found within the warranty period.

Installation Instructions

1. Tools Needed: Phillips-head screwdriver
2. Locate the black plastic cover plate behind the right side arm of the recliner.
3. Remove the two screws from the cover plate.
4. Place the IV Pole Mounting plate over the metal armrest mounting plate and align the holes.
5. Place the plastic cover plate over the IV Pole mounting plate and align with the screw holes.
6. Secure the top screw tightly followed by the bottom screw.

Warranty Information

The limited warranty covers defects reported within the specified warranty period. The warranty is not transferable

and commences from the date of shipment to the original customer. Make sure to follow the warranty guidelines for obtaining warranty service.

Obtaining Warranty Service

Exclusions to warranty coverage include misuse, abuse, negligence, alteration, and failure to seek repair in a timely manner. Ensure proper installation, use, and maintenance as per the official manual to avoid warranty avoidance. Contact GF for warranty service.

FAQ

- **Q: What tools are needed for installation?**

A: You will need a Phillips-head screwdriver for installation.

- **Q: What is the warranty period for the IV Pole and other components?**

A: The IV Pole has a warranty of one year, while all other components have a warranty of six months.

INSTALLATION

Tools Needed: Phillips-head screwdriver

1. Locate black plastic cover plate (behind right side arm of recliner).
2. Remove the two screws from cover plate.



3. Place the IV Pole Mounting plate (included) over the metal armrest mounting plate and align the holes.



4. Place the plastic cover plate over the IV Pole mounting plate and align with the screw holes.
5. Secure the top screw tightly followed by the bottom screw.

OBTAINING WARRANTY SERVICE

a request to cs@grahamfield.com . Customers located outside the United States must contact the Distributor from whom they purchased the products. In both cases, further directions will be provided once the initial contact is made. This limited warranty shall only apply to defects that are reported within the applicable warranty period. Failure to abide by the specific directions will result in denial of the warranty claim.
