The Bluetooth adapter turns ordinary device (PS4/PS5, Switch CTV ModeJ , PC, MAC) into a Bluetooth-enabled device so that you can easily connect to devices such as Bluetooth speakers and Bluetooth headphones. This adapter uses the JL chip and supports Bluetooth 5.1, allowing a reliable connection up to 24Mbps transmission speed with a range of up to 15 meters. It's compatible with Windows XP/7 /8/10, macOS, PS4/5, Switch (TV Mode). It supports hot plug, which means you can insert or remove at any time.

## Operation Instruction

Plug in the USB port, the blue and red LED blink alternately, indicating that the device is in Bluetooth discovery mode. It will automatically pair with your Bluetooth device, and once the pairing is completed, the blue LED will remain on.
