

- 1. Battery: AAA\*2
- 2. For the first time need to Code, dispense with Code aftertime
- 3. Long press key together, "Forward" and "Back" more than 3 seconds.
- 4. Open body power, The LED turns on the success of the code.
- 5. Press key of Forward, Back, Left, Right to move the car accordingly.
- 6. Press key "P" braking, Led slow flashing, Press "P" again to release.
