#### **Product Information**

The VSB3918 DISH is a device that operates in the 2.4 GHz and 5GHz spectrum. It complies with FCC regulations regarding radiofrequency radiation exposure limits and interference. The device is manufactured under licenses from Dolby Laboratories and HDMILicensing Administrator, Inc.

# **Usage Instructions**

## **Safety Guidelines:**

To avoid potential hearing damage, refrain from listening at high levels for extended periods.

## **Antenna Positioning:**

Ensure that the antenna is positioned to maintain a minimum distance of 30cm (0.98ft) from the radiating element to prevent exposure to radio frequency energy.

# **FCC Compliance:**

Operate the device by FCC Part 15 regulations to avoid harmful interference. Do not modify the equipment without explicit approval as it may void your authority to operate the device.

## Trademarks:

Respect the trademarks and logos associated with HDMI and Dolby, as well as other brands mentioned in the user manual.

## FAQ:

- Q: How can I ensure the safety of using the VSB3918 DISH?
  - A: Follow the safety guidelines provided in the manual, especially regarding avoiding high volume levels for extended periods.
- Q: What should I do if I encounter interference while using the device?
  - A: Ensure that the device is operated in compliance with FCC regulations. If interference persists, contact customer support for assistance.

#### Installation and Safe Usage Instructions

- 1. Place the product on a flat surface.
- 2. Connect the manufacturer-supplied AC power adapter. The VSB3918 DISH requires the use of a 12 VDC, 2A power adapter in compliance with PS2 or LPS according to annex Q of UL 62368-1. Only use a manufacturer-supplied and approved power adapter. Always first plug the adapter lead into the VSB3918 DISH, then the AC adapter into the AC wall socket. If you do not follow this sequence for set-up, you may get an electric shock.
- 3. Connect the power adapter to the AC outlet by the markings on the identification label (voltage, current, and frequency of electricity network).

4. Optionally, connect the Ethernet cable to the RJ45/Ethernet ports. Then connect the other end of the Ethernet Cable to the Ethernet service device.

When using this device, basic safety precautions should always be followed to reduce the risk of fire, electric shock, and injury to persons including the following:

- 1. Do not use this product near water and avoid contact with moisture. For example, do not use it near a bathtub, wash bowl, kitchen sink, laundry tub, in a wet basement, or near a swimming pool. Care should be taken so that liquids are not spilled on this equipment.
- 2. This equipment is for indoor use only, do not place or install it in an outdoor location.
- 3. Do not overload wall outlets or extension cords. Doing so can result in the risk of fire or electrical shock.
