To enjoy HeWo (also called the audio player or the product) safely, we ask parents to handle the charger and keep it out of reach of children at all times.

- Keep children away from chargers as they pose a choking hazard, and the cord poses a strangulation hazard.
- Please use only a USB-C cable to charge this product.
- Avoid using the product while it is charging.
- Make sure this product is used in a well-ventilated environment.
- Avoid covering the product, especially during use. Place the product on a stable and flat surface during use.
- Keep your HeWo away from electrically conductive objects. especially pacemakers.

### **SAFETY INSTRUCTIONS:**

Avoid using the product if it is damaged or broken to prevent any malfunction or damage to the audio player.

#### Please strictly follow the guidelines below:

- Do not expose the audio player to water or moisture during use. If you need to clean it with a damp cloth, make sure to disconnect the USB-C cable and turn off the audio player first.
- USB charger must be regularly examined for potential damage. In case of damage stop using it.
- Keep the product away from heat sources; it is designed to operate reliably at normal ambient temperatures.
- Handle the product with care to avoid mechanical damage.
- Do not tamper with screws or attempt to disassemble the product. The physical components of the product are not user repairable.

## **Body-worn Operation**

This device was tested for typical body-worn operations. To comply with RF exposure requirements, a minimum separation distance of 0mm must be maintained between the user's body and the handset, including the antenna. Third-party belt-clips, holsters, and similar accessories used by this device should not contain any metallic components. Body-worn accessories that do not meet these requirements may not comply with RF exposure requirements and should be avoided. Use only the supplied or an approved antenna.
