## **Appearance**



#### **Enrollment**

- 1. Log in to the APP Store, download and install the App.
- 2. Power on the security control panel.
- 3. Log in the APP and tap the icon "+" . Scan the QR code or input the control panel serial No. to add the control panel.

## 1. Enroll the Peripheral Locally

- 1. In the APP, tap the "Enrollment Mode" button on the control panel page to make the control panel enter the enrollment status.
- 2. Trigger the peripheral, and it will be automatically enrolled to the control panel.

## 2. Enroll the Peripheral with QR Code and Serial No.


- 1. In the APP, tap the icon "+"and scan the QR code or serial No. on the peripheral.
- 2. Trigger the peripheral, and it will be automatically enrolled to the control panel.



## **Test**

Trigger the emergency button, and the LED indicates the operation result.

- 1. Button
- 2. Alarm Received



## **Replace Battery**

- 1. Pry the groove on the side of the panic button to open the rear sheet.
- 2. Replace the battery.
- 3. Close the rear sheet.



## **Formatting**

Remove the battery. Hold any button for 8 seconds and meanwhile put the battery in . The red LED flashes 3 times when the formatting is completed.

# Set up with App

You can view the device status including temperature, signal intensity, battery level, connection, 24-hour zone, and operation mode on the device page.

Tap the button to enter the settings page.

## **Operation Caution and Device Maintenance**
