
- 1. Indicator

- 5. Power Switch




INSTALLATION





- 1. Check signal strength.
- 2. Install the device.
 - a. Mount the detector with screw.
 - b. Mount the detector with sponge tape (non EN compliant).
- 3. (Optional)Install the device with bracket (ceiling bracket is non EN compliant).
