## Overview

The transmitter makes the third-party wired detectors be able to connect to the AXPRO intrusion alarm system. It supports tampering alarms and can supply power to the connected peripherals.

## **Appearance**

- 1. Battery Holder.
- 2. Enrollment Indicator.

Enrollment procedure: Solid green for 1s->Flashing red and green->Flashing green for 7 times

3. Alarm Indicator

Alarm: Solid red for 2s

4. Fault Indicator

Fault alarm: Solid amber

- 5. Zone input/Tamper input/AM or OUT/3.3V power
- 6. Power Switch.




