Paste the expander in the required place with sponge tape.

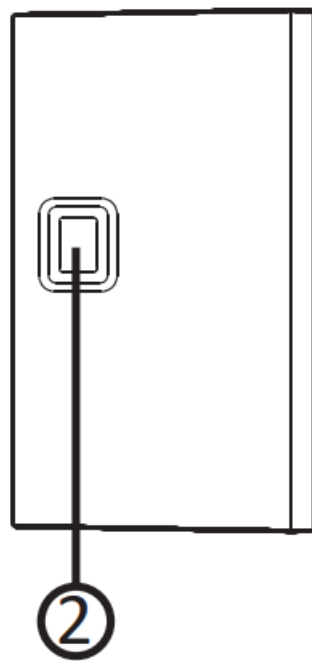
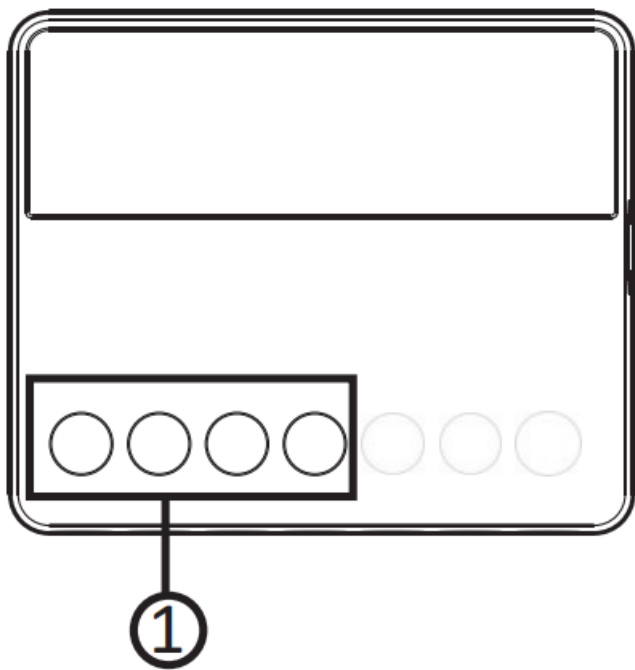
FORMATTING
