#### **Product Information**

- The Network Camera is a high-quality camera designed for outdoor use. It features a waterproof design,
  making it suitable for use in all weather conditions. The camera supports LAN and PoE interfaces, as well as
  DC12V and AC24V power inputs. The camera also comes with a MicroSD card slot for local storage.
- The Network Camera has an audio input and output interface, as well as alarm input and output interfaces. It also features an RS-485 interface and a BNC/CVBS interface for grounding.
- The camera complies with part 15 of the FCC Rules and operates under Industry Canada regulations. It is recommended to use an antenna of a type and maximum gain approved for the transmitter by Industry Canada to reduce potential radio interference to other users.


#### **Product Usage Instructions:**

- 1. Activate the camera by plugging it into a power source.
- 2. Connect the camera to your network using the LAN or PoE interface.
- 3. Insert a MicroSD card into the camera's MicroSD card slot to enable local storage.
- 4. Connect the camera's audio input and output interfaces to external speakers and microphones, if desired.
- 5. Connect the camera's alarm input and output interfaces to external alarm systems, if desired.
- 6. Ground the camera using the BNC/CVBS interface.
- 7. If necessary, adjust the camera's antenna to reduce potential radio interference to other users.
- 8. Access the camera's live feed using your preferred device or software.



# **Power Supply**

Device powered by Safety Extra-Low

Set up device time manually for the first time access if the local time is not synchronized with that of the network. Visit the device via Web browse/client software and go to time settings interface.

## Reflection

Make sure that no reflective surface is too close to the device lens. The IR light from the device may reflect back into the lens causing reflection.
