

Cable Description (Page 2 - A)




Notes:

The cables vary depending on different camera models.


- 1. Power Cord: Supports 12 VDC power supply.
- 2. Video Cable: Connect BNC Cable to test the video output.
- 3. RS-485
- 4. Alarm Cable: Connect terminal ALARM-IN with GND interface, and connect terminal ALARM-OUT with ALARM-COM interface.
- 5. Audio Cable: Connect terminal AUDIO-IN with GND interface.
- 6. Network Cable: Connect the network interface with network cable.


Install the Memory Card (Page 2 – B)

- ② Reset button: Press reset button for about 10 s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.















Remove the installation plate from the bottom of the camera (C1) and mount the camera on the ceiling or wall:










- 1. Install network cable waterproof jacket.



Installation
