





Fingerprint + Bluetooth Module




Fingerprint + Bluetooth + QR Code Module

- The peripheral module can be installed on the device module of DS-K1T673 series.


# Installation

1. Insert the module to the USB interface on the main device.



Take the fingerprint module as an example. You can choose different module according to your actual needs.

2. Secure the moudle on the device with 2 screws (M3).
