Module Model Name: BTM1

This module BTM1 is Bluetooth (BT) module that is compliant with the BT specification BR/BLE.

Electrical

Chipset: The module main chipset: SKY66407-11, BR8051A01, H2U34C1H1B0100

Supply: The module source all required power from a 3.3V +/- 0.1V input supply.

Environmental

Operating Temperature: The module operates across the temperature range of -30°to 50°Celsius

Conditions on using module BTM1:
