



# **Operating instructions**


1. Plug the USB-C end of your USB cable into the visualizer and insert the USB-A end into your computer. The status LED will light up, indicating a successful connection.




2. Your computer should automatically locate the visualizer. If it does not, please refer to the troubleshooting section of your guide.




3. Adjust the visualizer and camera to your preferred positioning.




4. To adjust the focus of your image, tap the autofocus button on your device.




5. To rotate your image 180°, tap the rotate button on your device.



6. To adjust the LED lighting, tap the light button on your device and choose your desired brightness settings from the three preset levels.




7. Before closing your visualizer, make sure to unplug the USB cable.

# **Troubleshooting**

#### Software Error

- · Restart the software.
- Uninstall and reinstall the software.

#### Computer cannot locate device after connected to the camera

- Unplug the USB cable and plug it back in or connect to a different USB port on your computer.
- Navigate to This PC>Manage>Device Manager and check if the camera is listed under "Image Devices."
- · Restart the software.
- Try with a different computer.

## · LED is not working

- Unplug the USB cable and plug it back in.
- Press the LED button and check if it is operating correctly.
