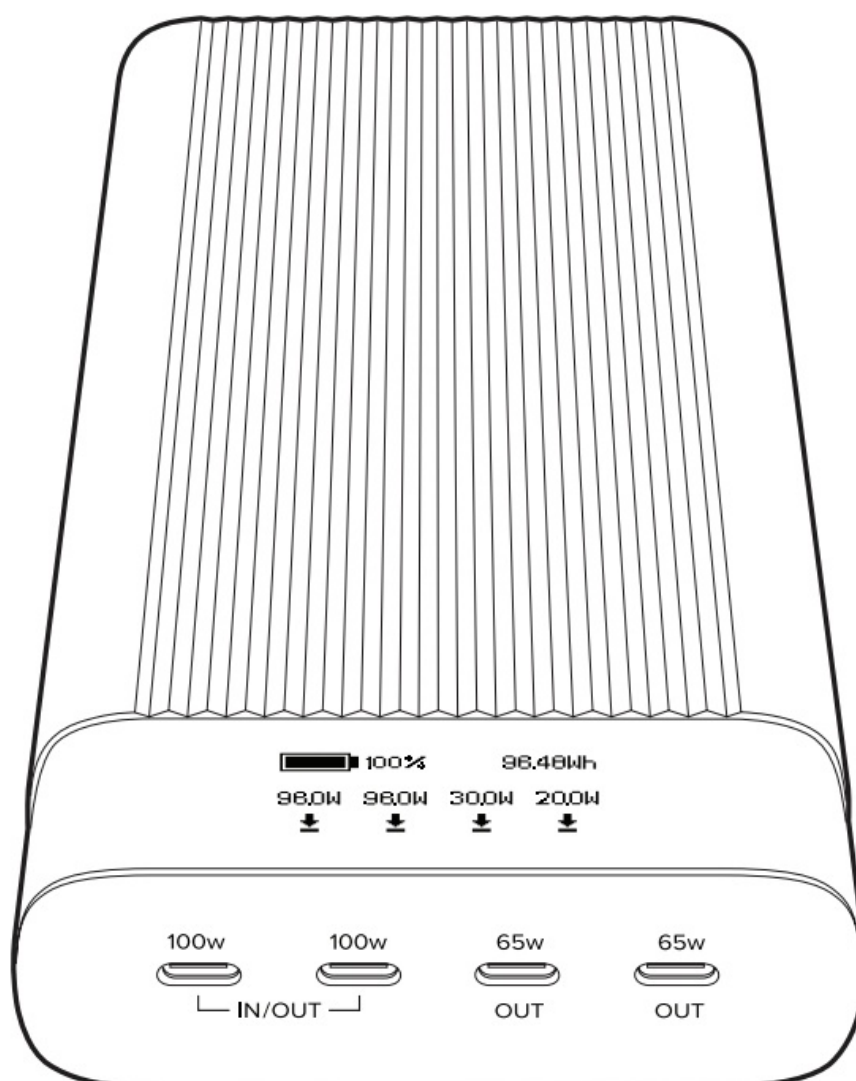

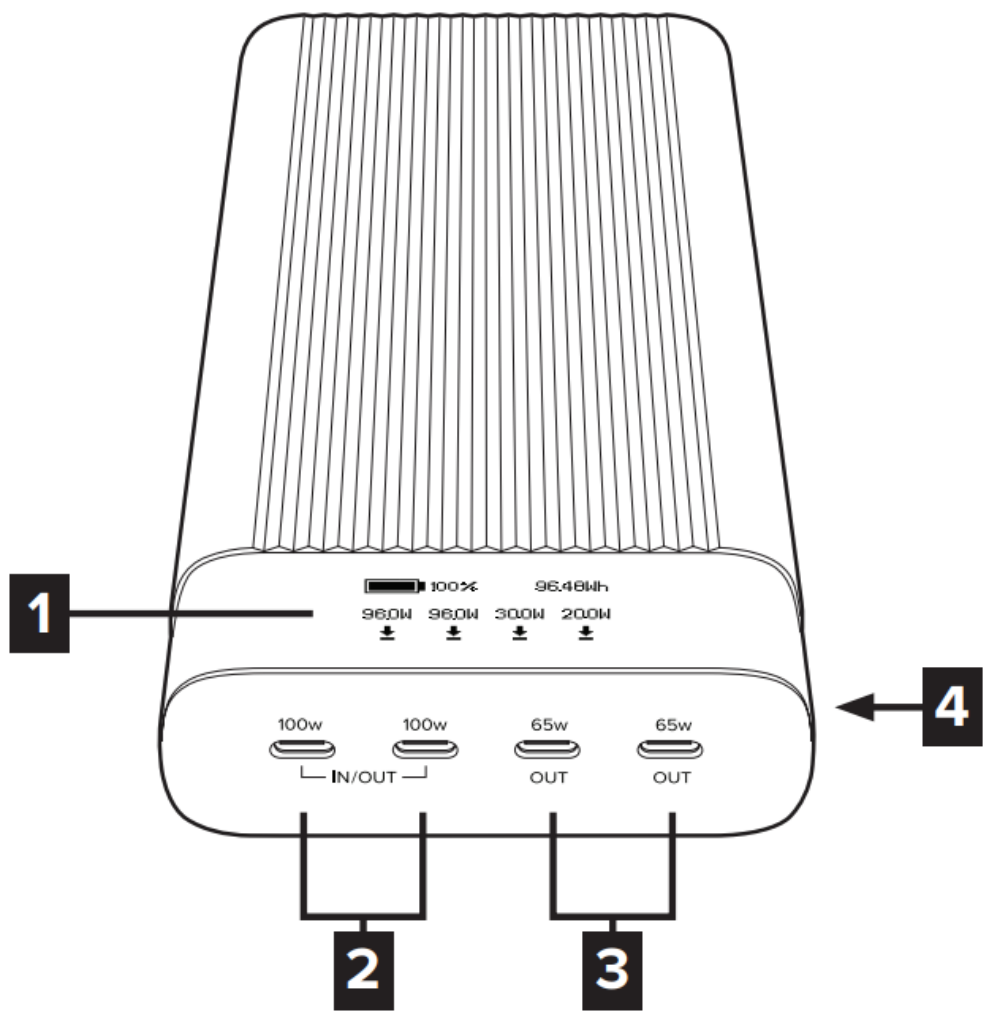

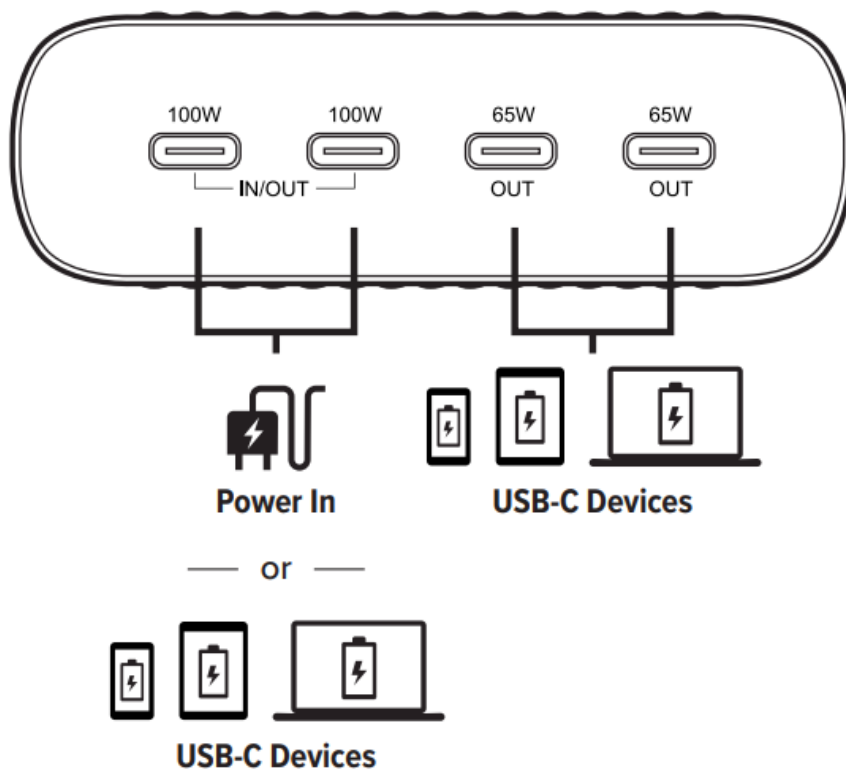

4. OLED Display On/Off Button	Allows you to turn on or turn off the OLED Display

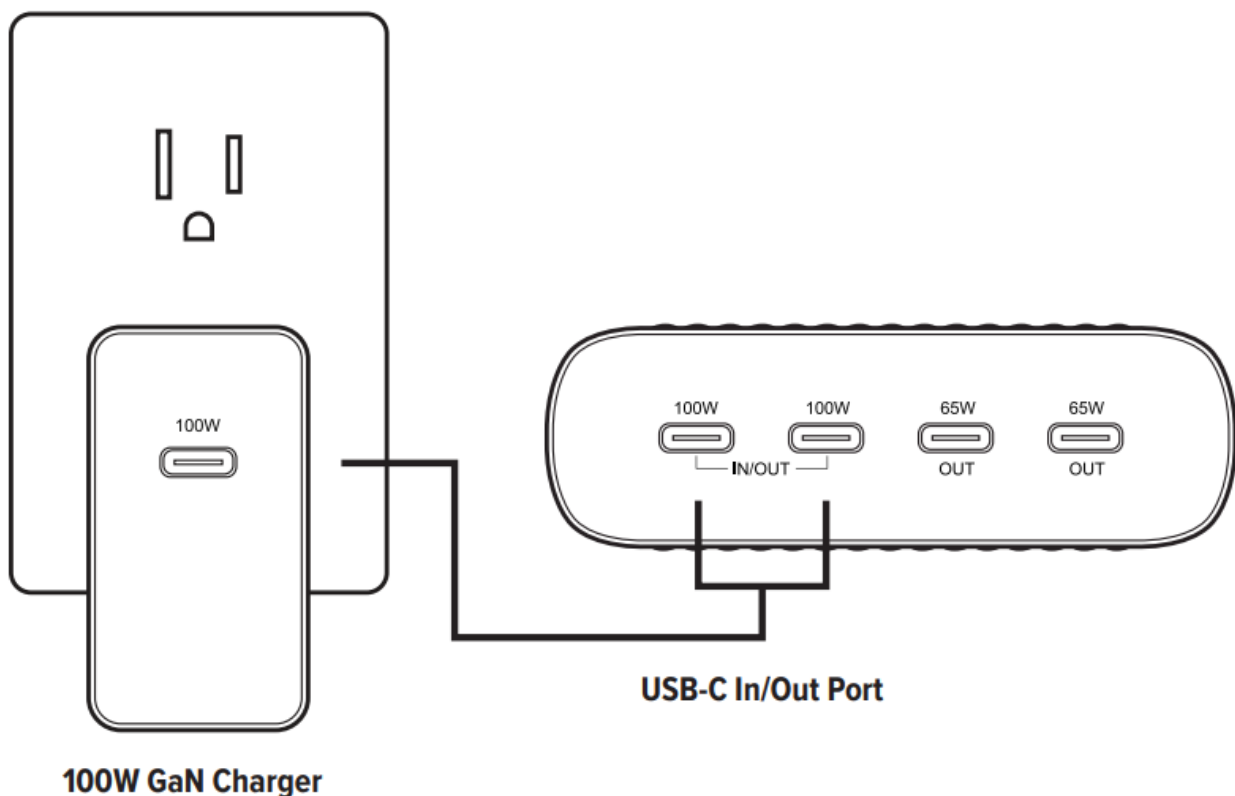


How to Connect



Recharging HyperJuice

100W USB-C PD charger is recommended for fast recharging of the Battery Pack. We'd suggest the HyperJuice 100W GaN Charger or the HyperJuice 245W GaN Desktop Charger.



Safety Instructions

- Store in a cool, dry place. Recommended storage temperature: -20°C/-4°F to 45°C/113°F (< 3 months); -20°C/-4°F to 25°C/77°F (< 12 months); Operating temperature: 0°C/32°F to 30°C/86°F.
- Do not disassemble or attempt to re-purpose or modify the product in any manner.
- Stop using and contact manufacturer if the product is excessively hot, is emitting odor, deformed or if you witness any other abnormalities.
