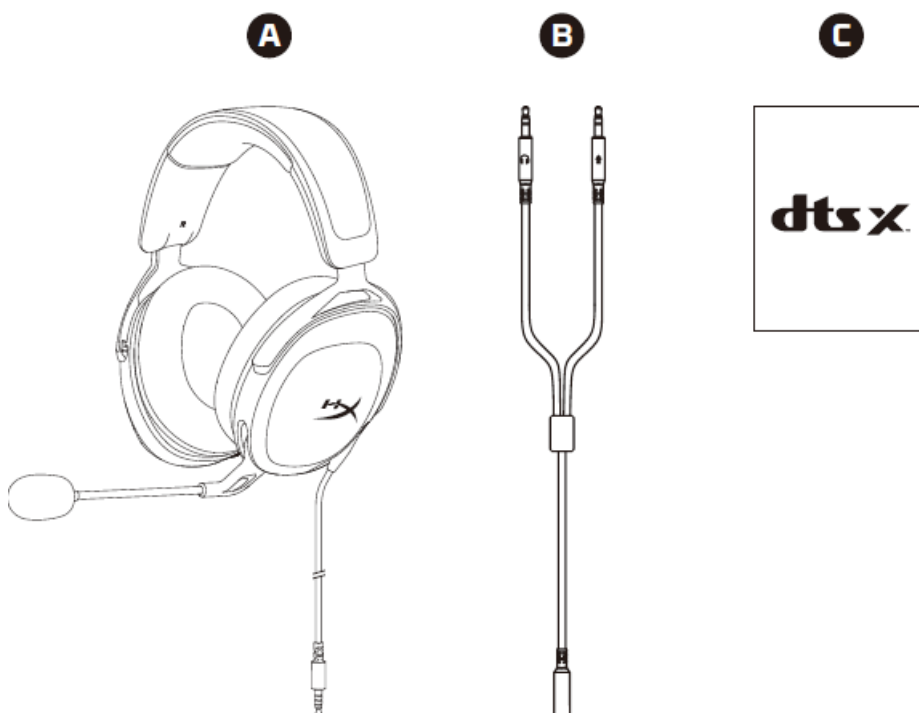

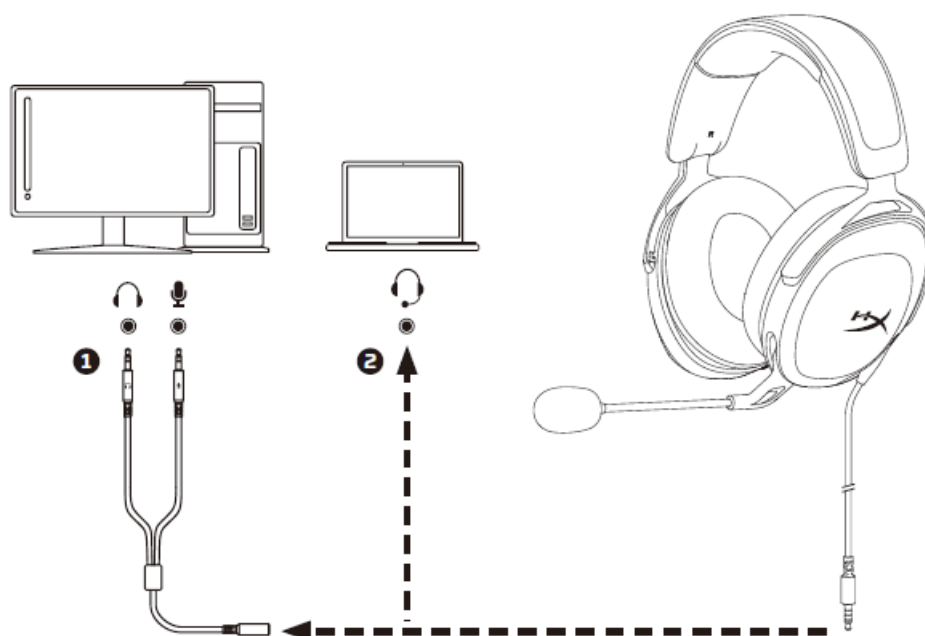

- **C** DTS Headphone: X instruction card

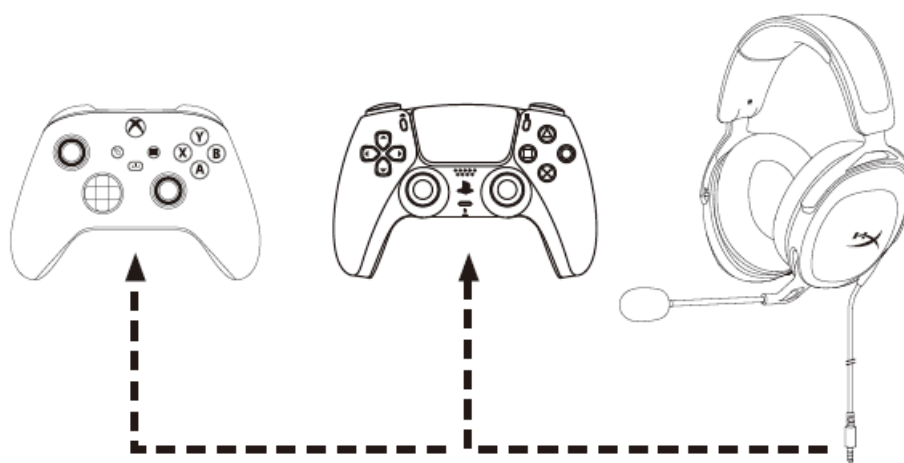

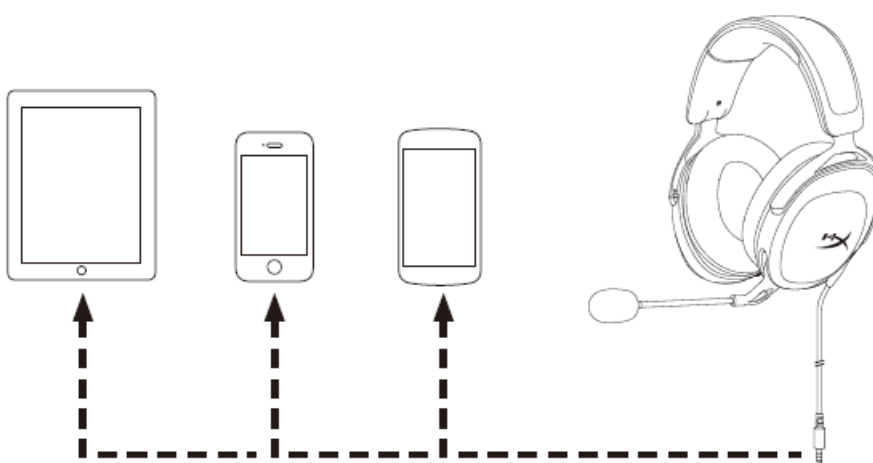

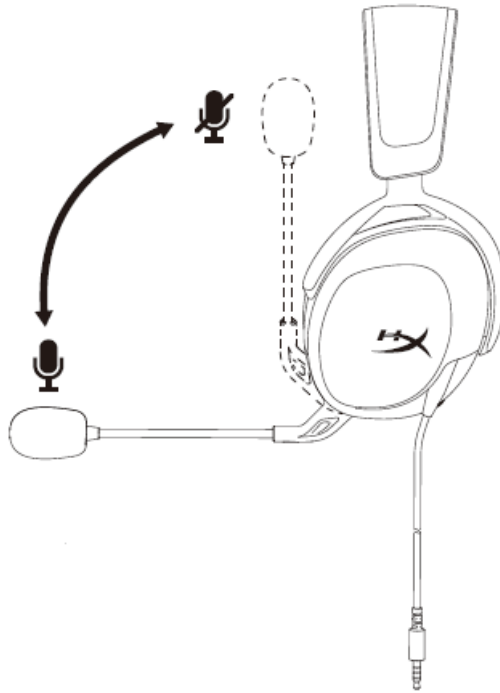
