#### **Product Information**

- The Network Disk Recorder is a professional-use device with the model number WJ-NX100/2E. It is designed
  for indoor use only and is equipped with functional earthing and grounding features. The device operates on
  both direct and alternating current power and has a polarity of d.c. power connector. It complies with part 15 of
  the FCC Rules in the U.S.A.

- The model number and serial number can be found on the surface of the unit for identification purposes.
- The device also meets the CAN ICES-3(A)/NMB-3(A) standards for Canada.
- For safety in the U.K., the device comes with a molded three-pin mains plug and a 5 amp fuse. The replacement fuse must have a rating of 5 amp and be approved by ASTA or BSI to BS1362. The plug should not be used if the fuse cover is lost, and a replacement cover can be obtained from a local dealer.

# **Product Usage Instructions**

#### **Connecting and Operating:**

- 1. Read the user manual carefully before attempting to connect or operate the product.
- 2. Ensure functional earthing or grounding as indicated by the symbols provided in the manual.
- 3. Use the included AC power adapter to power the device.

## Mounting the Recorder:

- 1. When installing the recorder on a wall, use the recommended M5, 10mm screws for installation.
- 2. Ensure a minimum pull-out strength of 196 N (44 lbf) for secure mounting.
- 3. The height of the recorder on the wall should not exceed 2 m (6.6 ft).

## **Fuse Replacement:**

#### Follow the instructions below to replace the fuse:

- 1. Identify the type of AC mains plug (Figure A or Figure B) used.
- 2. Using a screwdriver, open the fuse cover.
- 3. Replace the fuse with a new one.

4. Close or attach the fuse cover securely.

**Note:** Always ensure the device is disconnected from power before performing any maintenance or replacing fuses.



#### **Preface**

- The network disk recorders WJ-NX100/2E (hereinafter, recorder) equipped H.265 CODEC and are designed for use within a H.265 surveillance system, and record images/audio from up to 4 network cameras (hereinafter, cameras) on the hard disk drives (HDDs).
- This product has a built-in 2 TB HDD. In addition, one more HDD is expandable. With one more HDD added, two HDDs can be used in RAID1 mode.
- For more information about HDD for expansion, please contact your dealer.
- This recorder supports connection with a monitor equipped with the HDMI (High-Definition Multimedia Interface) connector. Connection using an HDMI cable (optional) offers display of playback/live images with superior quality.
- It is possible to display images from multiple cameras, switch those images and perform basic operation of the camera.

# **Features**

- The ports with PoE power supply function equipped
- The camera is equipped with four camera ports\*1 with PoE power supply function compliant with IEEE802.3af, so there is no need to prepare a separate PoE switching hub to connect the camera.
- Power cannot be supplied to the PoE+ camera. A separate power supply is required for the PoE+ camera.



They will reach the end of their lifetime after 30000 hours of operation if they have been used at the recommended ambient temperature (approx. +25 °C).
- To prevent data loss from disk crashes, it is recommended to keep the ambient operating temperature at approx. +25 °C and to replace them after around 18000 hours of operation.
- You can check the operating time of each HDD in "Operation" of the "HDD information" tab under "Maintenance" under "Advanced" from the setup menu.
- When hard disk drive trouble occurs, replace it immediately. Contact your dealer about servicing.

## About external storage devices (External HDD and USB memory)

- An external hard disk drive or a USB memory that is compatible with USB3.0 can be connected to the copy
  port to use as the external storage device.
- Use external storage devices formatted in exFAT, FAT (FAT16) or FAT32.
- USB media recognizable by the recorder can be formatted by the recorder. Refer to Operating Instructions (PDF) for the format procedure.
- External storage devices requiring password authentication or a special driver or using an encryption function

cannot be used.

## Prevent condensation from forming

- If this happens, it can cause malfunction.
- Leave it switched off for around 2 hours in the following cases.
- When this product is placed in an extremely humid place.
- When this product is placed in a room where a heater has just been turned on.
- When this product is moved from an air-conditioned room to a humid and high-temperature room.

#### About the monitor

 When displaying the same image on the PC monitor for a long time, it may cause image burn-in on the PC monitor.

# Cleaning



## 2. Operation indicator [OPERATE]

· Lights when the power is on.

## 3. Error indicator [ERROR]

- Blinks when an error that can become a problem for the recorder to run the system occurs.
- Blinks red: System error
- Blinks orange: Thermal error, cooling fan malfunction, etc.
- Shows a solid light when automatically reset from an error status.

# 4. Alarm indicator [ALARM]

• Blinks when an alarm occurs, and lights when the alarm output stops. This indicator will go off when the [Reset] button ( Operating Instructions (PDF)) is clicked.

## 5. Recording indicator [REC]

• Lights orange when recording is being performed.

## 6. [HDD1]/[HDD2] indicator







# When operating from a PC via a network

- Operation of the recorder can be made using a PC via a network. Up to 16 hosts (PCs) can access the recorder at the same time.
