


Before you get started, ensure that all the drivers required for your USB devices are installed. LEX = Local Extender, REX = Remote Extender

1. Place extenders where desired and connect the fiber cable to the Link ports LC on the LEX and REX.




Max 200m OM3 multimode fiber


2. Connect the LEX to the computers USB port using the included USB cable.



3. Power the LEX with the included 24V 1A AC adapter and tighten the locking ring.




4. Power the REX with the included 24 V .2.27A AC adapter and tighten the locking ring.



5. Attach USB devices to the REX.



6. Optional: Connect LEX and REX LAN ports to a network or device as necessary.
