- To power on the device, press and hold the Power Button. To power off, press and hold the Power Button, then confirm on the screen.

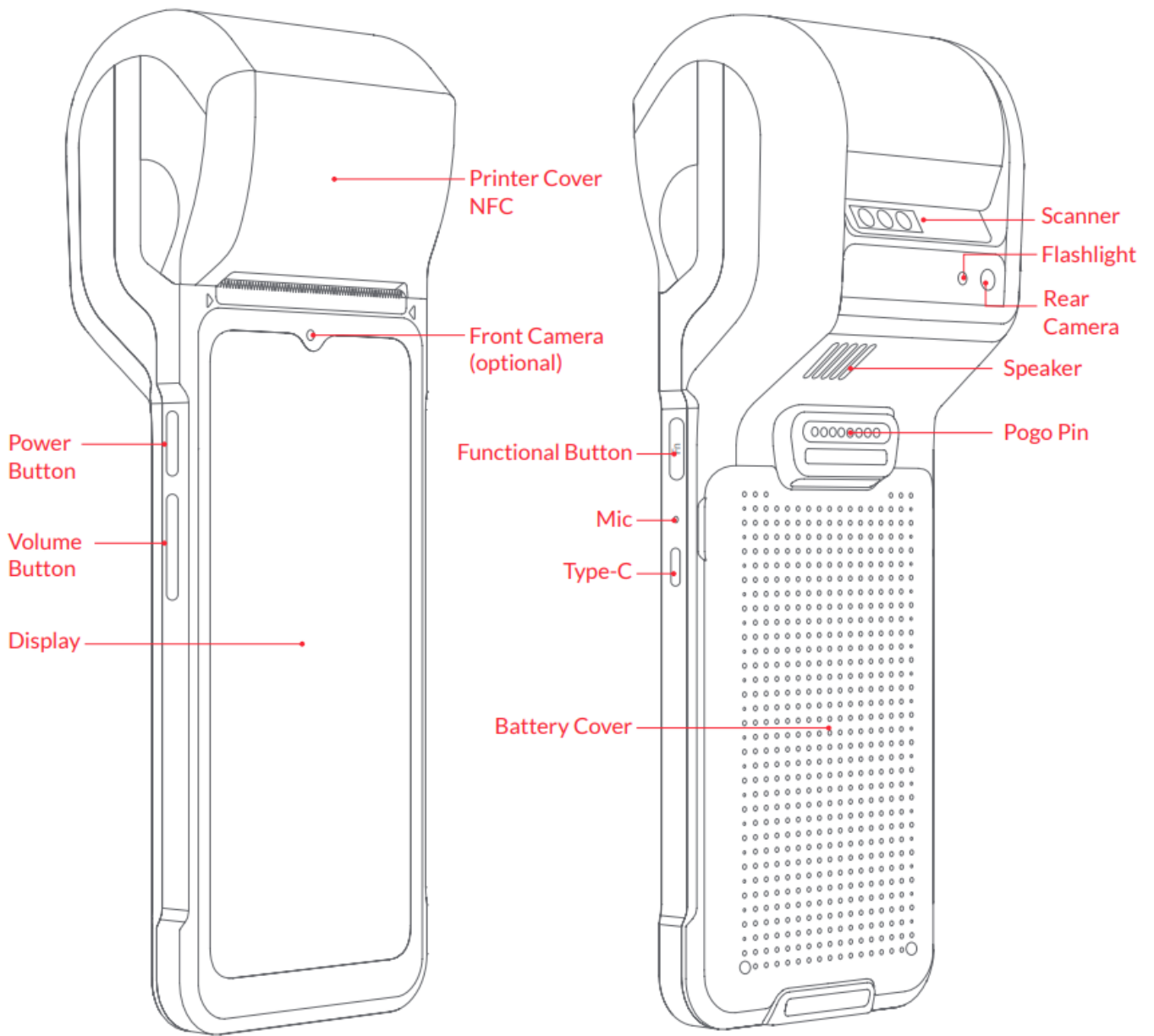
Volume Control

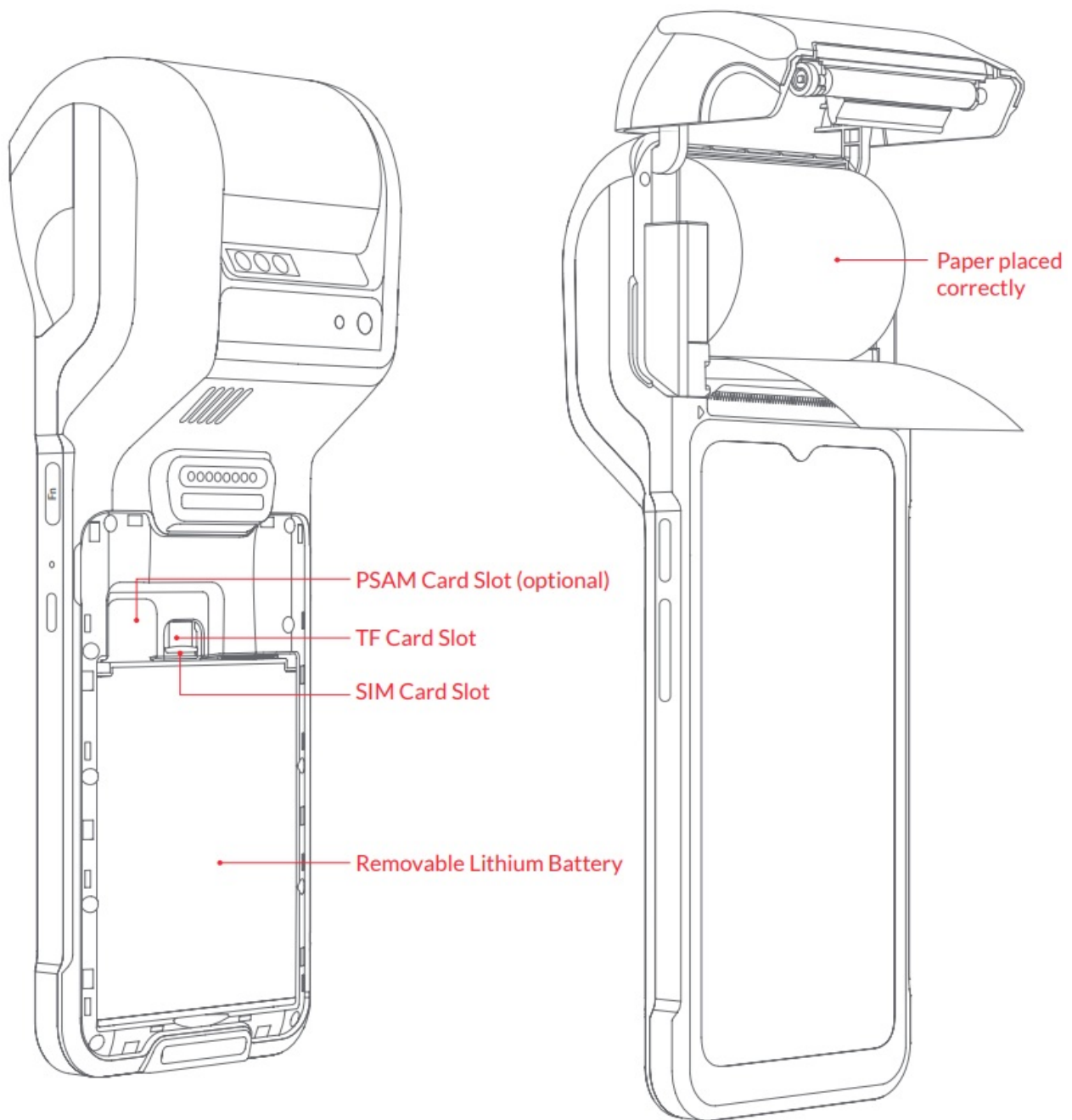
- Adjust the volume using the Volume Button located on the side of the device.

Display

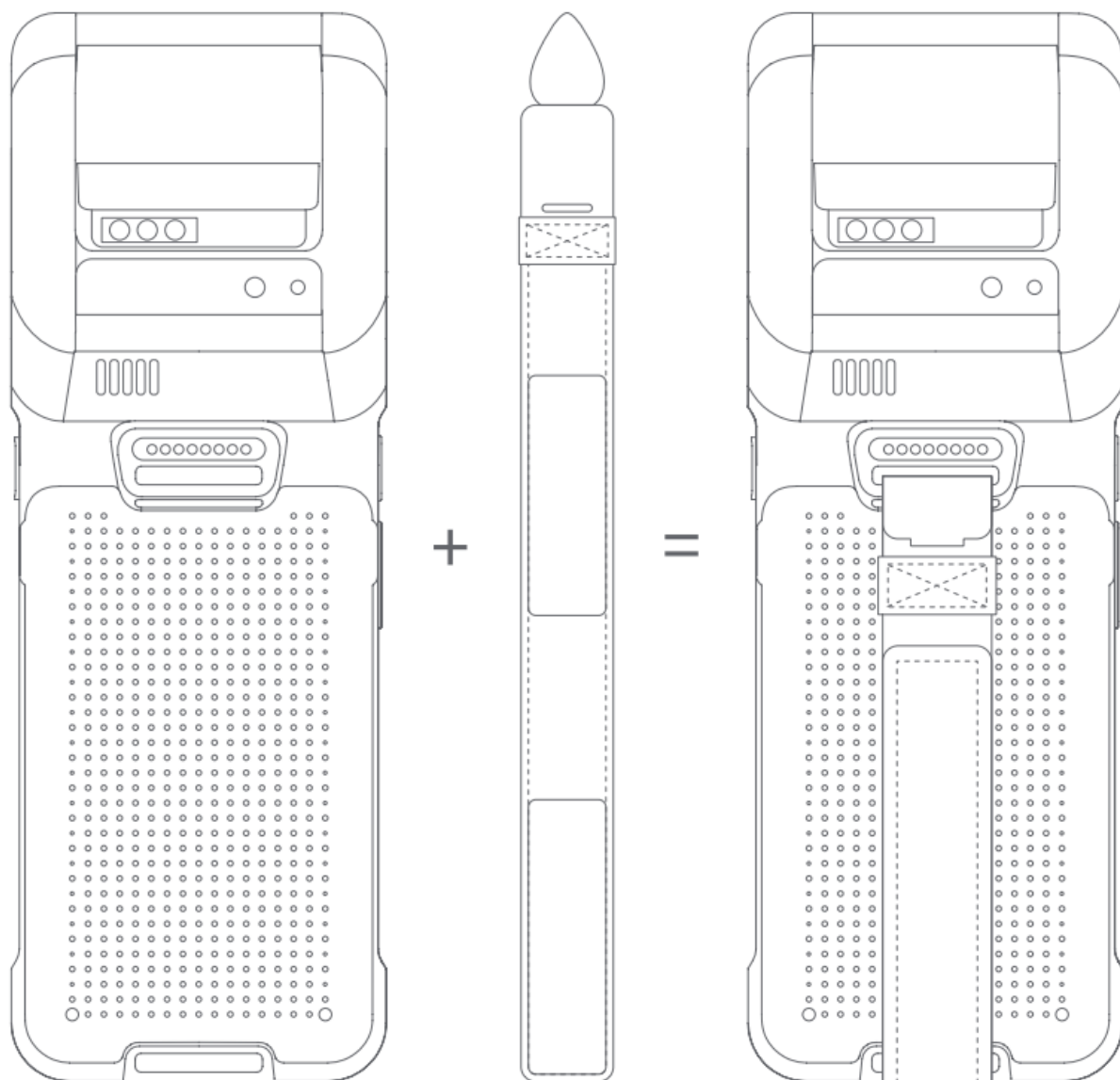
- The display provides visual feedback and information. Touch the screen to interact with the device.

- **Q: How do I charge the device?**
 - **A:** Connect the Power Adapter to the Type-C port on the device and plug it into a power source. The device will start charging automatically.
