# **LEDs**

The LED indicators make it easier to monitor the switch and its connections.

**NOTE:** Ports 1-8 can provide power to a connected powered device, and all powered devices should comply with IEEE 802.3at/af.

#### **Ports**

All RJ45 ports on the switch support Auto-MDI/MDI-X functionality, so you can use straight or crossover UTP/STP cables to connect the RJ45 ports to PCs, routers, hubs, other switches, etc. Cat5e/6 UTP/ STP cables provide optimal performance; if a status LED doesn't indicate a link or activity, check the corresponding device for proper setup and operation.

#### **Power**

Use the included power cord to connect the device (on the rear panel) to an AC outlet. Confirm that the Power LED on the front panel is lit.

## Installation

# Prior to use, it is recommended that the switch be placed/positioned:

- on a level surface that can support the weight of the switch;
- with at least 25 mm (approx. 1") of clearance for ventilation;
- away from sources of electrical noise: radios, transmitters, broadband amplifiers, etc.;
- within 100 m (approx. 328') of network devices it's to be connected to.
