- It supports USB 3.0 A to C for PC connection and USB 2.0 C to C for Android connection. The adapter also features a cold shoe mount for attaching accessories.

- If you want to mix audio from the HDMI source, use the Mic Mix HDMI feature.

## • For Android Connection:

- Connect the Live Capture Adapter to your Android device using the USBTM 2.0 C to C cable.
- If you want to attach any accessories, use the cold shoe mount.
- Connect the HDMI source to the HDMITM IN port on the adapter.

• If you want to mix audio from the HDMI source, use the Mic Mix HDMI feature.


- Q. Why isn't the captured sound synchronized with the sound on the headset?

- **A:** The smartphone may not be connected properly. Please confirm that the USBTM 2.0 C-to-C cable is used to connect the smartphone to the JVA02.


