



- Mount this product securely to prevent damage or injury in severe conditions.



JL Audio warrants these products to be free of defects in materials and workmanship from the original date of purchase for these periods:

One (1) year from the original date of purchase: Car Speakers and Subwoofers Two (2) years from the original date of purchase: Car Amplifiers, Electronics, Enclosed Sub woofers, Stealthbox and Connection Products

**Note:** The Car Amplifier Warranty Period Is extended to three (3) years when accompanied by the purchase of a qualifying JL Audio Amplifier Power Connection System and with installation by an authorized JL Audio dealer. This warranty is not transferable and applies only to the original retail purchaser from an authorized JL Audio dealer in the USA. Should service be necessary under this warranty for any reason due to manufacturing defect or malfunction, JL Audio will (at its discretion), repair or replace the defective product with new or remanufactured product at no charge.

**Note:** Products purchased from unauthorized dealers are not covered under warranty.

Damage caused by the following is not covered under warranty: accident, misuse, physical abuse, product modification or neglect, failure to follow Installation instructions, unauthorized repair attempts, and misrepresentations by the seller.

The customer is responsible for shipping charges and insurance in sending the product to JI Audio. Freight damage on returns is not covered under warranty.
