Warranty and Technical support

- **1 YEAR** UNIT EXCHANGE
- **10 YEARS** PARTS
- Unit must be installed by a licensed HVAC Technician to qualify for Limited Warranty.
- Register the unit for Limited Warranty within 90 days of installation at www.keplerx.net.
- If unit is not registered within 90 days of installation, Limited Warranty will be 5 years on parts.
- Unit exchange if compressor or coils failed within 1st year of installation.
- For troubleshooting and Error codes, please refer to our online resources. Error code explanations can be found at www.keplerx.net Find your unit model under our "Products" tab and click the "Troubleshooting Guide"

- If you are still in need of Technical Support or warranty assistance, prepare the following information before calling KEPLERX support at 1-888-493-0305 between the hours of 9am and 5pm eastern Time, Monday to Friday.
 - Model/serial number
 - Date of Unit installation
 - Installer's HVAC License Number
 - Place of purchase
- If it is determined that the unit is covered under the Limited Warranty and requires replacement parts, the parts will be provided at no cost, although shipping and handling will need to be covered by the client. If the unit is not yet registered, but is still within the 60-day registration period, we will require proof of purchase and proof of installation in order to register and complete the parts replacement request.

Should your KEPLERX brand UNITARY UNIT prove to be defective in material or workmanship under normal use during the warranty period listed below, effective from the date of original consumer purchase of the product, KEPLERX will replace the defective part(s). Replacement parts will meet intended fit and function of the original part. Replacement parts are warranted for unexpired portion of the original warranty period. This limited warranty is good only to the original purchaser of the product and effective only when used in the United States of America.

No other warranty is applicable to this product. This warranty is in lieu of any other warranty. Express or implied. Including without limitation, any warranty of merchant ability or fitness for a particular purpose. To the extent any implied warranty is required by law, it is limited in duration to the express warranty period above. Neither the manufacturer nor its U.S. distributor shall be liable for any incidental, consequential, indirect, special, or punitive damages of any nature, including without limitation, lost revenues or profits, or any other damage whether based in contract, tort, or otherwise.
