Ports



Direct attached storage (DAS) ports

Use the following ports when connecting Lyve Mobile Array to a computer:

A	Thunderbolt™ 3 (host) port —Connect to Windows and macOS computers.
B	Thunderbolt™ 3 (peripheral) port —Connect to peripheral devices.
D	Power input —Connect the power adapter (20V/13A).
E	Power button —See Direct-Attached Storage (DAS) Connections .

Seagate Lyve Rackmount Receiver ports

The following ports are used when Lyve Mobile Array is mounted in a Lyve Rackmount Receiver:

C	Lyve USM™ Connector (High Performance PCIe gen 3.0) —Transfer large amounts of data to your private or public cloud for efficient throughput up to 6GB/s on supported fabrics and networks.
D	Power input —Receive power when mounted in Rackmount Receiver.

Setup Requirements

Lyve Management Portal credentials

A Lyve Management Portal username and password are required to authorize computers to unlock and access Lyve Mobile Array and compatible devices.

Account manager—You created a Lyve Management Portal username and password when you set up your Lyve account at lyve.seagate.com.

Product admin or product user—You were identified as a product user for a project created in the Lyve Management Portal. An email was sent to you from the Lyve team that included a link for resetting your password.



If you can't remember your credentials or you lost your email invitation, visit lyve.seagate.com. Click **Sign in** and then click the **Don't remember your password?** link. If your email isn't recognized, contact your account manager. For further help, you can contact customer support using the Lyve Virtual Assist Chat.

Download Lyve Client

To unlock and access Lyve devices connected to your computer, you must enter your username and password in the Lyve Client app. You can also use it to manage Lyve projects and data operations. Install Lyve Client on any computer intended to connect to Lyve Mobile Array. Download the Lyve Client installer for Windows® or macOS® at www.seagate.com/support/lyve-client

Authorize host computers

An internet connection is required when authorizing a host computer.

1. Open Lyve Client on a computer intended to host Lyve Mobile Array.
2. When prompted, enter your Lyve Management Portal username and password.

Lyve Client authorizes the host computer to unlock and access Lyve devices and manage projects on the Lyve Management Portal.

The host computer remains authorized for up to 30 days, during which you can unlock and access connected devices even without an internet connection. After 30 days, you'll need to open Lyve Client on the computer and re-enter your credentials.



Lyve Mobile Array locks when powered off, ejected or unplugged from the host computer, or if the host computer goes to sleep. Use Lyve Client to unlock Lyve Mobile Array when it is reconnected to the host or the host has awakened from sleep. Note that Lyve Client must be open and the user must be signed in to use Lyve Mobile Array.

Connection Options



Lyve Mobile Array can be used as direct-attached storage. See [Direct-Attached Storage \(DAS\) Connections](#).



Lyve Mobile Array can also support connections via Fibre Channel, iSCSI and Serial Attached SCSI (SAS) connections using the Lyve Rackmount Receiver. For details, see the [Lyve Rackmount Receiver user manual](#).

Connexions au stockage à connexion directe (DAS)

Branchement de l'alimentation

Branchez le bloc d'alimentation inclus dans l'ordre suivant :

- Branchez le bloc d'alimentation sur l'entrée d'alimentation de Lyve Mobile Array.
- Branchez le câble d'alimentation sur le bloc d'alimentation.
- Branchez le câble d'alimentation sur une prise électrique.



Utilisez exclusivement le bloc d'alimentation fourni avec votre périphérique. Les blocs d'alimentation provenant d'autres périphériques Seagate et tiers peuvent endommager votre Lyve Mobile Array.

Connexion à l'ordinateur hôte

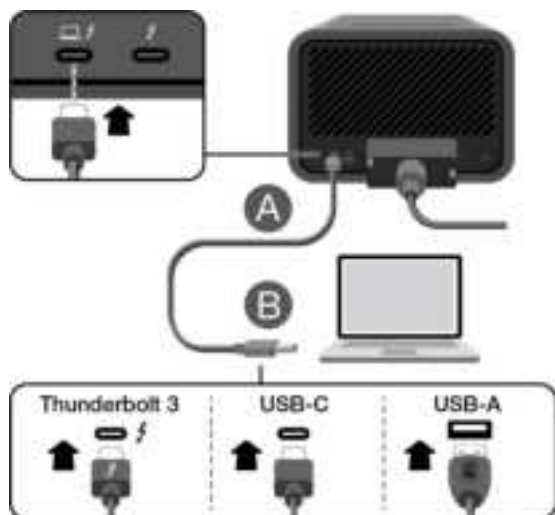

Connectez Lyve Mobile Array à un ordinateur dans l'ordre suivant :

- A. Connectez le câble Thunderbolt 3 au port hôte Thunderbolt 3 de Lyve Mobile Array situé sur le côté gauche du panneau arrière.
- B. Connectez l'autre extrémité au port correspondant sur l'ordinateur hôte.



Invite Windows : Approuver le périphérique Thunderbolt

Lorsque vous connectez un périphérique Lyve Mobile Array à un PC Windows compatible Thunderbolt 3 pour la première fois, vous pouvez être invité à authentifier le périphérique récemment connecté. Suivez les instructions à l'écran pour approuver la connexion Thunderbolt à Lyve Mobile Array. Déverrouillage du périphérique

Le voyant LED du périphérique clignote en blanc pendant le processus de démarrage, puis devient orange et fixe. Lorsque le voyant LED orange est fixe, cela indique que le périphérique est prêt à être déverrouillé.



Assurez-vous que l'application Lyve Client est en cours d'exécution sur l'ordinateur hôte. Ce dernier déverrouillera automatiquement le périphérique s'il s'y est déjà connecté et s'il y est toujours autorisé pour des raisons de sécurité. Si l'ordinateur hôte n'a jamais déverrouillé le périphérique, vous devrez saisir votre nom d'utilisateur et votre mot de passe Lyve Management Portal dans l'application Lyve Client. Voir [Conditions requises pour l'installation](#).

Une fois que Lyve Client a validé les autorisations pour le périphérique connecté à l'ordinateur, le voyant LED du périphérique devient vert. Le périphérique est déverrouillé et prêt à être utilisé.

Bouton d'alimentation

Mise sous tension : une connexion directe à un ordinateur n'est pas requise pour mettre Lyve Mobile Array sous tension. Il se met automatiquement sous tension lorsqu'il est connecté à une prise électrique.

Mise hors tension : avant de mettre Lyve Mobile Array hors tension, veillez à éjecter de manière sécurisée ses volumes de l'ordinateur hôte. Appuyez de façon prolongée (3 secondes) sur le bouton d'alimentation pour mettre Lyve Mobile Array hors tension.



Si Lyve Mobile Array est éteint, mais encore branché au secteur, vous pouvez rallumer Lyve Mobile Array en appuyant brièvement (1 seconde) sur le bouton d'alimentation.

Redémarrage lors d'un changement de type de connexion

Basculer d'un type de connexion DAS (Thunderbolt, USB ou adaptateur PCIe) à un autre peut empêcher l'affichage de certains volumes. Les utilisateurs Windows peuvent également recevoir une erreur sur un écran bleu.

Pour éviter ces problèmes, suivez la procédure ci-dessous au moment de changer de type de connexion :

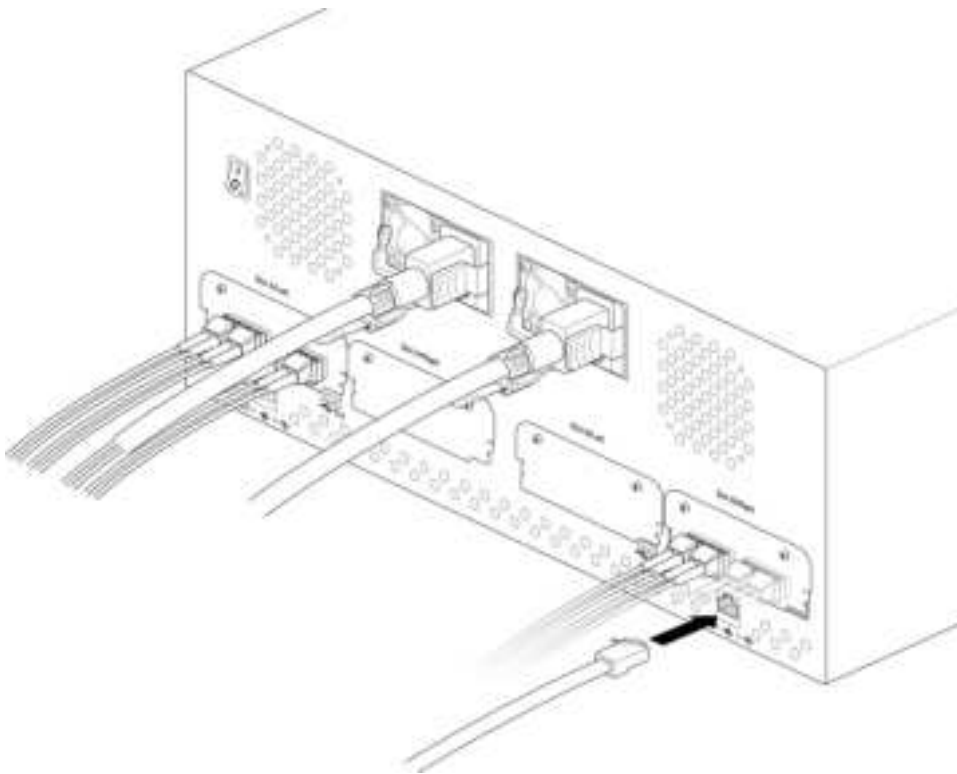
1. Retirez le volume de manière sécurisée.
2. Mettez le Lyve Mobile Array hors tension.
3. Effectuez le changement de connexion.
4. Mettez le Lyve Mobile Array sous tension.

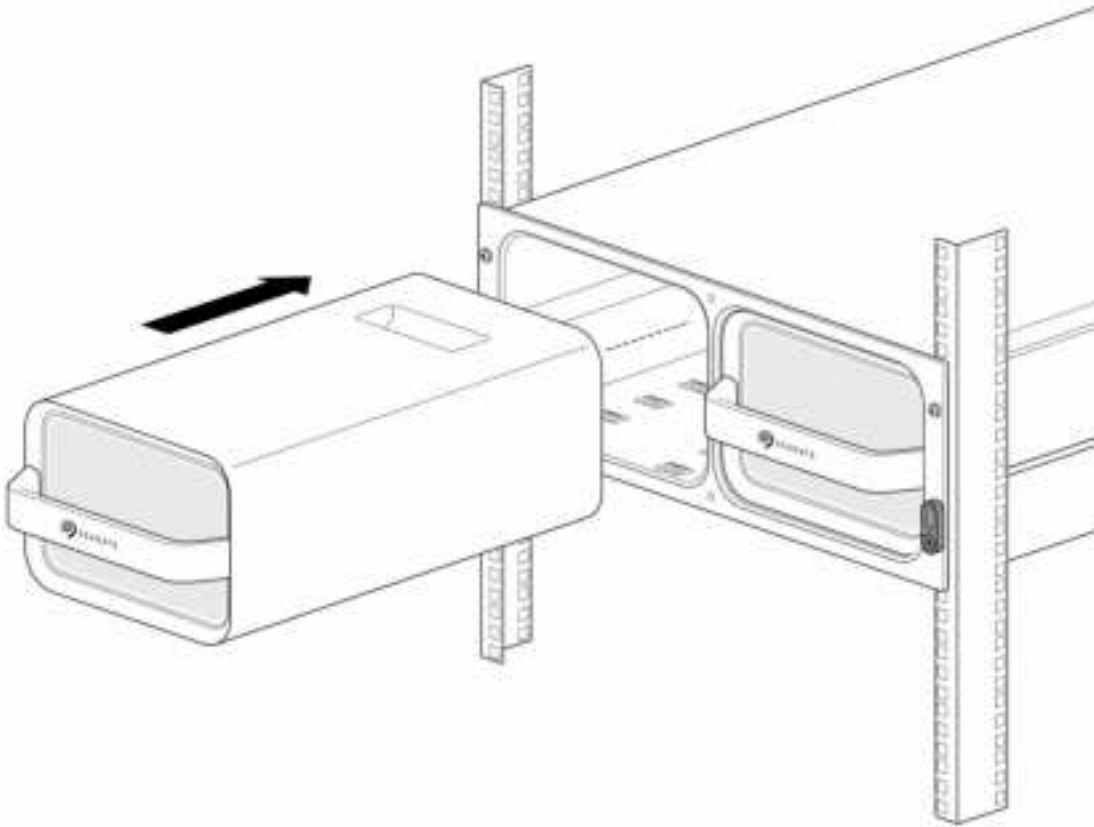
Connect Ethernet port

Lyve Client communicates with devices inserted in Lyve Rackmount Receiver via the Ethernet management ports. Ensure that the Ethernet management ports are connected to the same network as the host devices running Lyve Client. If no device is inserted in a slot, there's no need to connect its corresponding Ethernet management port to the network.



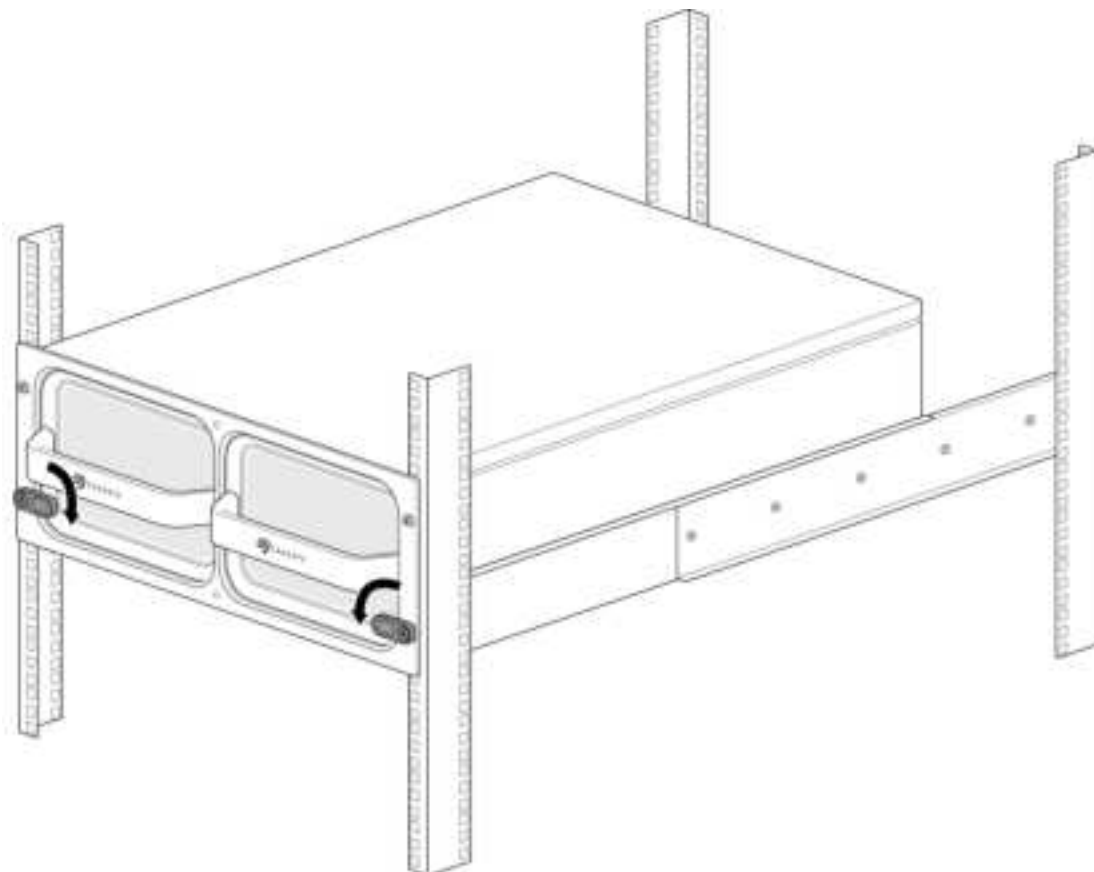
Connect Lyve Mobile Array

Insert Lyve Mobile Array into slot A or B on Rackmount Receiver.



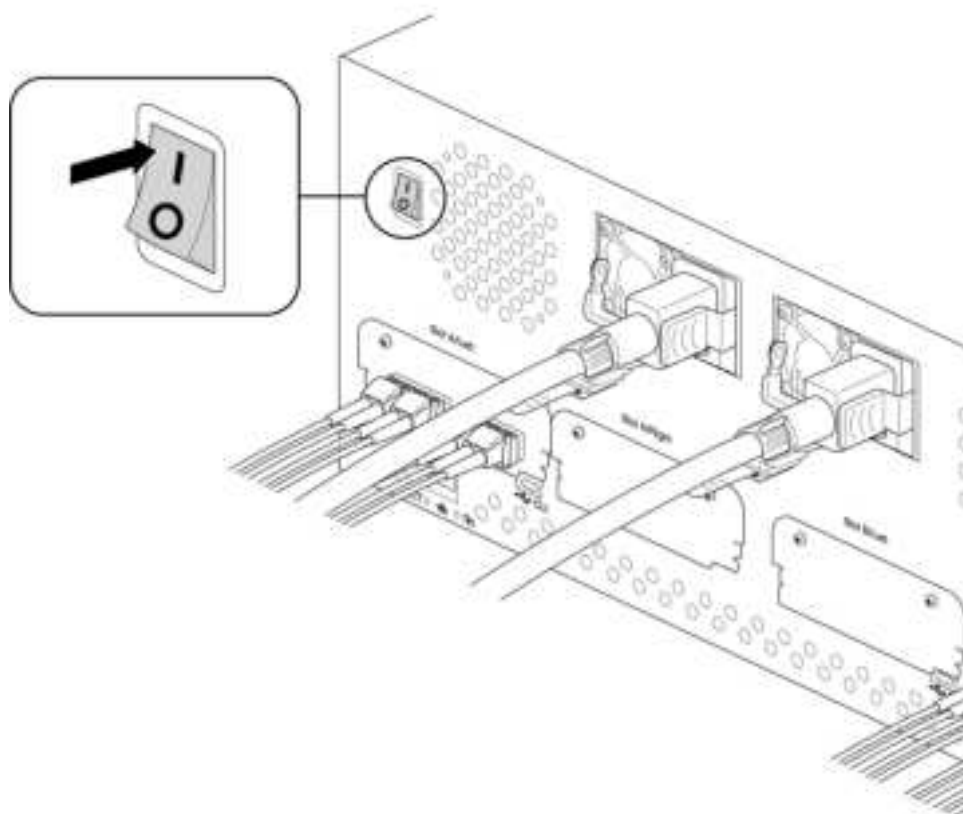
Slide device in until it's fully inserted and firmly connected to Rackmount Receiver's data and power.

Close latches.



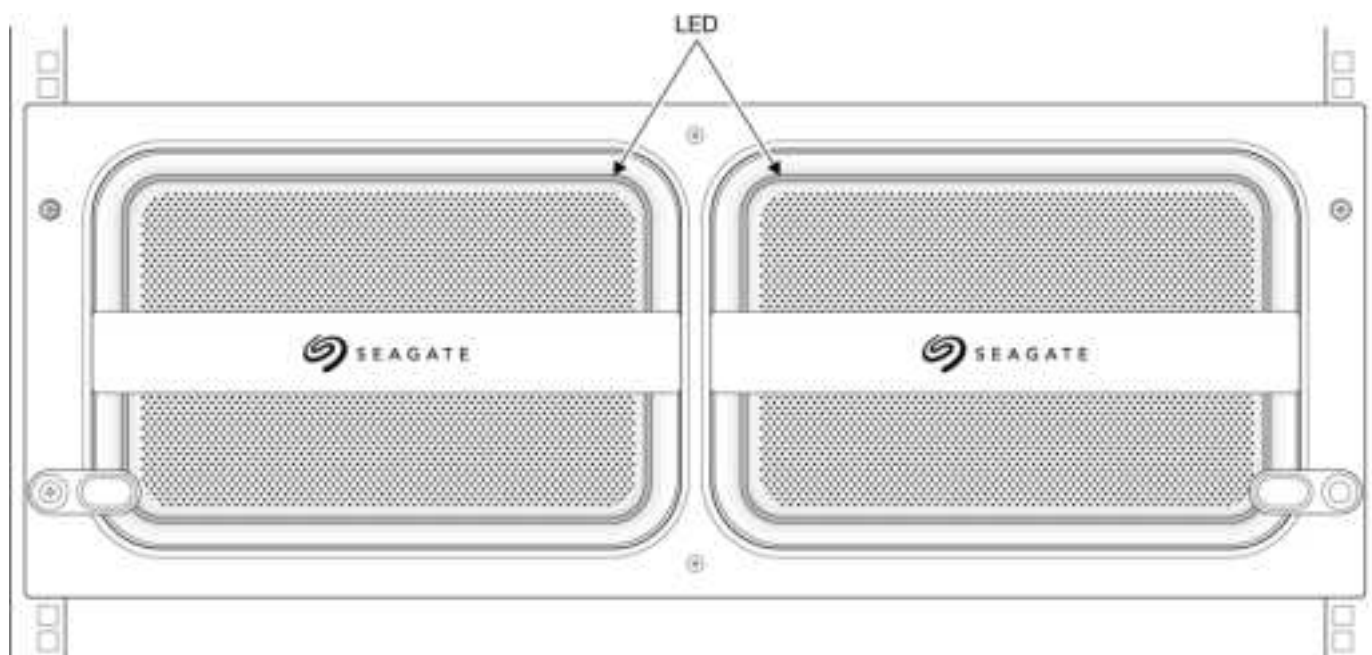
Turn on power

Set the power switch on Lyve Mobile Rackmount Receiver to ON.



Unlock the device

The LED on the device blinks white during the boot process and turns solid orange. The solid orange LED color indicates the device is ready to be unlocked.



Make sure the Lyve Client app is running on the host computer. The host computer will automatically unlock the device if it connected to it in the past and is still authorized for security. If the host computer has never unlocked the device, you will need to enter your Lyve Management Portal username and password in the Lyve Client app. See [Setup Requirements](#).

Once Lyve Client has validated permissions for the device connected to the computer, the LED on the device turns solid green. The device is unlocked and ready for use.

Status LED

The LED on the front of the enclosure indicates the device's status. See the key below for the color and animations associated with each status.

Lyve Mobile Shipper

A shipping case is included with Lyve Mobile Array.

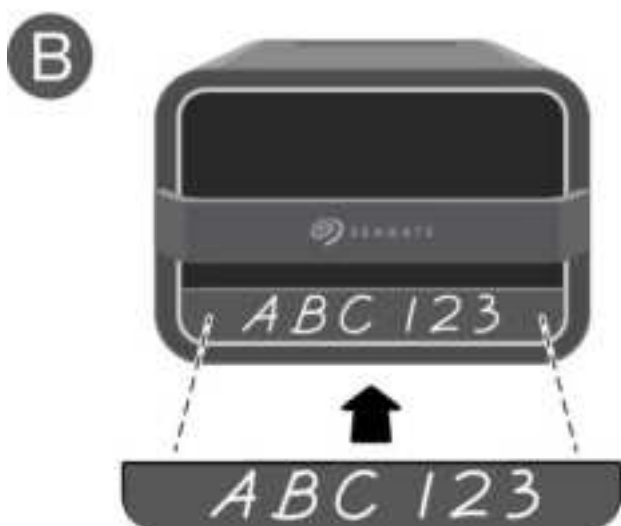
! Always use the case when transporting and shipping Lyve Mobile Array.

For additional security, fasten the included beaded security tie to Lyve Mobile Shipper. The recipient knows the case was not tampered with in transit if the tie remains intact.



Magnetic Labels

Magnetic labels can be placed on the front of Lyve Mobile Array to help identify individual devices. Use a marker or grease pencil to customize the labels.
