## Product Usage Instructions

### Remote Control Pairing

1. Pull the plug off.
2. Press the stop button until the gear lights flicker.
3. Pull the plug in when the remote controller is near the product.
4. The gear lights should stop flickering and stay lit to indicate successful pairing.

### H/C Massage

In the cleaning mode, press the hot and cold massage button to enable alternating hot and cold water temperature for cleaning. This function is available during buttocks cleaning and women washing.

### Nozzle Clean:

To clean the nozzle, press the nozzle cleaning button. The nozzle will extend, and you can use a cloth for cleaning.

### RF Warning:

The device complies with general RF exposure requirements and can be used in portable conditions without restrictions.

## FAQ

### 1. What should I do if the remote control pairing is unsuccessful?

If the pairing process fails, ensure that the remote controller is close to the product and follow the pairing steps carefully. If issues persist, contact customer support for assistance

## 2. Can I use the H/C massage function at any time?

The hot and cold massage function is available during buttocks cleaning and women washing modes. Ensure you are in the appropriate cleaning mode before using this function.

## 3. How often should I clean the nozzle?

We recommend cleaning the nozzle regularly for hygiene purposes. Depending on usage frequency, consider cleaning it at least once a week with a soft cloth.

### User Manual

The remote control is used for intelligent toilet operation control. Before use, it is necessary to check the code with the receiving device on the smart toilet.

Remote Control Pair Code: Pull the plug off → Press the stop button until the gear lights flicker → Pull the plug in when the remote controller near the product → The gear lights stop flicking and keep lighting → Successful.



The functions that can be operated on the smart toilet are as follows

### Flush

Press the “flush” button to flush the product

### Rear cleaning

- Press the “Rear” button. The cleaning water spurts out from the front of the nozzle, cleaning the buttocks in the previous way. Press again

### DRYER

- Press to activate the warm air dryer.
- Press again to adjust the fan speed.

### NIGHT LIGHT

- Press to turn the night light on/o .

### Stop

To stop the function of buttocks cleaning or women washing, press ” button or short press the knob button.※ hip cleaning and women’s washing, with automatic stop function after

### H/C massage In

the cleaning mode, press the hot and cold massage button to realize alternating hot and cold cleaning of water temperature. ※ this function can only be turned on/off for hot and cold massage during buttocks cleaning and women washing.

Nozzle Clean

Press the nozzle cleaning button, the nozzle is extended, and the cloth can be used for cleaning
