- 4. Place the speakers in a stable position to avoid fall and cause damage or personal injury.

- 5. Do not expose the product to direct sunlight for longer periods. High temperatures may shorten the life of the product, destroy the battery and distort certain plastic parts.
- 6. Do not expose the product to extreme cold as it may damage the internal circuit board.
- Rechargeable batteries have a limited number of charge cycles.
 Battery life and number of charge cycles varies by use and settings.
- 8. Avoid liquids getting into the product.
- 9. Before wiping with a dry cloth to clean the speakers, set the power switch to the off position and unplug the power cord from the power outlet.
- 10. Do not throw with or stamp on the product. This may damage the internal circuit board.
- 11. Do not try to disassemble the product. This must only be done by a professional.
- 12. Do not use concentrated chemical products or detergent to clean the product.
- 13. Keep the surface away from sharp things, as these may cause damage to the plastic parts.
- 14. Use 5V / 1A power supplies only. The connection of power supplies with higher voltage may lead to severe damage.
- 15. Do not arbitrarily discard or place the lithium battery near fire or intense heat in order to avoid a risk of explosion.
