Product Usage Instructions

Wireless Charging Method:

This product features a white LED indicator. When powered on, the LED will flicker and then turn off. Place the mobile device in the wireless charging area for charging. The LED indicator will remain on during the charging process, indicating charging is in progress. The phone will start charging automatically.

Light Usage of Cosmetic Mirror:

1. Press the touch button lightly to turn on the light.
2. For adjustable brightness, press and hold the touch button until the desired brightness is achieved.

3. Press the touch button again to turn off the light.
4. When using the 10x magnetic magnifying glass, maintain a distance of within 15 cm from the eyes to avoid vertigo.
5. While charging the mirror, a flashing red light indicates charging in progress, and a solid red light indicates full charge.

Points to Note:

- Read the product manual carefully before use.
- Avoid disassembling the device.
- Ensure correct placement of the 10x magnetic magnifying glass in the makeup mirror back recess.
- Use the company's charger for optimal performance and safety.
- Avoid placing objects with NFC or RFID chips between the phone and charger to prevent damage or performance degradation.

FAQ

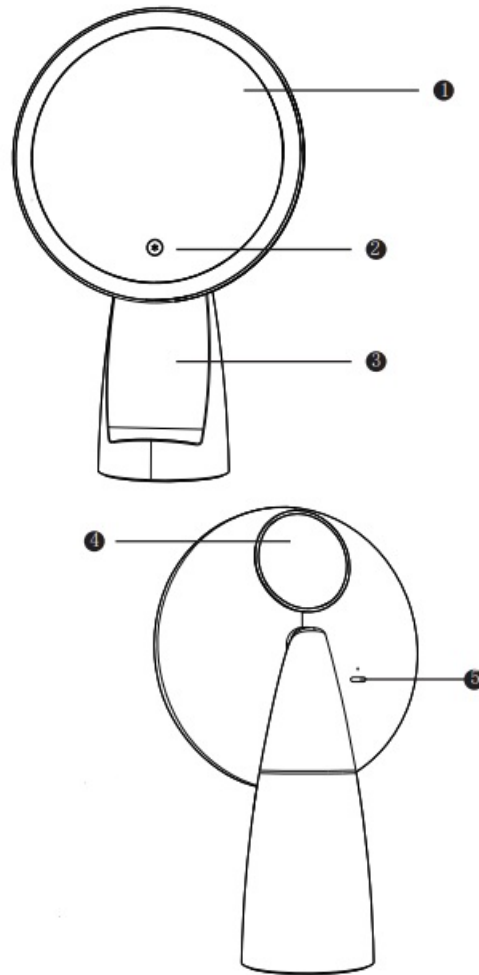
Q: What should I do if the LED indicator flashes during wireless charging?

A: If the LED indicator flashes, it may indicate that the device does not support wireless charging, there is foreign body interference, or overheating. Check for these issues and adjust placement accordingly.

Q: How long can the LED lighting last on a fully charged battery?

A: A fully charged battery can power the LED lighting for up to 2 hours without an external power supply. It is recommended to connect to a power supply for continuous use.

Wireless charging method

1. This product has 1 white LED indicator. When the power comes on, the LED lights flicker and then go out.
2. After electrifying, the mobile device for wireless charging shall be placed in the wireless charging area. During the charging process, the LED indicator light is always on.
3. The phone will start charging automatically.

Attention: When using the wireless charging function, if the LED indicator flashes, the device does not support wireless charging or there is foreign body interference between the device and the wireless charging surface, or overheating.

Light usage of the cosmetic mirror:

1. This product has a touch button, press it lightly and the light turns on.
2. Do not let go of the long touch button, light with the length of time, from dark to light, adjust to their own appropriate light, let go of fingers, makeup mirror light will not change.
3. Press the touch button again and the light goes off.
4. 10 X magnetic magnifying glass in use, please keep the distance between the eyes within 15 cm. Too far, distance will produce vertigo, which is the normal physical phenomenon
5. When charging the mirror, the red light flashes. When the mirror is fully charged, the red light is on.

Attention:

In the use of the process, LED brightness will decrease with the decrease in voltage. A fully charged battery can be used for LED lighting for up to 2 hours without a power supply. Therefore, in the cosmetic mirror LED lighting use, the best connection on the power supply.

Points to note:

- Before using this product, please be sure to read the product manual carefully, and according to the instructions of the use of the correct operation.
- Do not disassemble the device by yourself. This product is not equipped with any self-disassembly/maintenance parts.
- 10 x magnetic magnifying glass in use, placed in the makeup mirror back recess (indicated picture ©). After use, please tar down the magnifying glass to prevent the mirror from falling down and damaging.
- The wireless charger has multiple protection functions. When the charging is abnormal, check the status of the mobile phone and place the mobile phone again after handling.
- In order to give full play to the best charging performance, the use of the company's Charger is recommended.
- If the mobile phone is not placed correctly, it may lead to the mobile phone can not be charged properly.
- Don't put anything between the phone and the charger. Attention: Placing a magnetic stand, protective case, metal or room card, bus card, bank card, passport or other items with an NFC or RFID chip between the phone and the charger may degrade the Charger's performance, cause fever and even damage to articles.
- Please stop using the product immediately if there is any abnormal fever.
