Installation Guidelines

For smooth installation, please prepare the following items:

1. Connecting cables, such as network cable, etc.
2. Related devices, such as electrical outlets, HUB, switch, router, etc.

The installation environment for the switch must meet the following requirements:

1. The switch must avoid direct sunlight, away from heat and sources of strong electromagnetic interference.
2. The switch must be placed in a cool, dry place, and there should be enough gap for heat dissipation all around for the purpose of ventilation and heat dissipation.
3. The switch must work in the indoor environment with a temperature of 5°C~50°C and humidity of 20%~80% without condensation.

Connecting Equipment:

Step1: Inspect the Power Adapter carefully, and make sure that it is properly connected to a power source.

Step2: Plug in the Power Adapter to the Switch.

Step3: Connect your network devices with the switch by using an Ethernet cable. (e.g. Cat-5e)

WEEE

WEEE is waste electrical and electronic equipment. It is end-of-life electrical and electronic equipment and covers virtually everything with a plug or battery. The EC introduced the WEEE Directive in 2002 to address the environmental impacts of unwanted electrical and electronic equipment at end-of-life disposal.


CE

marking is a certification mark that indicates conformity with health, safety, and environmental protection standards for products sold within the European Economic Area (EEA). The CE marking is also found on products sold outside the EEA that have been manufactured to EEA standards. This makes the CE marking recognizable worldwide even to people who are not familiar with the European Economic Area.
