

- 5. Charger connection port

# Starting the device for the first time


It is recommended to charge the device at least 60 minutes before starting it up for the first time.

The device can still be used while charging.

## Turn on the device

Before turning on the device for the first time, make sure the battery has been charged for at least 60 minutes

- 1. Press and hold the power key until the screen lights up.
- 2. Wait for the device to be activated.



## Turn off device

- 1. Press and hold the power button until the options menu opens.
- 2. In the options menu, tap Shut down. The device will take some time to shut down.

#### Internet connection


- 1. Press the upper right corner of the screen to enter the function menu bar and select Wi-Fi Setting.
