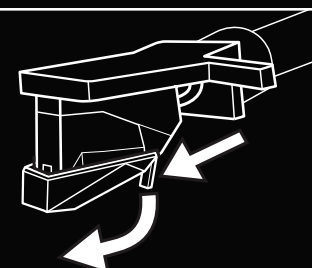

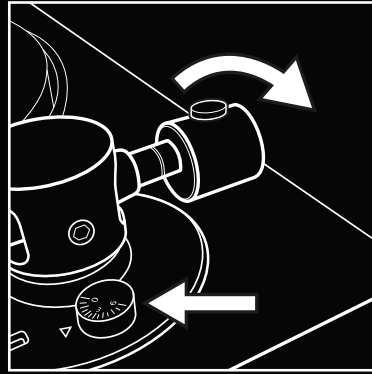
1 SETUP YOUR TURNTABLE

ORTOFON 2M SERIES COUNTERWEIGHT SLIDES TO THE FIRST GROOVE.

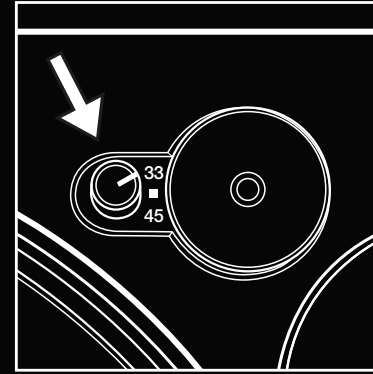
AUDIO TECHNICA VM95 SERIES COUNTERWEIGHT SLIDES TO THE SECOND GROOVE.



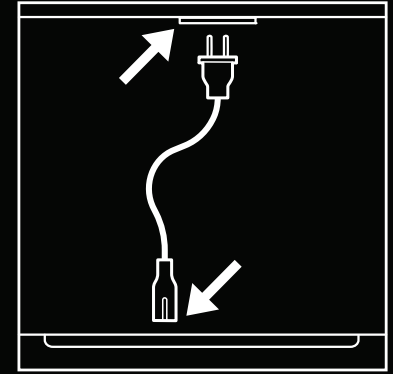
ONCE ALIGNED WITH THE CORRECT GROOVE, TURN THE TOP SCREW CLOCKWISE TO TIGHTEN THE COUNTERWEIGHT.

SET THE ANTI-SKATE KNOB WITHIN THE RECOMMENDED RANGE: 1.5-2.0

note: you may need to adjust the anti-skate if you notice distortion, skipping, or looping during playback.



USE THE SPEED SELECTOR KNOB TO SELECT YOUR RECORD SPEED.



PLUG THE POWER CORD INTO THE UNIT AND WALL OUTLET. THE TURNTABLE WILL AUTOMATICALLY BOOT UP. ONCE THE ILLUMINATED CONTROL KNOB BEGINS FLASHING GREEN, TURNTABLE IS READY TO CONNECT TO A NETWORK.

FAQ

TURNTABLE NOT SPINNING

- ENSURE YOU HAVE INSTALLED THE PLATTER BELT AND SELECTED A RECORD SPEED USING THE SPEED SELECTOR KNOB.

TURNTABLE NOT STREAMING TO SONOS

- ENSURE YOU HAVE SELECTED A DEFAULT SONOS PLAYER OR GROUP WITHIN THE VICTROLA APP AND AUTOPLAY IS ENABLED. IF AUTOPLAY IS DISABLED, PRESS AND HOLD THE CONTROL KNOB FOR 1 SECOND TO SET YOUR TURNTABLE AS THE SOURCE FOR YOUR DEFAULT SONOS PLAYER OR GROUP.

AUDIO IS SKIPPING WHEN STREAMING TO SONOS

- SKIPPING WHILE STREAMING IS MOST COMMONLY CAUSED BY POOR WI-FI QUALITY. WITHIN THE VICTROLA STREAM APP, VISIT THE ADDITIONAL SETTINGS PAGE OF YOUR TURNTABLE AND ADJUST THE WIRELESS AUDIO DELAY UNTIL YOUR TURNTABLE NO LONGER SKIPS WHILE STREAMING.

TURNTABLE IS MAKING A HUMMING NOISE

- A HUMMING NOISE IS USUALLY CAUSED BY A GROUND LOOP ISSUE, REMOVING AND REINSTALLING THE REMOVABLE HEADSHELL WILL USUALLY FIX THIS ISSUE.

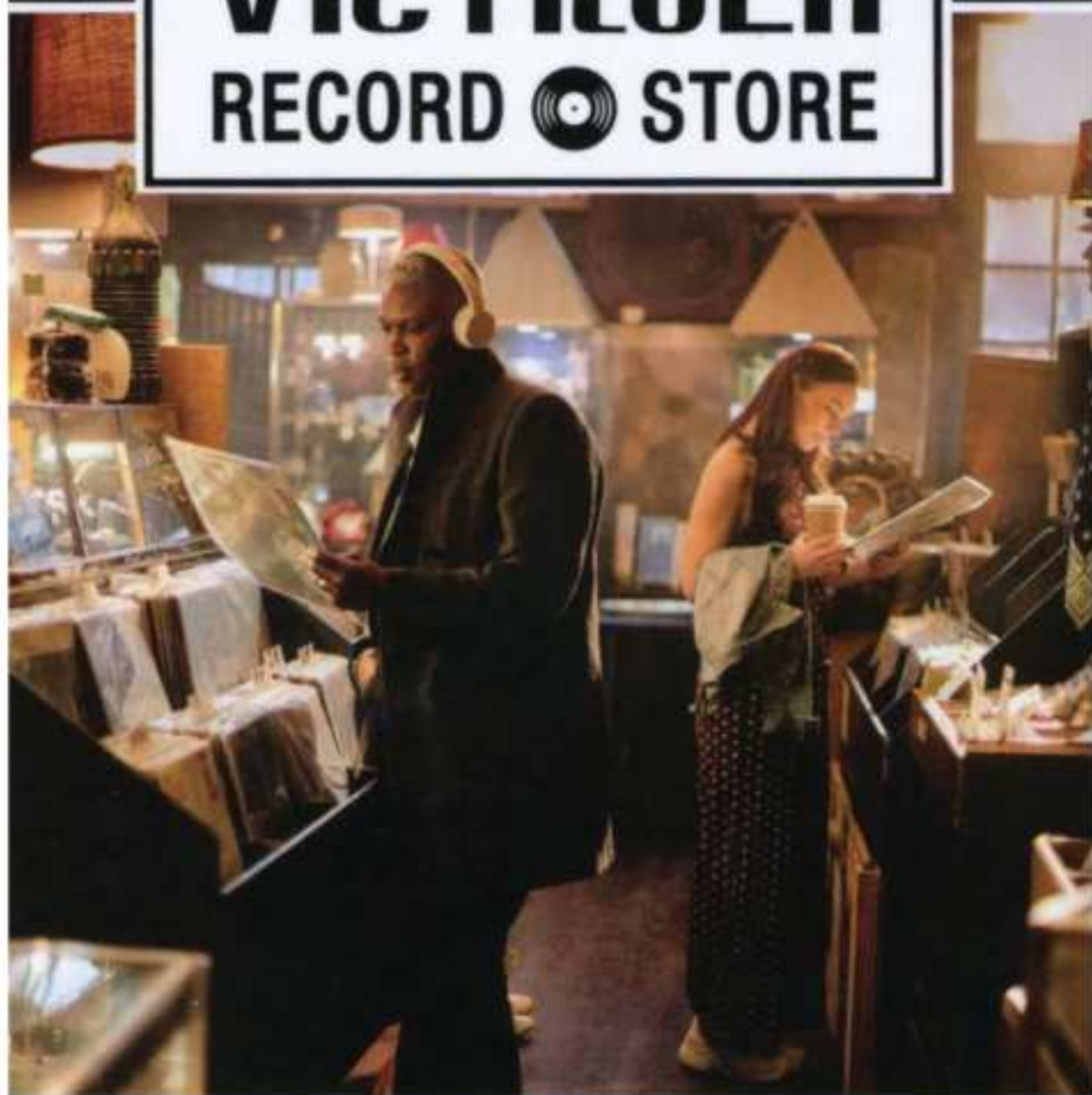
