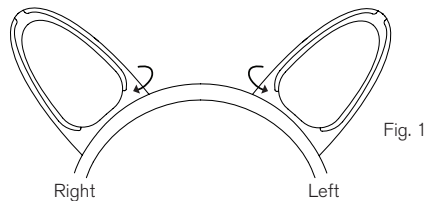

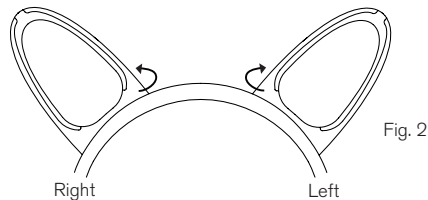
INSTALLING BUNNY EAR SPEAKERS

Align the tabs on the BUNNY EAR SPEAKERS with the slots on the headphones (the tabs are keyed so they will only insert in one orientation), insert and twist to secure as shown in Figure 1.



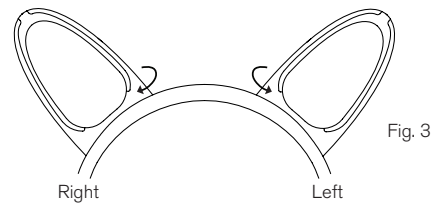
REMOVING BUNNY EAR SPEAKERS

Twist the BUNNY EAR SPEAKERS and remove as shown in Figure 2.



CHANGING DIRECTION OF BUNNY EAR SPEAKERS

Twist the BUNNY EAR SPEAKERS to change the direction of the speakers as shown in Figure 3.
