

Installation

Before You Start

- Disconnect negative battery terminal. Consult a qualified technician for instructions.
 Avoid installing the unit where it would be subject to high temperatures, such as from direct sunlight, or where it would be subject to dust, dirt or excessive vibration.



* Use 2 or 3 screws to affix the monitor to the bracket.

The radio display features the following functions and displays:


- 1) RESET

Note:

When replacing a fuse, make sure to use the correct type and amperage. Using an incorrect fuse could cause damage. The unit uses (1) 15 amp ATC mini style fuse located on the power connector.

Wiring Notes:

Subwoofer output

The Subwoofer preamp audio output (Green RCA) is active in all audio modes.

Rear camera input

A rear view camera (not included) can be used with the Camera input.


Main Menu

In main menu, press the desired icon to enter the corresponding mode: Radio/USB/BT Phone/BT Audio/Android Auto/Apple CarPlay/AV In/Equalizer/Settings.





Tuner Operation



USB Operation

From the main menu, touch the USB icon on the main screen.



Note: Video playback is enabled only when the vehicle is in park and the parking brake engaged.

Bluetooth Operation

Before using Bluetooth

Before you can use a Bluetooth device to make hands-free calls or stream audio. it must be authenticated. This is also referred to as "pairing" a device.

Pairing a New Device

The unit broadcasts the pairing signal constantly when no devices are currently connected. Complete the pairing sequence from your Bluetooth device. Refer to the owner's manual for your device for more details. **The device name is "CAR710-4"**. The unit can be in any mode of operation when pairing is performed. On certain phones, pairing may need to be done more than once.

Connect

The head unit will automatically connect to the last connected device when the connect feature is set to Auto connect On. If the connect feature is set to Auto Connect Off, the head unit will not automatically connect to any device.

Bluetooth Phone

From the main menu. touch the **Bluetooth** on the screen. Bluetooth icon will appear anytime a Bluetooth device is connected.

Dialing a Number

Press to display keypad and dial a number.

Making and Ending a Call

Press to connect a call, and press to end a call.

Transferring Audio

Press = - = to transfer audio between the head unit and mobile phone.

Streaming Audio

Press /II to play or pause the music.


Press | to skip to the previous track.

Press ▶ to advance to the next track.



Audio Operation

Press the Settings icon on the main menu screen to adjust Fader and Balance controls, Equalizer (8-Band Tone Control and 8 Presets EQ Settings).





Apple CarPlay Operation

Select Apple CarPlay on the Main Menu.

If the iPhone is connected via USB port, press Apple CarPlay icon on main menu to mirror the iPhone's apps onto the screen. If the iPhone USB cable is inserted to the USB port then the CAR710-4 will automatically change to Apple CarPlay mode.

Android Auto™ Operation

Select Android Auto on the Main Menu.

If the Android Phone is connected via USB port, press Android Auto icon on main menu to mirror the Android Auto Basic Image onto the screen. If the Android Phone USB cable is inserted to the USB port then the CAR710-4 will automatically change to Android Auto mode.

General Operation

From the Main Menu screen, select Setup to access the Settings menu and select from categories represented by the icons on the right of the screen: General, Audio, Display, Others. Select the category, and adjust any of the available options using the touch screen.


What's in the box

- 1. Product Sheet
- 2. BUCAM350 License plate style camera
- 3. Power Cable w/ Fuse, Video Cable





Mounting the camera



- 1. Fix the camera to the appropriate position on the license plate and adjust the angle .
- 2. Follow ONE of the following wiring options.

OPTION 1: Connect camera power wire to the vehicle's reverse lamp:

a)Locate the reverse lamp in the tail light assembly.

b)Attach the red wire to the positive 12 volt wire from the reverse lamp. Use a crimp connector or soldering tool to ensure connection is secure. Once this connection is complete, note that the red power wire that is located on either end of the video RCA cable will not be needed. The bare wire at the end of each wire lead should be capped or taped off to prevent potential power interruption. c)Attach the black wire to ground(-).

d)Run video cable to the location of the receiver or montior(not included). Connect one yellow RCA end of the video cable to the camera and connect the other end of the yellow RCA cable to the video source (receiver/monitor).

OPTION 2: Connect camera power wire to receiver/monitor power:

a)From camera location, connect red power wire from power cable to red power wire from one end of the video cable. Use a crimp connector or soldering tool to ensure connection is secure.

b)Attach the black wire to ground.

c)Run video cable to the location of the receiver or monitor(not included). Connect not yellow RCA end of the video cable to the camera and connect the other end of the yellow RCA cable to the video source(receiver/monitor).

d)From video source(receiver/monitor) location,connect red power wire from end of the video cable to the reverse wire lead located on the video source(receiver/monitor).


