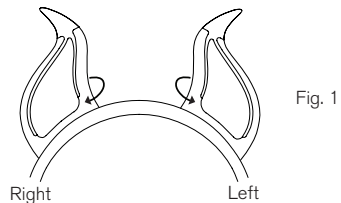

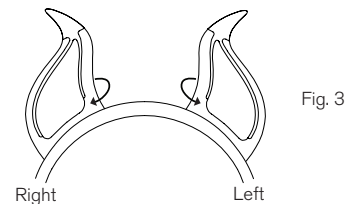
INSTALLING DEVIL HORN SPEAKERS

Align the tabs on the DEVIL HORN SPEAKERS with the slots on the headphones (the tabs are keyed so they will only insert in one orientation), insert and twist to secure as shown in Figure 1.



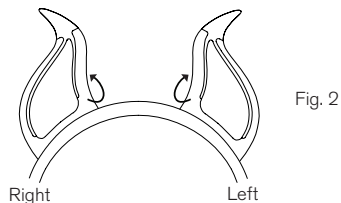
CHANGING DIRECTION OF DEVIL HORN SPEAKERS

Twist the DEVIL HORN SPEAKERS to change the direction of the speakers as shown in Figure 3.



REMOVING DEVIL HORN SPEAKERS

Twist the DEVIL HORN SPEAKERS and remove as shown in Figure 2.
