# STEP 1: Connecting to a TV





- If you connect this unit to a 4K-compatible TV and perform "Easy Setting", 4K/60p will be automatically selected.
- To view Ultra HD Blu-ray content in 4K/HDR format, connect to the HDMI terminal of a device that supports HDCP2.2, 4K/60p (4:4:4), and HDR signals that meet Ultra HD Blu-ray standards.






