

(U) Power Button

- Press the power button to turn on the device, and activate the default mode "Whole" at low intensity, press again to turn off the device.

SSS Heat Button

-Press to turn on/off heating function

Instructions for use



Mode Button

-Use the Mode button to cycle between 3 automatic programs:

WHOLE: Pressure massage for the whole hand (wrist, palm, fingers)

FRONT: Pressure massage focusing on the palm and fingers **REAR**: Pressure massage focusing on the palm and wrist



Intensity Button

-Press the Intensity button to set massage intensity at Low/Medium /High level, and the corresponding LED will light on.



Timer Button

-The default timer is 15 minutes to automatically turn off the machine. Press to set the timer for 5/10/15 minutes.

Note: Instructions for use of deflate valve

There is an emergency deflate valve at the bottom of the product. When the machine malfunctions or the pressure is too strong, you can turn the knob to ON position to deflate immediately.

Battery Charging

- 1. When the battery is low, the charging indicator will start flashing.
- Connect the USB cable to any USB charger, it can be plugged in the portable power bank, mobile phone battery chargers, laptop and any USB port.



- 3. When charging, the indicator light will turn red.
- 4. When full charge, the indicate light will turn green.
- 5. Normally it takes about 3~3.5 hours to fully charge.
- You are able to use the massager whilst charging, but it is recommended to charge the battery first then use.
- 7. After full charged, the device can work continuously for around 1.5 hours.

! Note

You should allow your body some rest periods. To avoid straining your muscles too much, we recommend to not exceed a continuous massage of **15** Minutes per time and not exceed **2** times use one day

Troubleshooting

Trouble	Reason/Solution
Can not start the massager	Battery Low,Please charge it before using
The massager stoped abnormally	Battery runs out of power, charge the battery; Self-timed 15 mins is out, restart the product
Massager slight noise	It is normal working noise of the internal mechanism

Notes and Maintenance

Care and cleaning instructions

- 1. Always unplug the unit before cleaning it.
- 2. Before cleaning, allow unit to cool.
- 3. Dampen a cloth in water or a 3%-5% mild detergent solution.
- 4. Wipe the dirty areas with the wet cloth.
- 5. Do not use sharp brush, sharp tool, gasoline and diesel to clean it.
- Do not use wet cloth clean control panel, lest cause failure, only use dry cloth to wipe the control panel.
- 7. Never submerge any part of the unit in liquid.
- 8. Wait for the unit to become fully dry before use.

Maintenance

- 1. Please keep it into a box and keep in a safe, dry and cool place.
- Do not keep it in any place with high temperature, near fire or direct sunlight, or it may faded or damaged
- 3. Do not contact benzene, dilient or any other corrosive liquid.
