



# CW-SYS DUAL-PURPOSE WIRELESS DRIVEWAY SYSTEM

## VERSION 6 - SEPTEMBER 2024

### 1. WHAT'S IN THE BOX

- 1. SENSOR "PUCK"
- 2. INTEGRATOR
- 3. AUGER SCREWS (2)
- 4. CR123A BATTERIES (2)
- 5. TERMINAL BLOCK
- SCREWDRIVER

#### OPTIONAL

- (A) 12VDC power supply (Part #CW-PSU)
- (B) Coaxial cable (1M) with grommet (Part #CW-COA)



NOTE: Screwdriver may vary

### 2. SERIAL NUMBER

There is a barcode serial number on the back of Integrator, bottom of puck, and on product box. When calling to talk about your product, please have one of these numbers handy.



### 3. INSTALLING BATTERIES/LOW BATTERY

- 1. Use **CR123A** batteries and match polarity with battery terminal in puck.
- 2. If batteries are put in backwards, they will not make contact.
- 3. Push batteries in place fully to make contact.
- 4. Sensor will power up automatically when batteries are installed.

**NOTE: battery clips are not needed. Puck lid holds batteries in place**



**NOTE: BATTERY CLIPS NO LONGER NEEDED**

#### LOW BATTERY

When batteries need replacing in sensor, sounder's LED will remain a constant RED. When hooked to external system's zone inputs (see #10 below), program what you desire in order to indicate low battery.

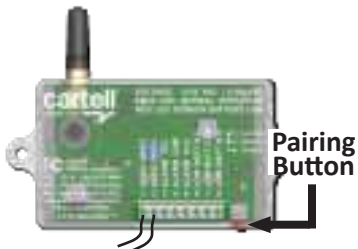
**WARNING: CLEAN SENSOR BRIM, LID, & LID GASKET BEFORE SCREWING LID TO HOUSING.**

**REPLACE BOTH BATTERIES AT SAME TIME. DO NOT USE RECHARGEABLE BATTERIES.**

### 4. PAIRING

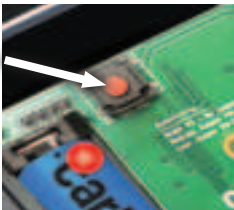
**YOUR SYSTEM HAS BEEN PAIRED AT FACTORY. THESE DIRECTIONS APPLY WHEN PAIRING ADDITIONAL UNITS**

You can pair up to 30 pucks with an unlimited number of Integrators



- 1. Bring sensor close to Integrator and power up both units (#4 above & #10 below).
- 2. Push pairing button on Integrator (will stay in pairing mode 30 minutes).

- 3. Sensor (1) Power up sensor (2) Wait for it to boot up (3) Press and release red (test mode) button for **1 second** to send a pairing message to Integrator.



- 4. Integrator will beep 2 times (1 short & 1 long) when paired and exit pairing mode automatically.

#### ON AN OBJECT



- Use stable object
- Use 4 deck screws for fastening

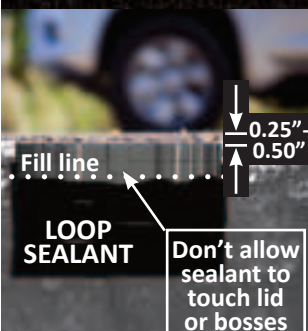
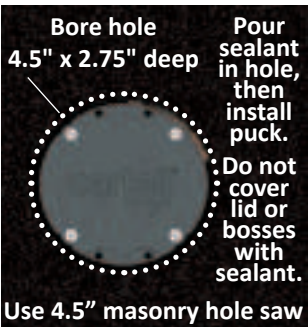
min. 6" - 8"

#### IN THE GROUND



- Put logo parallel to drive
- Put just below surface
- Auger screws secure puck
- Do not cover puck lid
- Pack dirt/grass around puck
- Keep puck lid clean

#### IN THE DRIVEWAY



Bore hole 4.5" x 2.75" deep

Pour sealant in hole, then install puck.

Do not cover lid or bosses with sealant.

Use 4.5" masonry hole saw

Fill line

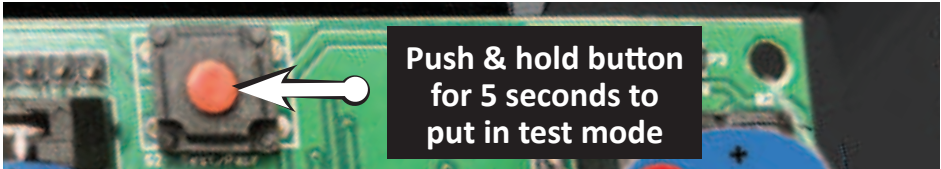
LOOP SEALANT

Don't allow sealant to touch lid or bosses

### 5. TEST MODE FOR SENSOR PUCK

Test mode allows the sensor puck to be tripped without a vehicle. This is useful when testing radio range (see #6 below) and solo installations.

- 1. Press and HOLD button on sensor puck for **5 seconds**
- 2. The red LED will be solid and dim while waiting the 5 seconds
- 3. Once the 5 seconds has expired, the LED will be bright red
- 4. Test mode is activated when the button is released
- 5. The sensor will trip itself every 15 seconds
- 6. Test mode will be exited when button is pressed again
- 7. Test mode will automatically be exited after 30 minutes



Push & hold button for 5 seconds to put in test mode

### 6. TESTING RANGE

Your system has a radio range of at least 350 feet or over 1000' line-of- sight. To determine range in your application, test before final installation.

Radio range depends on several variables:

- How the puck is installed (in ground or above ground on post)
- Obstacles blocking radio signal, such as soil, trees, foilage, buildings, concrete, etc.

To test range:

- 1. Put Integrator near its final installation place in the home or gate.
- 2. You will need to confirm the Integrator is sounding (see #9 below).
- 3. Put sensor in test range mode (see #5 above).
- 4. Listen for Integrator to trigger. If it doesn't, move sensor closer to Integrator.
- 5. Be sure to test again with puck installed in ground (see #8 below).
- 6. You may need to add a repeater inside the home (see #9 below).

### 7. SETTING SENSITIVITY

**ONLY ADJUST (LOWER) SENSITIVITY IF PUTTING IN MIDDLE OF DRIVEWAY (see #8 below). IN ALL OTHER CASES USE DEFAULT.**

SENSITIVITY ADJUSTMENT	
<b>HIGH (Default)</b> Detects vehicle going <b>5 MPH</b> 12-14' away 1 & 2 in OFF position	<b>ON</b> 1 2
<b>MEDIUM</b> Detects vehicle going <b>5 MPH</b> 6-8' away 1 ON & 2 OFF position	<b>ON</b> 1 2
<b>LOW</b> Detects vehicle going <b>5 MPH</b> 2-4' away 1 & 2 in ON position	<b>ON</b> 1 2

**NOTE: HIGHEST SENSITIVITY IS WITH DIP SWITCHES IN THE OFF POSITION**

### 8. INSTALLING SENSOR PUCK

The sensor puck can be installed in the driveway, in the ground, or on an immovable object (post, tree, etc.).

**NOTE: SENSOR PUCK DETECTS A VEHICLE GOING 5 MPH AFTER IT PASSES. THEREFORE, IF POSSIBLE, PLACE SENSOR AT LEAST 50 FT. AWAY FROM GATE OPERATOR FOR OPTIMUM PERFORMANCE.**

**ON AN OBJECT** (see illustration bottom left)

- 1. Test range (#6 above), then seat lid securely on puck with screws provided, leaving no gap between lid and puck. Do not over-tighten or strip screws.
- 2. Find a tree, post, or other object directly beside the driveway.
- 3. Make sure the object is IMMOVABLE or false alarms will occur.
- 4. Use the holes on the bottom tabs to screw puck to the object.

**IN THE GROUND** (see illustration bottom left)

- 1. When range has been tested (see #6 above), seat lid securely on puck with screws provided. Be careful not to strip screws with screw gun. There should be no gap between lid and puck.
- 2. Find a spot directly beside driveway.
- 3. Dig a hole big enough for puck and auger screws, allowing puck's lid to be level with surface of dirt.
- 4. Secure puck in ground with auger screws, overlapping bottom tabs of puck. If you fail to secure puck, lawn mowers, etc. will pull/suck it up.
- 5. Pack and tamp dirt around puck, ensuring lid is clean of dirt and all debris.

**IN THE DRIVEWAY** (see illustration bottom left)

- 1. When range has been tested (see #6 above), seat lid securely on puck with screws provided. Be careful not to strip screws with screw gun. There should be no gap between lid and puck.
- Note: If close to cross traffic, consider turning sensitivity down (see #7 above)**
- 2. Use a 4.5" diameter masonry hole saw to bore a hole for puck. Bore at least 2.75" deep so puck lid will be 0.25" - 0.50" below driveway surface (so it can't be pulled up by snow plows, graters, etc.).
- 3. Pour loop sealant in hole, careful not to overfill, and put puck in hole.
- 4. Hold puck down with weight until sealant becomes firm.
- 5. DO NOT pour sealant over puck lid or bosses to gain access to batteries.

**NOTE: SENSOR PUCK AND LID ARE KEYED. WIPE SENSOR LID, LID GASKET, AND SENSOR BRIM WITH CLEAN CLOTH AND KEY CORRECTLY BEFORE ATTACHING.**



9. INTEGRATOR DIP SWITCHES

Dip switches control sounder and repeater mode on Integrator.

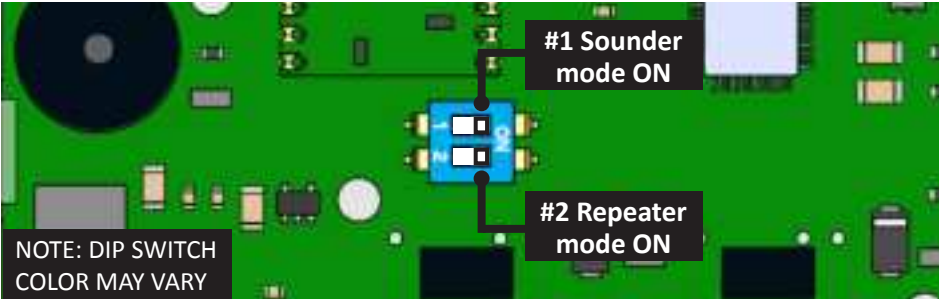
SOUNDER

Turn dip switch 1 ON to turn sounder on.

Sounder will beep 5 times when vehicle is detected. It will also “chirp” when sensor puck batteries are low and need replacing.

REPEATER MODE

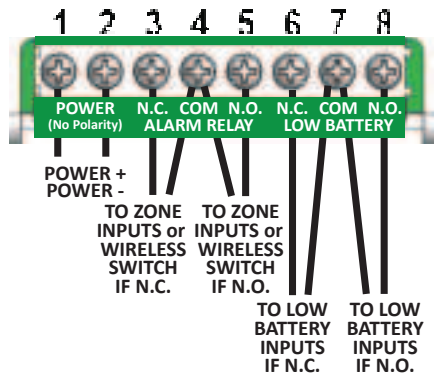
Turn dip switch 2 ON to turn Integrator into a repeater. In repeater mode, the unit will continually receive and repeat any signal from the sensor to the Integrator installed in the home (see #11 below). Red and blue LED will alternately and continuously blink in repeater mode.



10. INSTALLING INTEGRATOR

Your system integrates seamlessly with any security/H.A. system or electric gate operator. To integrate, use the following wiring schematics as guides:

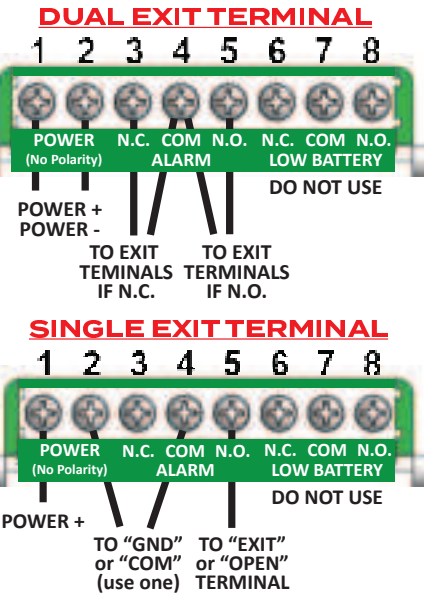
SECURITY/HOME AUTO SYSTEMS



Integrator uses 8-24 VAC or 8-30 VDC. Use security/H.A. system or gate operator to power or use any 12VDC power supply. Cartell sells optional power supply (Part #CW-PS).

YOU MUST ADD A SAFETY TO GATE WHEN USING CW-SYS FOR FREE EXIT.

11. REPEATER MODE\*

To increase radio range, it may be necessary to make the Integrator a repeater.

If the signal from sensor puck is not reaching the Integrator:

- 1. Move the sensor closer to the Integrator, and/or
- 2. Install a repeater in the home between the sensor puck and Integrator connected to the security/home automation system. Do the following:
  - 1. Purchase an optional Integrator and power supply (Product CW-REP).
  - 2. Remove enclosure cover by carefully pushing side tabs in.
  - 3. Connect power supply to terminals 1 & 2 (no polarity).
  - 4. Turn dip switch 2 ON (see #9 above). This puts the unit in repeater mode. The red and blue LEDs will alternately blink to indicate repeater mode. It will continually receive every signal from the sensor and transmit (repeat) it to the Integrator installed beside the main system.
  - 5. Install repeater in a window closest to the sensor puck.
  - 6. Turn dip switch 1 OFF to turn sounder off.

NOTE: Relay will not work in repeater mode. \*Order using CW-REP

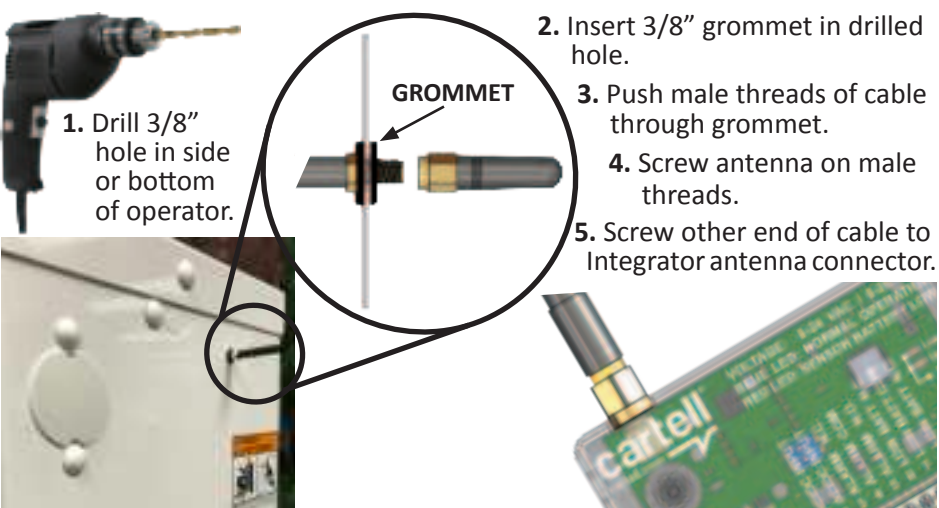

12. OPTIONAL EXTERNAL GATE ANTENNA

In gate operator installations, antenna attached directly to Integrator will work in most cases. The only time it may not work is in a *sealed* metal gate operator that blocks the RF signal. If that is the case, use an optional coaxial cable and 3/8” grommet, and install antenna externally, per the following:
