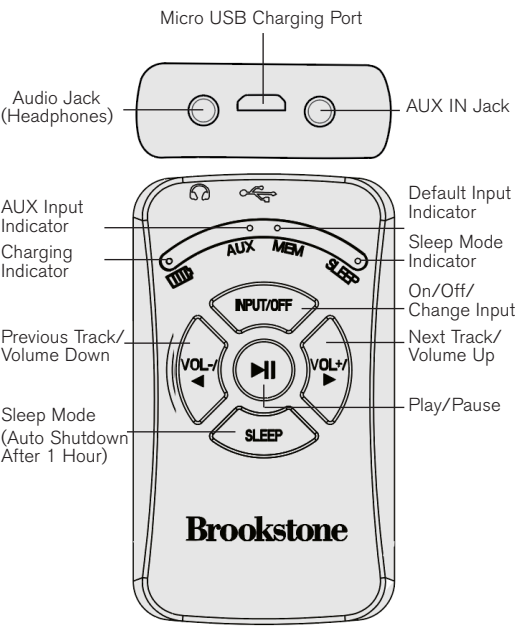

CHARGING THE BATTERY

Your Nature Sounds Pillow contains a rechargeable Lithium-Ion battery. Charge the battery before first use. A full charge takes approximately 2.5 hours.

To charge the battery:

1. Plug the supplied Micro USB charging cable into the Micro USB Charging Port and into a USB port on an active device, such as a computer or adapter. The Charging Indicator is red while charging.
2. When fully charged, the Charging Indicator turns off. Unplug the charging cable.

USING THE NATURE SOUNDS PILLOW

After charging the battery, you are ready to use your Nature Sounds Sleep Pillow.

1. To turn on, press INPUT/OFF. The Default Input Indicator (MEM) lights, and the sounds stored in memory begin playing.
2. To play audio from an auxiliary device, such as a smartphone, press INPUT/OFF again. The AUX Input Indicator lights green. Plug an auxiliary input cable into the AUX IN Jack and connect it to your device, and begin playing your music.
3. To move to the next track, press VOL +/►. To move to the previous track, press VOL -/◄.

To increase the volume, press and hold VOL +/►. To decrease the volume, press and hold VOL -/◄.

4. To pause the audio, press Play/Pause ►||. To resume listening, press Play/Pause ►|| again.
5. To listen to audio through headphones or earbuds, plug an audio connector into the Audio Jack.
6. To enter sleep mode, press SLEEP. The Sleep Mode Indicator lights blue. The volume of the sounds will gradually decrease for one hour. At the end of the hour, the audio will automatically turn off.
7. To turn off the Nature Sounds Sleep Pillow, press and hold INPUT/OFF for 3 seconds.

CARE AND MAINTENANCE
