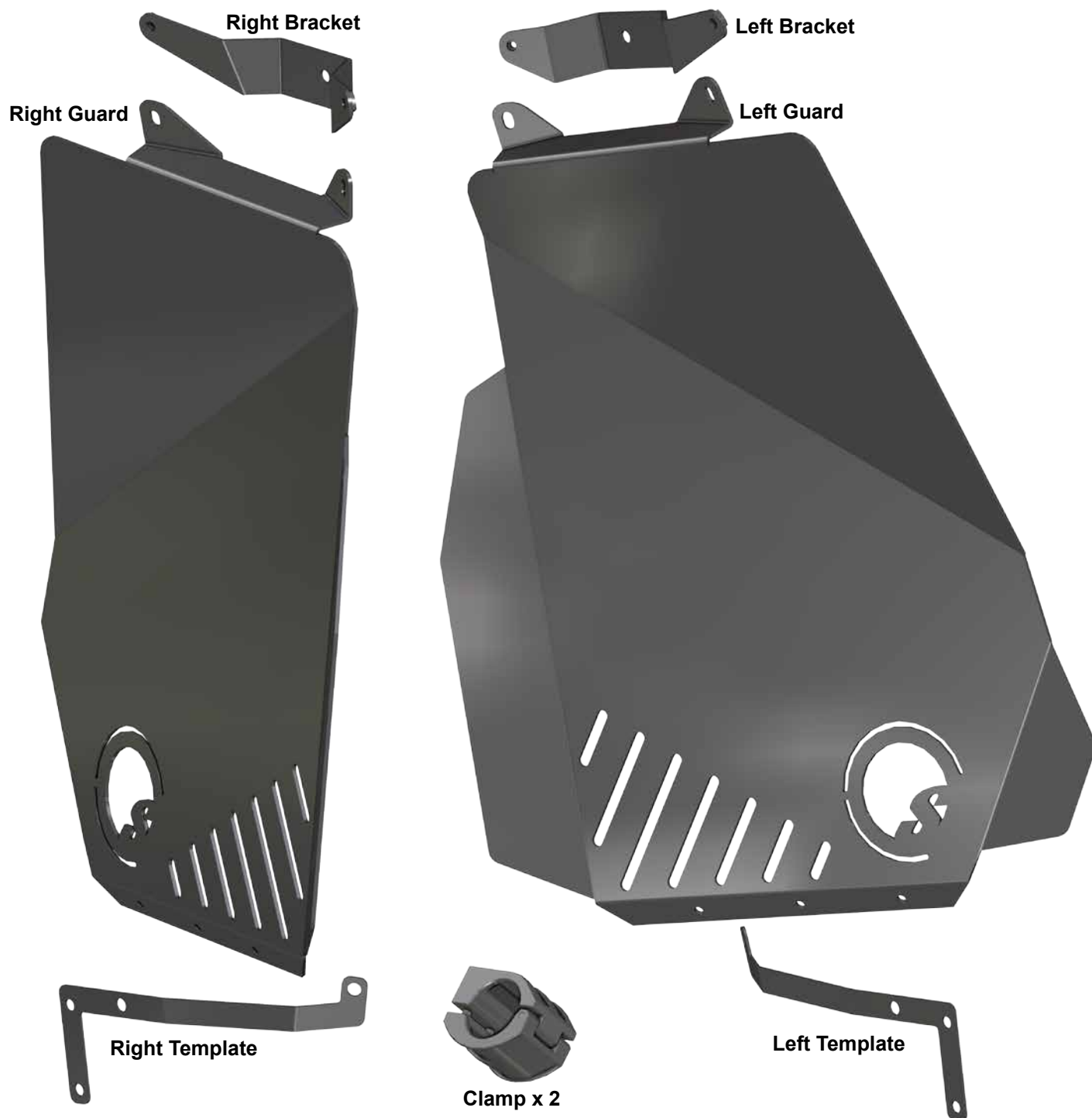


INSTALLATION INSTRUCTIONS

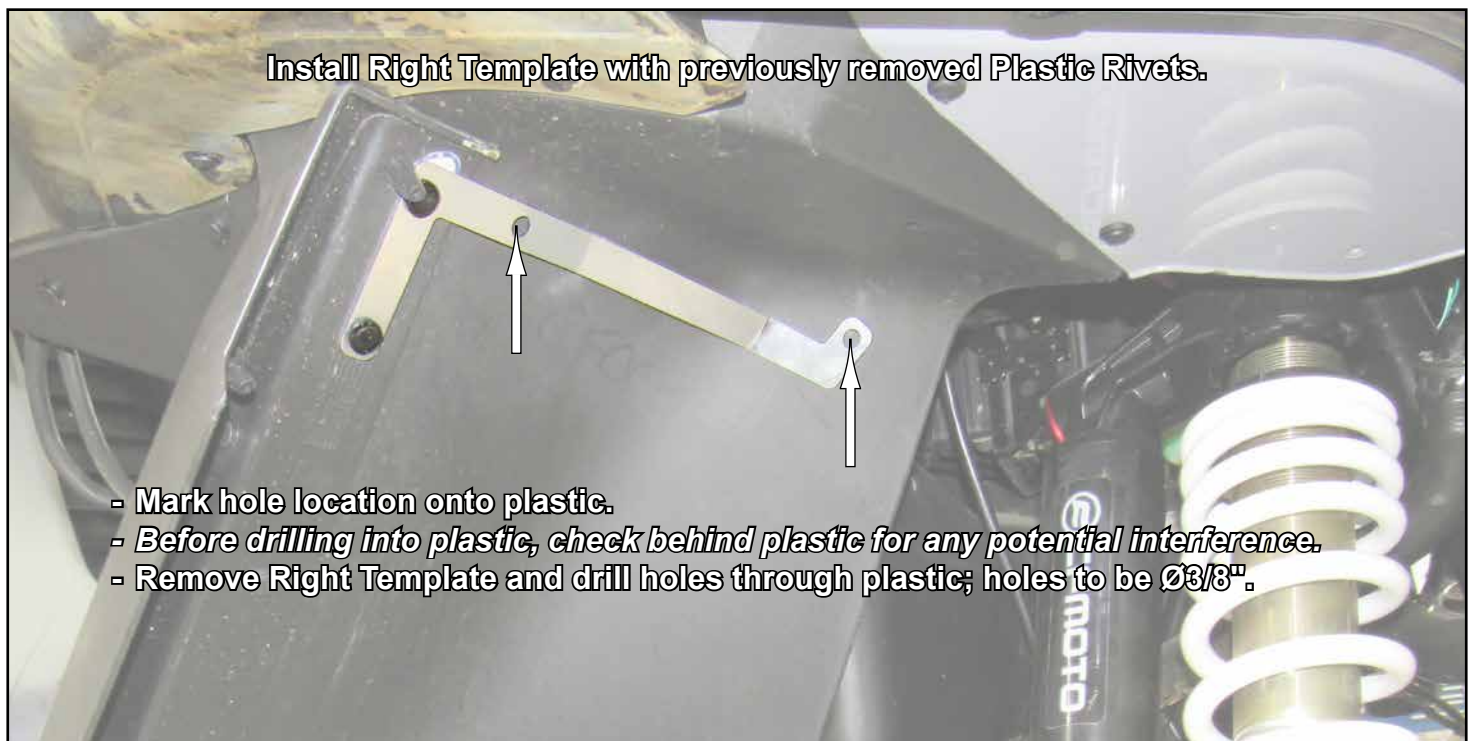

Remove Plastic Rivets shown.



Install Right Template with previously removed Plastic Rivets.

- Mark hole location onto plastic.
- *Before drilling into plastic, check behind plastic for any potential interference.*
- Remove Right Template and drill holes through plastic; holes to be $\varnothing 3/8"$.





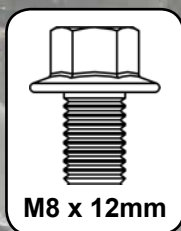




Install Clamp around Frame; Clamp should be snug but not tight.



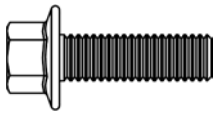
Install Right Bracket to Clamp with hardware shown;
hardware should be snug but not tight.





Reinstall all stock Plastic Rivets and Screw.

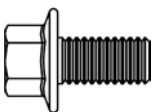
Install Right Guard and secure to Right Bracket with hardware shown; tighten hardware.



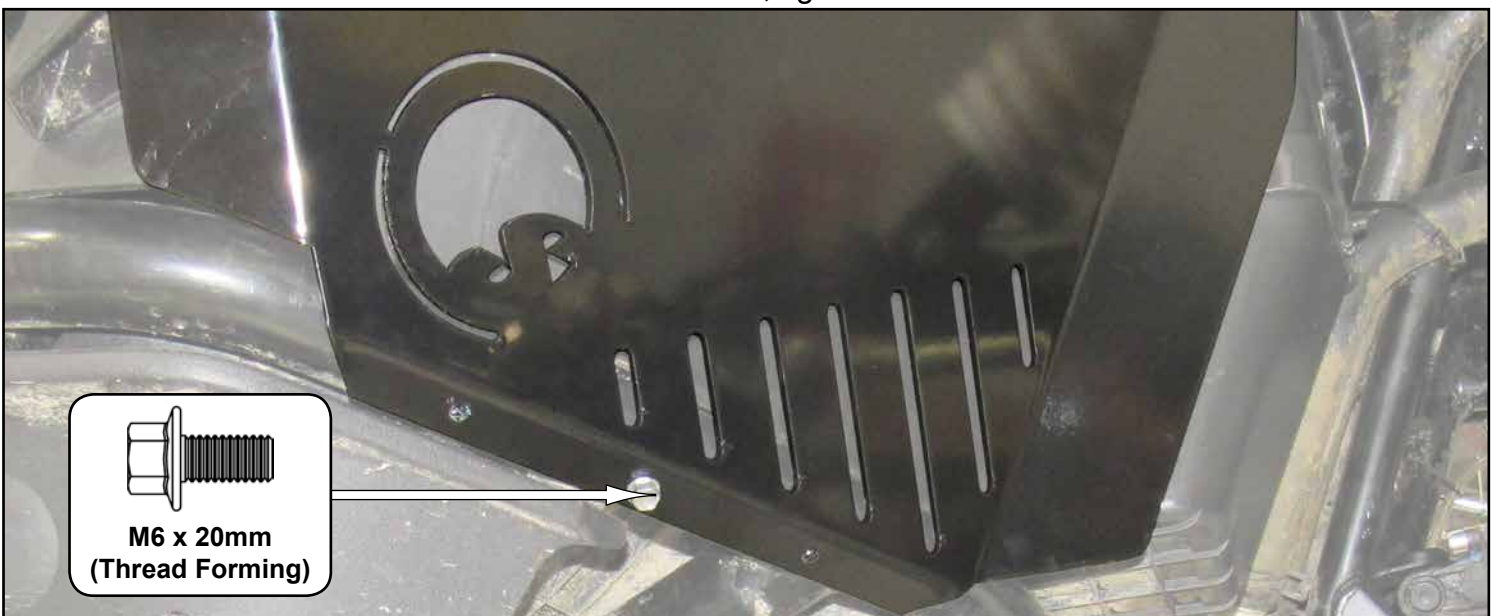
2x - M6 x 20mm



Use provided Drill Bit and drill hole into Frame and secure Right Guard with hardware shown; tighten hardware.



M6 x 20mm
(Thread Forming)



Use provided Drill Bit and drill holes into Frame and secure Right Guard with hardware shown; tighten hardware.



2x - M6 x 20mm
(Thread Forming)

Repeat steps for Driver Side installation.
