

QUICK START

- 1. Press and hold the power button for 3 seconds to turn on/off the pixie mouse.
- 2. The pixie mouse plays with your cat for 10 minutes, then it stops working and goes into sleep mode for 30 minutes, the light strip flashes yellow slowly.
- 3. To reactivate the pixie mouse, touch it again, then it plays with your cat for another 10








Before having fun with your pet, make sure the pixie mouse's surface is in good condition. Supervision is required during the playtime to prevent your pet from swallowing the toy.

HOW TO CHARGE



- 1. Plug the Micro USB charging cable into the power jack.
- 2. The light strip turns yellow during charging.
- It takes about one hour to fully charge the pixie mouse, and the light strip turns green.

- If the pixie mouse doesn't work, and the light strip flashes red for 3 seconds, it indicates the pixie mouse needs charging.
- With constant touch, the pixie mouse can work continuously for 40 minutes.
- If the pixie mouse works for 10 minutes and sleeps for 30 minutes, the total battery life is 160 minutes.


