

Using the Speaker


Charging the Speaker

Insert the small connector of the supplied micro-USB cable to the port on the back of the speaker. Insert the large connector to the USB port on a computer, USB charging device, or **5V USB adapter** (not included) and plug into a wall socket.

The charging LED indicator will turn **solid RED** while charging and turn off when fully charged.

Powering ON/OFF


• Turn the speaker ON/OFF by moving the **[POWER]** switch. A tone will be heard, indicating that the speaker is powered ON.



Playing Music

To enjoy music wirelessly on your speaker, make sure that it is properly paired to your Bluetooth-enabled device. Once paired, playback and volume adjustment is controlled through your paired device.

If you are pairing the device for the first time, please consult the **Pairing the Speaker** section in the next column.



If you are using a wired device to play music, please consult the **Using with a Wired Device** section of this user manual.

Pairing the Speaker (Bluetooth)

- 1. Move the **[POWER]** switch to the ON position. A tone will be heard and the Bluetooth LED indicator will **quickly flash BLUE**.
- Set your mobile device to search for Bluetooth devices. When it appears, select AR520 from the list of found devices.
- 3. Once successfully paired, a tone will be heard and the Bluetooth LED indicator will **slowly flash BLUE**.



If a previously paired device is in range when the speake is turned on, they will re-connect to it automatically.




The screenshots above are typical of many Bluetooth-enabled devices in the market today, and are used to assist in the explanation of the pairing process. Your Bluetooth-enabled device's interface and interaction with the device may differ slightly from the illustrations above.

Using with a Wired Device (AUX)

Insert one connector of a 3.5 mm auxiliary cable (not included) into the 3.5 mm auxiliary input jack on the back of the speaker. Insert the other connector into the headphone jack on your media-playing device.

When the 3.5 mm auxiliary input jack is in use, all Bluetooth connections will be automatically disabled until the cable is removed from the input jack.
