## Thank you for choosing Angler.

Angler's 6-inch Fresnel lens fits on most lights with a Bowen mount. It employs a ribbed Fresnel lens design to help focus, sharpen, and amplify your beam. The rotating barrel focuses the spread from an intense  $12^\circ$  spot to a broad  $40^\circ$  flood with a smooth falloff from the center hot spot.

**Note:** This len's photometrics will change when it's used with different light fixtures.

### Precautions

- Please read and follow these instructions, and keep this manual in a safe place.
- ► Clean the unit with only a soft, dry cloth.
- ► Make sure that this product is intact and that there are no missing parts.
- ▶ Do not use with lights that output more than 300 W.
- ➤ The lens may become hot during use. Allow time for it to cool before handling or moving it.

## Attaching the lens

Insert the lens's mounting tabs into the light's Bowens mount, and turn the lens clockwise until it locks.



# Adjusting the Beam Angle


 Turn the barrel counterclockwise to extend the lens's length and narrow the beam.



2. Turn the barrel clockwise to shorten the lens's length and widen the beam.



 Mark the position on the beam angle scale to set the same beam angle multiple times.



# Unmounting the Lens

Pull the Bowens lock release, and turn the lens counterclockwise. Pull the lens from the light's Bowens mount.
