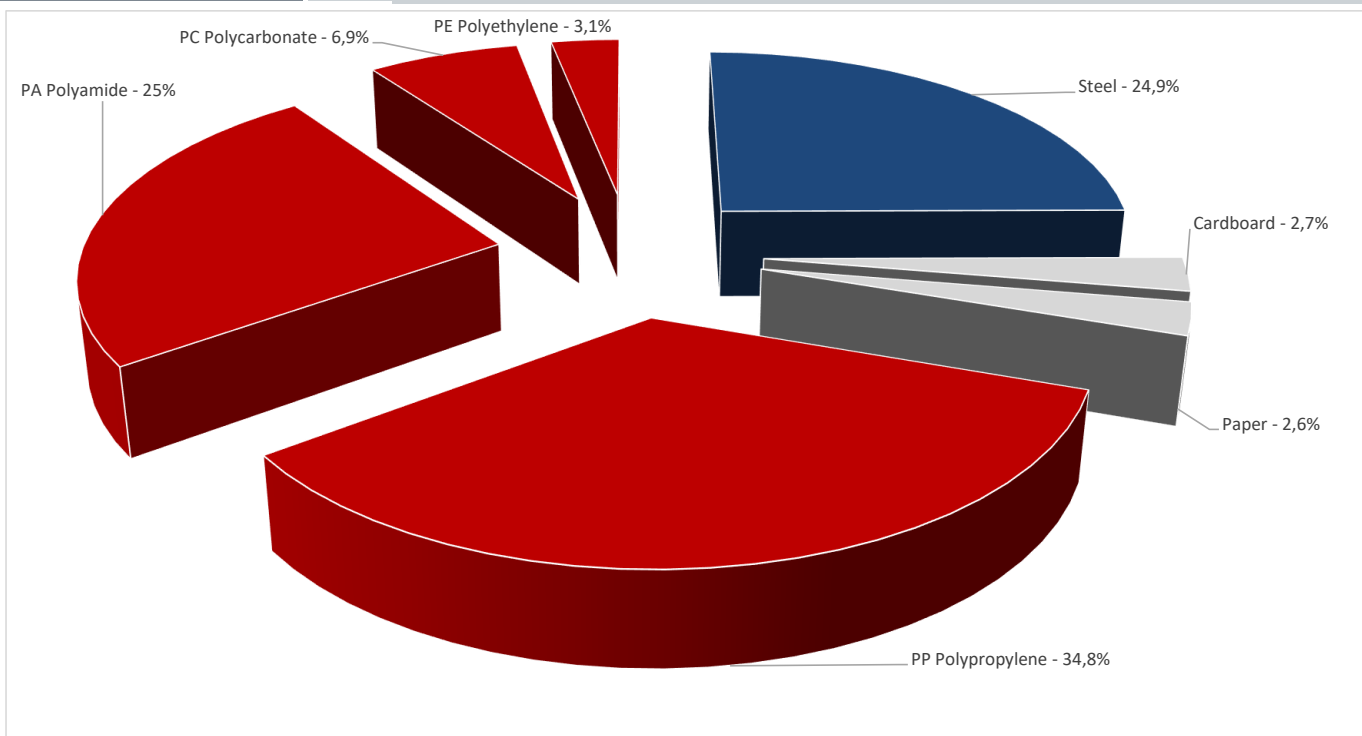


## General information

Description of the product	The main function of the ELKO Flexi flush mounted box range is to facilitate housing for different wiring devices in buildings. Manually adjustable fixing ring, the ring is adjustable when turned to 45° and locked when turned horizontally or vertically.
