Draw	<p>(a) The draw will be held on the Draw Date at Anisimoff Legal, Level 3, 162 Collins Street, Melbourne, Victoria, 3000.</p> <p>(b) The Promoter will compile all Eligible Entries upon the conclusion of the Promotional Period and conduct a draw on the relevant Draw Date.</p> <p>(c) The Promoter will randomly draw four (4) Eligible Entries (Winners).
