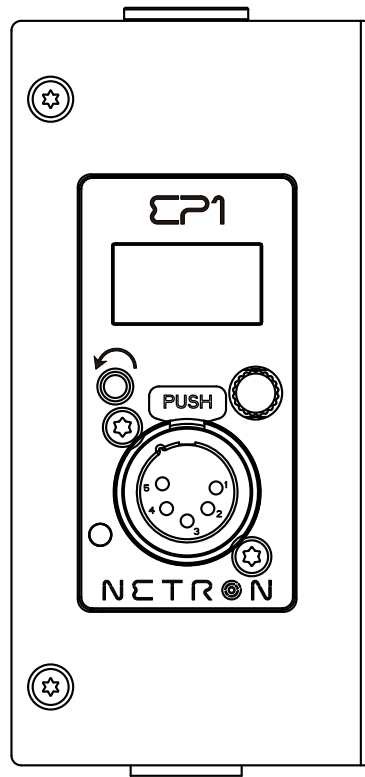

ELECTRICAL CONNECTIONS

A qualified electrician should be used for all electrical connections and/or installations.

Device **MUST** be installed following all local, national, and country commercial electrical and construction codes and regulations.

MOUNTING OPTIONS:

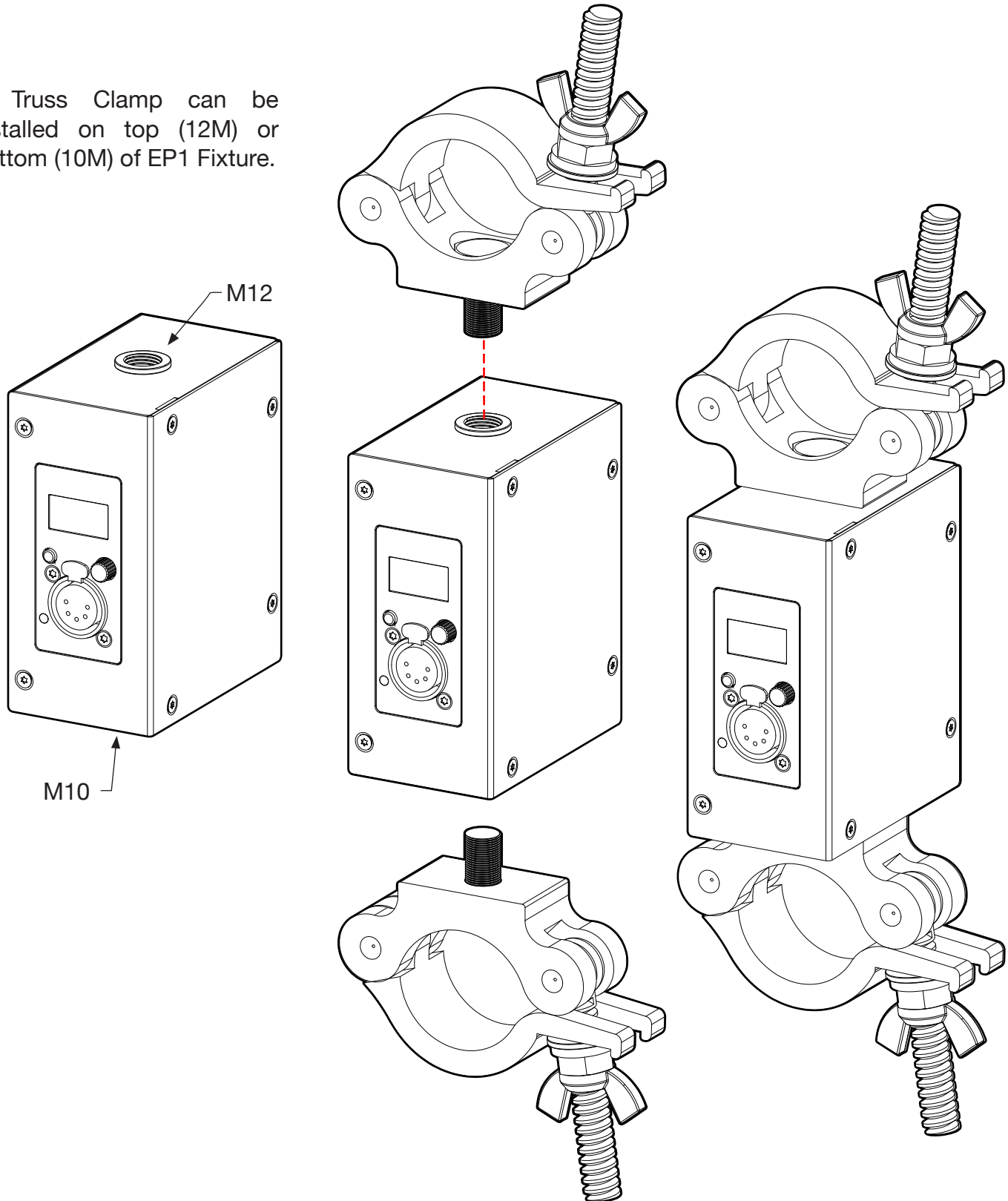
- Truss-mounted using the M10 or M12 mounting holes for use with a truss clamp or appropriate mounting hardware.
- The EP1 can be used Standalone, where the device sits on a firm flat surface.
- 1-Gang In-wall with included Decora cover plate

INSTALLATION INSTRUCTIONS

CLAMP INSTALLATION

Insert 18.8 steel M10x25mm or M12x25mm bolt (not included) through the respective mounting hole of the clamp (not included), and then thread it into the matching 12M hole on top, or 10M hole on bottom. The bolt must be threaded at least 18mm (0.7ins) into the fixture base.

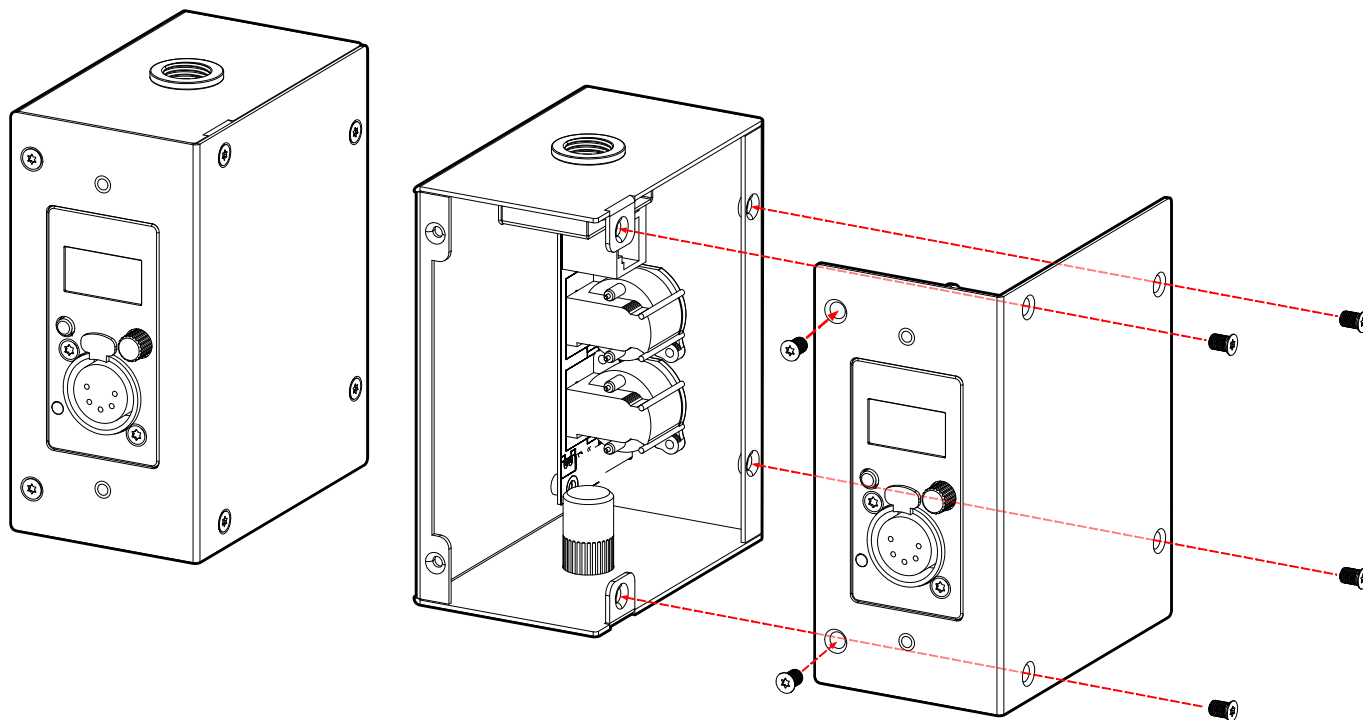
A Truss Clamp can be installed on top (12M) or bottom (10M) of EP1 Fixture.



INSTALLATION INSTRUCTIONS

Wall-Mount/Panel Installation: Chassis Assembly/ Disassembly

The wall-mount/panel installation options requires the control panel to be removed from the mounting case, the internal multi-use mounting-bracket removed, and then remounted to the junction box. After the control surface panel has been wired by a qualified electrician, the control panel can then be remounted to the multi-use mounting-bracket.

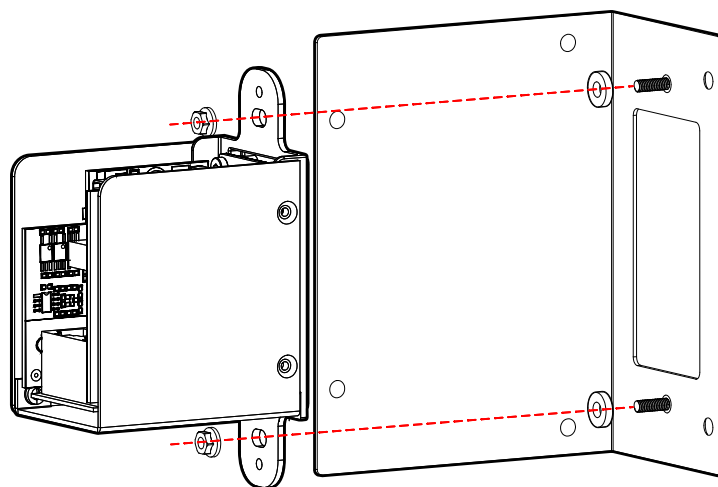


1. Remove (6x) torx-screws securing the control surface panel to the integrated multi-use mounting-bracket and separate. A qualified technician/electrician can then disconnect the data and power connectors from the control surface panel to the mounting case.

2. Depending on the Junction Box you are installing the control surface into, it may be necessary to remove the mounting bracket. If necessary, remove the (2x) nuts securing the control panel to the integrated multi-use mounting-bracket to the mounting case.

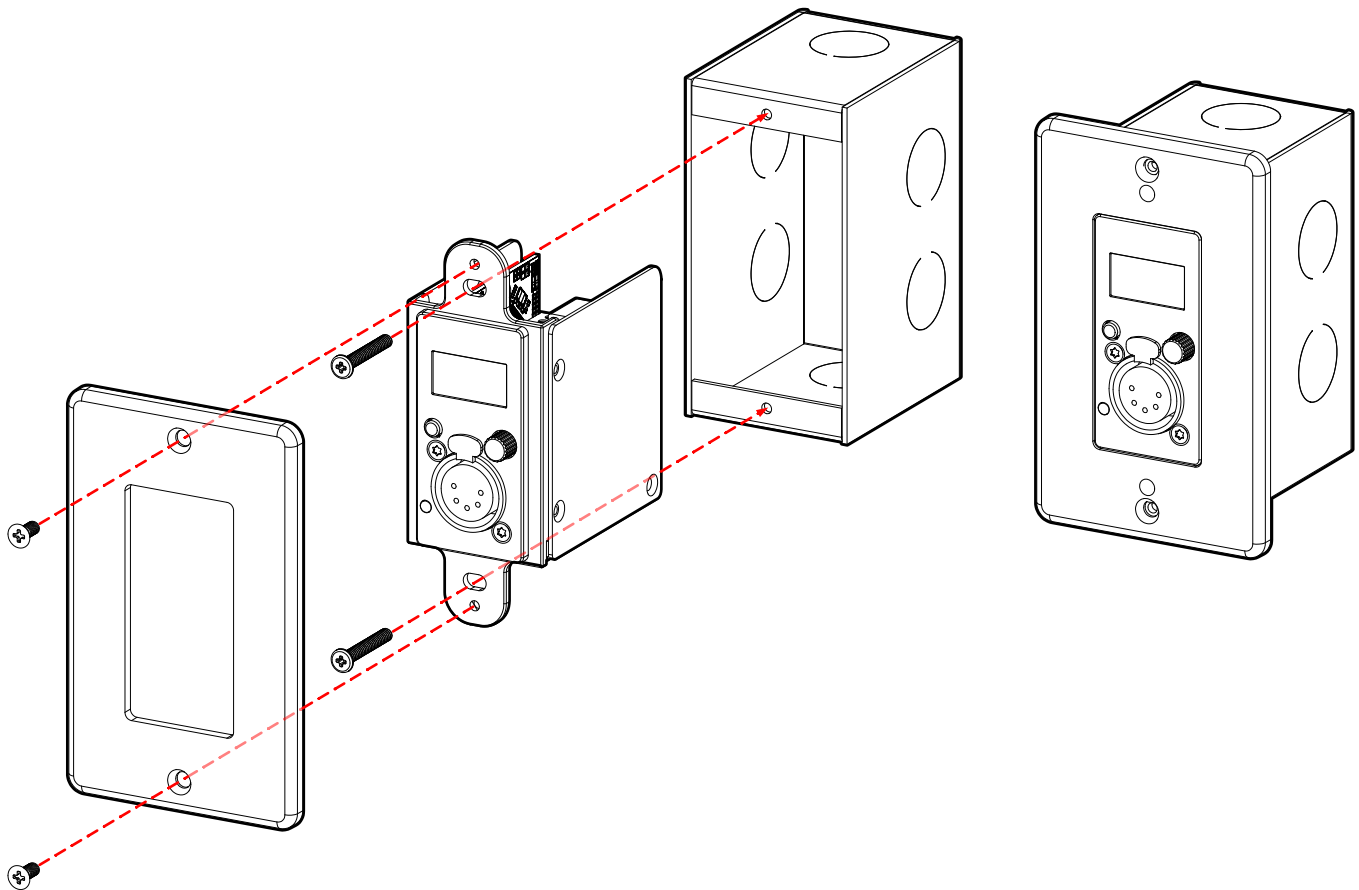
Wall-Mount/Panel Installation: Junction Box

1. Mount and secure the internal multi-use mounting-bracket to the junction-box with (2x) screws.

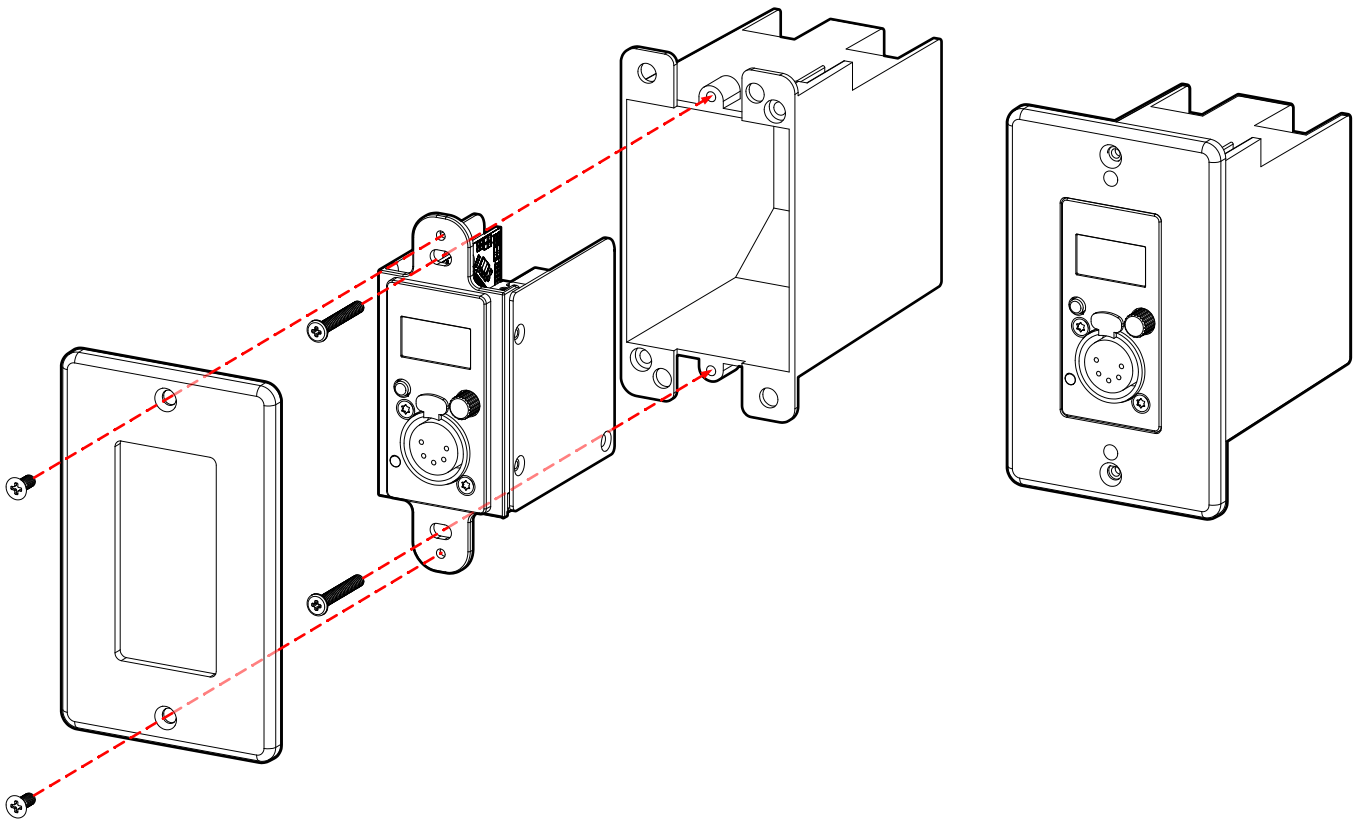
Wall-Mount/Panel Installation: American Standard Socket Junction Box

1. Mount and secure the internal multi-use mounting-bracket to the junction-box with (2x) screws.

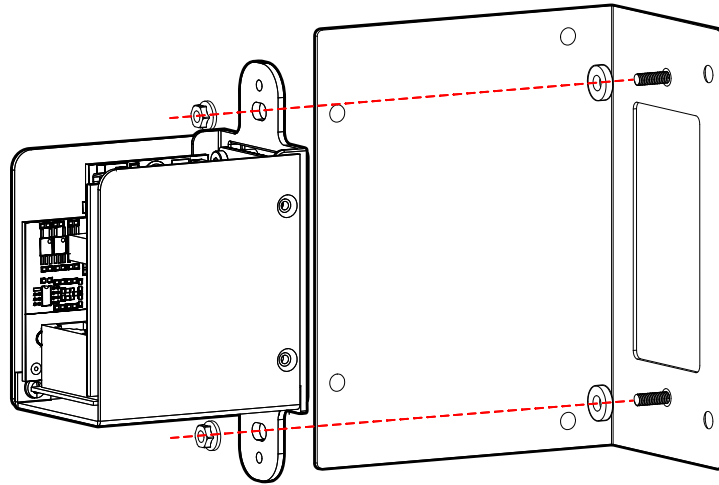
2. Secure the cover plate to the junction box with (2x) screws.



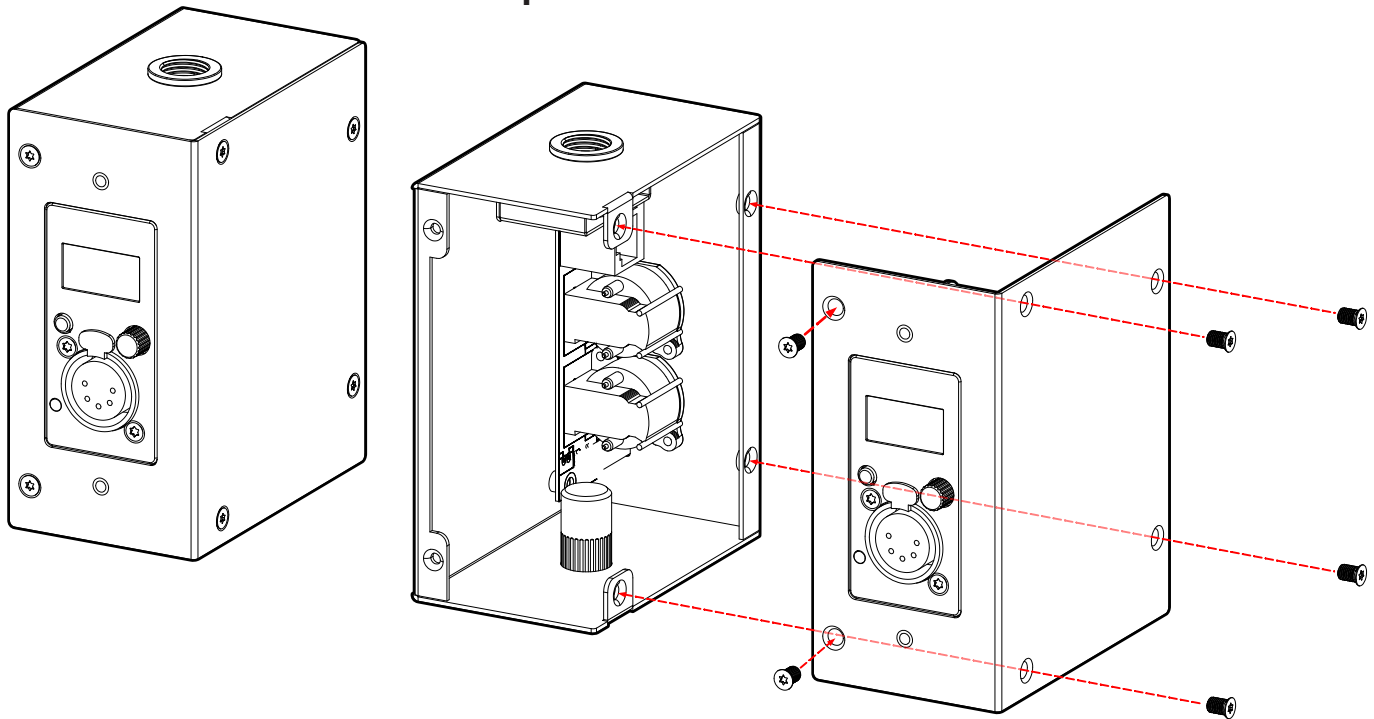
INSTALLATION INSTRUCTIONS

Wall-Mount/Panel Installation: Chassis Reassembly

To reconfigure the EP1 to its original form, remount the internal multi-use mounting-bracket to the case and secure it with (4) hex-screws.

Once a qualified technician/electrician has reconnected the control surface panel with the power and data connectors, the control surface panel can then be mounted and secured to the base assembly with (6) torx-screws.

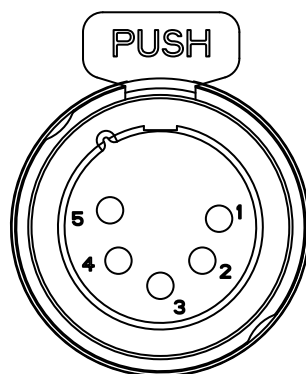
POWER CONNECTIONS:

The Obsidian Control Systems Netron EP1 is powered through USB-C or POE.

DMX CONNECTIONS:

All DMX Output connections are 5pin female XLR; the pin-out on all sockets is pin 1 to shield, pin 2 to cold (-), and pin 3 to hot (+). Pins 4 and 5 are not used. Carefully connect DMX cables to the respective ports. To prevent damaging the DMX ports, provide strain relief and support. Avoid connecting FOH Snakes to the ports directly.

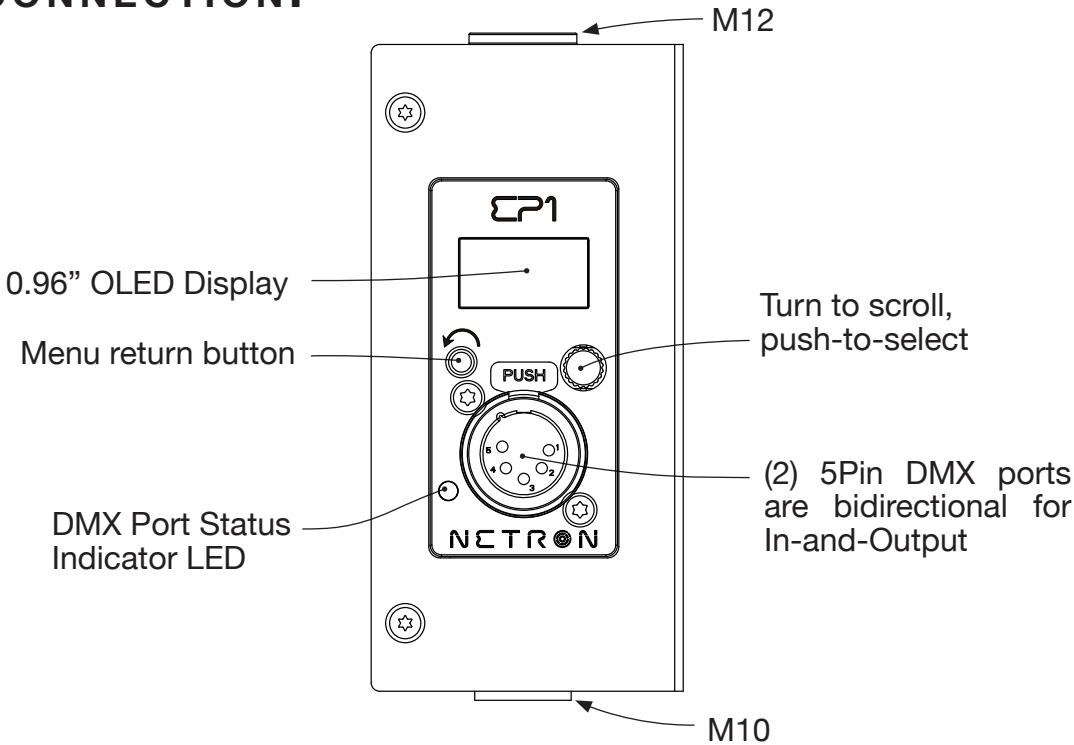
ETHERNET DATA CONNECTION

The Ethernet cable is connected on the side of the EP1 device. The device provides two gigabit connections, one with POE input support. POE power is not forwarded to the second port.

The Ethernet connection is also used to connect a computer to the EP1 for remote configuration via a web browser. To access the web interface, simply enter the IP address shown in the display in any web browser connected to the device. Information about the web access can be found in the manual.

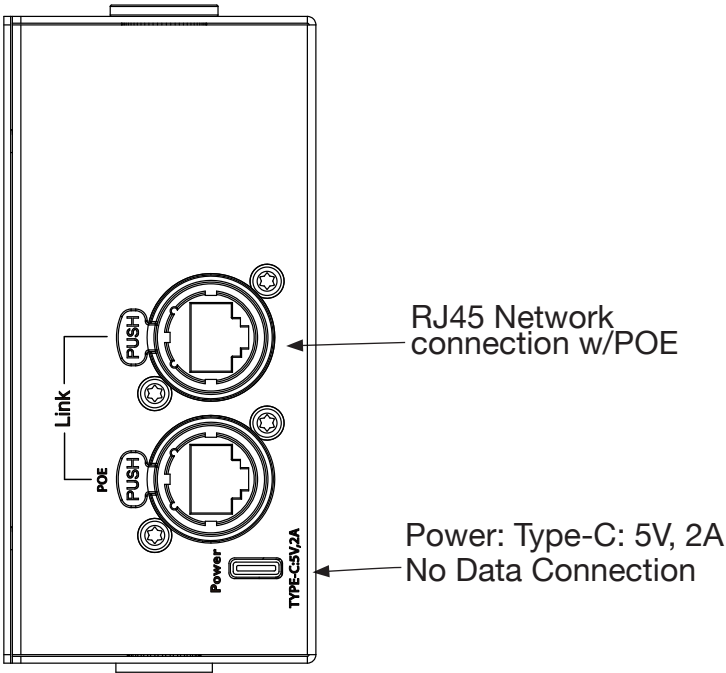

MAINTENANCE

The Obsidian Control Systems Netron EP1 is designed as rugged, roadworthy device. The only required service is occasional cleaning. For other service-related concerns, please contact your Obsidian Control Systems dealer, or visit www.obsidiancontrol.com.

Any service that is not described in this guide must be carried out by a trained and qualified Obsidian Control Systems technician.

As any computer, the EP1 requires periodic cleaning. The schedule relies on the environment in which the controller is operated. An Obsidian Control Systems technician can provide recommendations if necessary.

Never spray cleaner directly onto the device surface; always spray into a lint-free cloth and wipe it clean. Consider using cleaning products designed for cellphone and tablet devices.



Important! Excessive dust, dirt, smoke, fluid build-up, and other materials can degrade the performance of the EP1 device, causing overheating and damage to the unit that is not covered by the warranty.
