

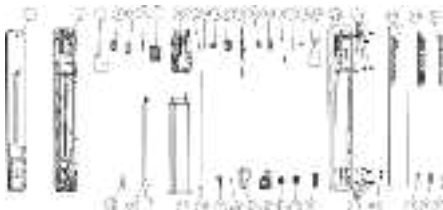

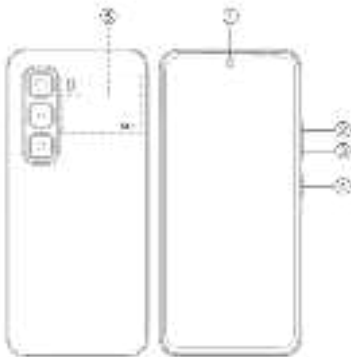

2. Refer to the following picture for SIM/SD card installation.

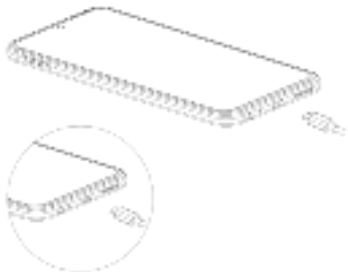


Charging the phone
