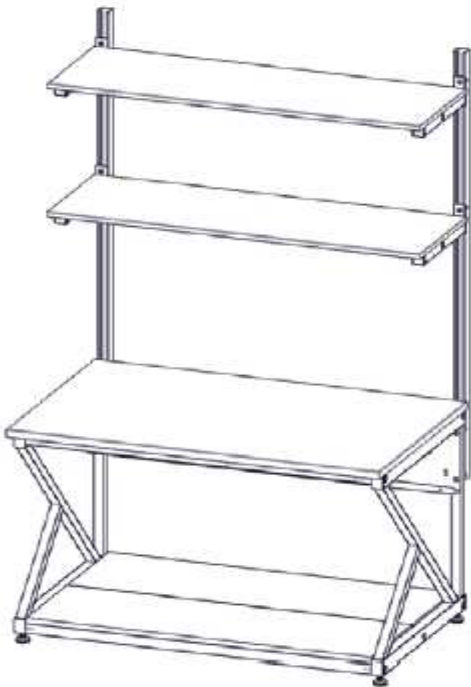

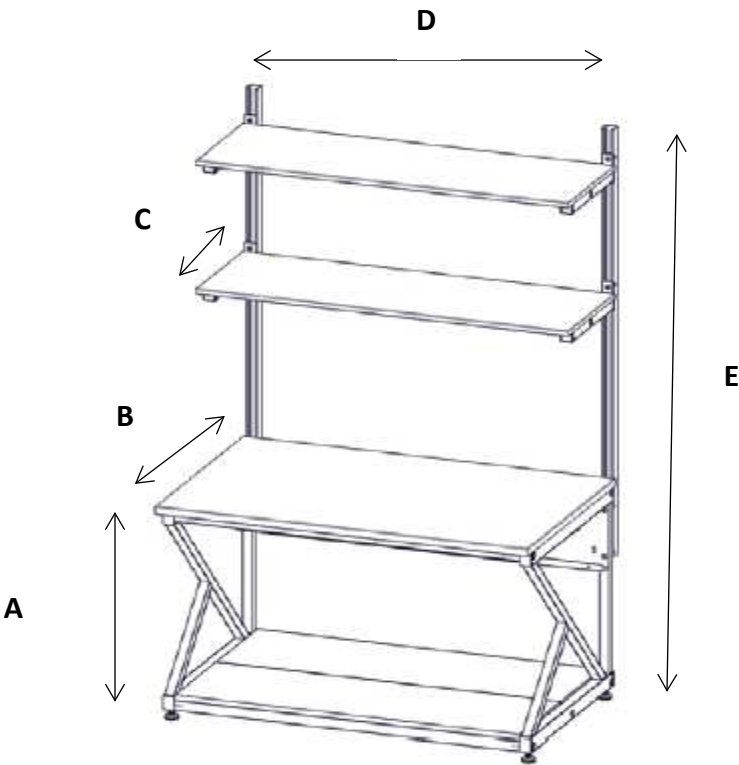

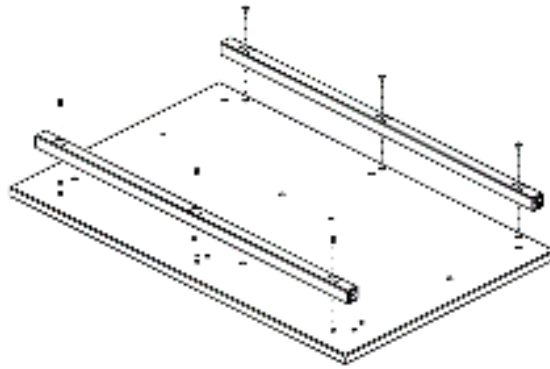

## Step 1:

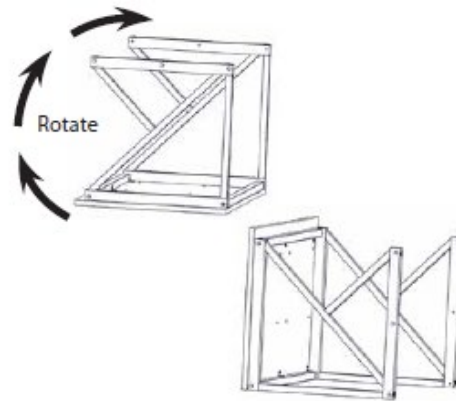
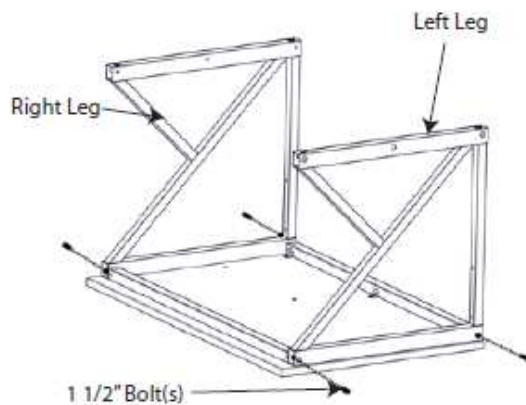
Remove all components from the crate. Place the worksurface on a sturdy working area with the screw holes facing up. Locate two cross bars and the ¼-20 screws. Install the screws as shown below.

## Step 2:

Locate the left leg, Install the bolts cross bars as to the back



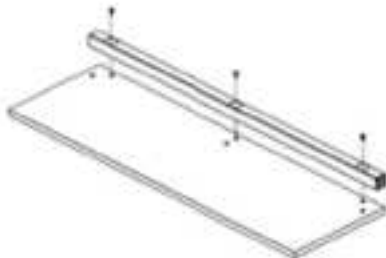
right leg and the 1 ½" bolts. through the legs into the shown. Rotate the table on surface.



## Step 3:

Locate two cross bars and the lower shelf. Attach the cross bars to the lower shelf with the ¼-20 screws.

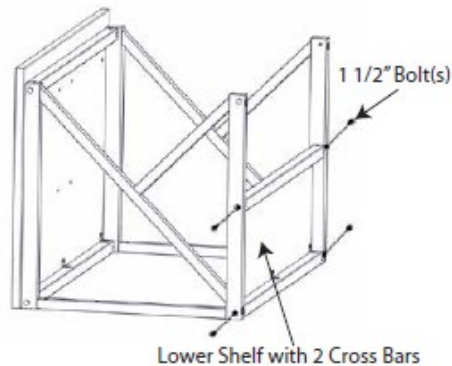
**Note: The 100 Series will have 1 lower shelf surface and the 200 series has 2.**

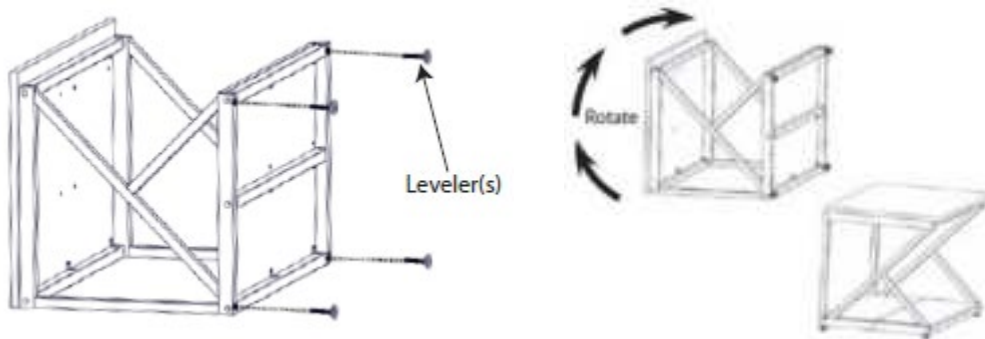
### Step 4:

Attach the lower shelf assembly to the bottom of the workbench with the 1 1/2" bolts.



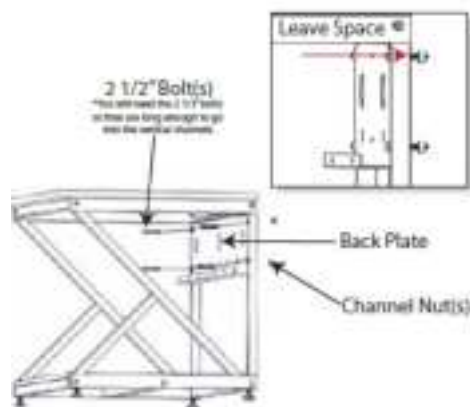
### Step 5:

Install the four leg levelers to the bottom of the workbench. If the optional castors were purchased, install the castors instead of leg levelers. Rotate the workbench on to the levelers.



### Step 6:

Locate the back panel, four 2 1/2" and four channel nuts. Align the back panel with the pre drilled mounting holes on the rear LAN station legs, loosely install the 2 1/2" bolts through the back panel.



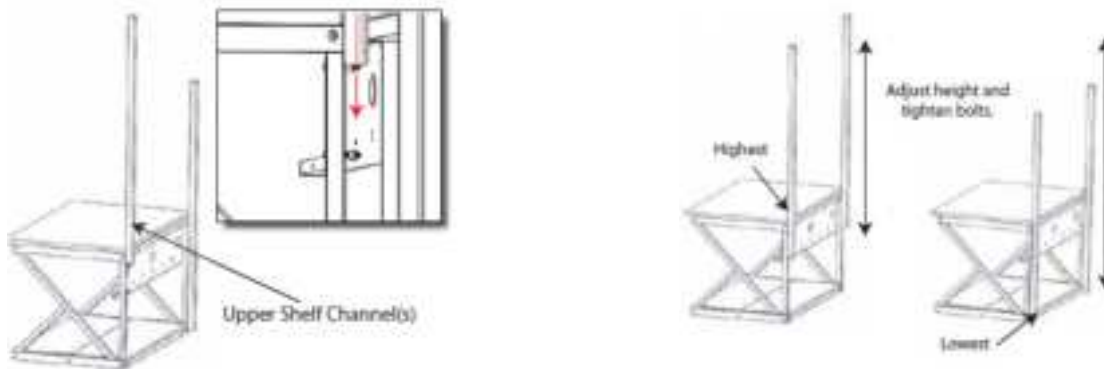
Note: The channel nut teeth should always face towards the bolt head.

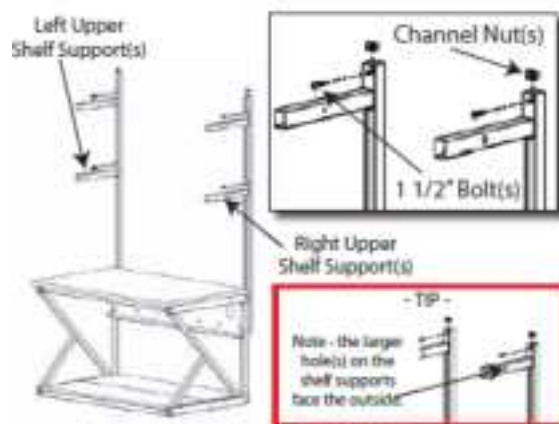
### Step 7:

Locate the upper shelf channels and slide them over the channel nuts as shown below. Adjust the height and fully tighten the bolts.



### Step 8:

Locate the four upper shelf supports, four 1 1/2" bolts and four channel nuts. Install the 1 1/2" bolt through the top mounting holes of the upper shelf supports, loosely install the channel nuts. Note that the larger holes on the shelf supports face outward. Slide the shelf supports into the upper shelf channels.



### Step 9:

Locate the upper shelves, cross bars, and 1/4-20 screws. Install the 1/4-20 into the shelves as shown below. Locate four 1 1/2" bolts and install through the upper shelf mounts and into the cross bar. Adjust shelf assembly to the desired height.

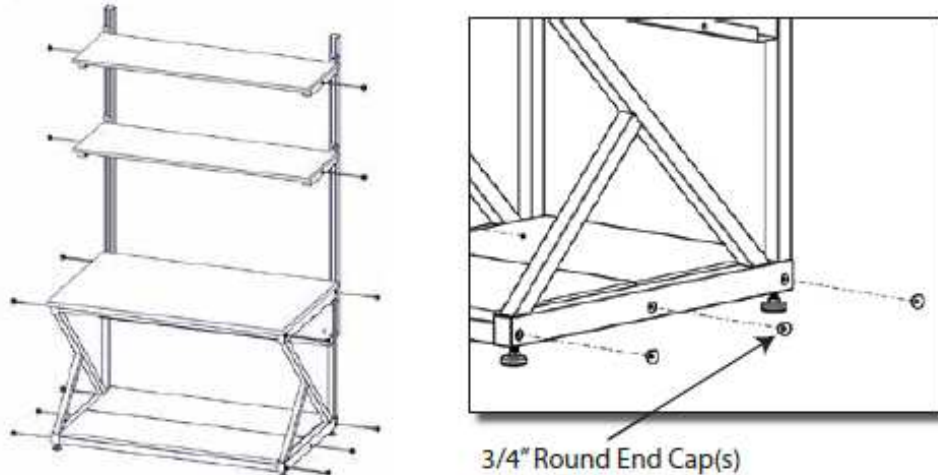

Locate three cross bars and the two lower shelves. Attach the cross bars to the lower shelves with the ¼-20 screws.

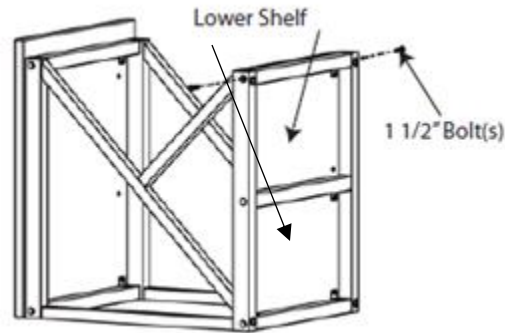

## Step 2. Assemble the Upper Shelves

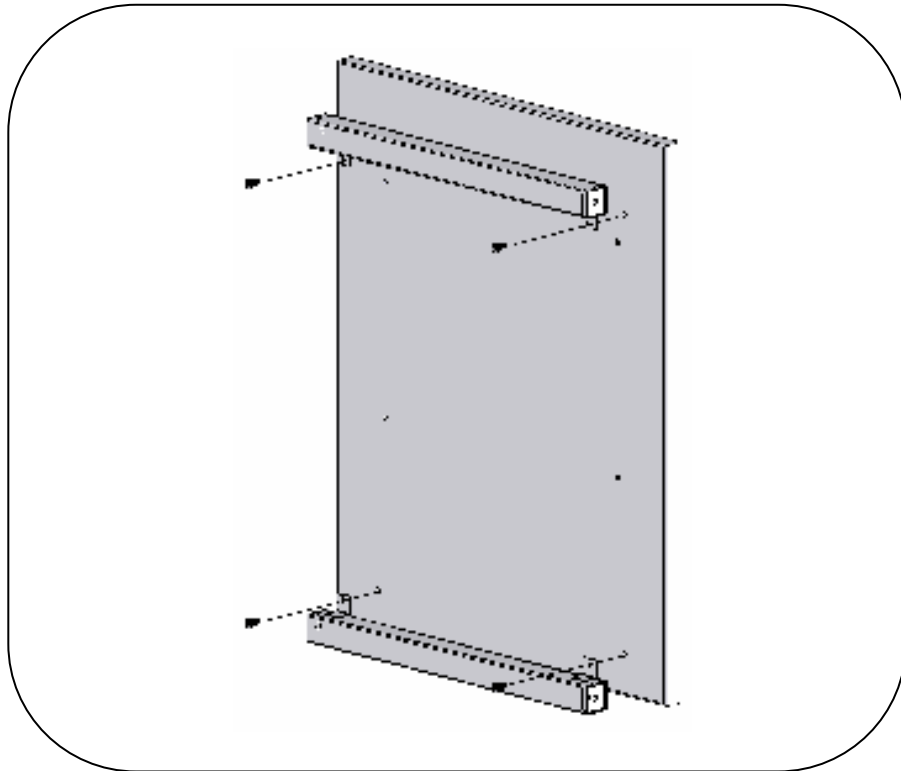
Place the upper shelves so that the hardware inserts are facing up. Next, place one of the cross bars on the shelf lining up the holes on the shelf with the brackets on the cross bar. Insert (2) cross head screws but **DO NOT FULLY TIGHTEN**. You will notice a small gap between the bracket and the shelf. This was designed so that after the bench is assembled, you will tighten all the cross head screws which will pull the shelf down tight against the frame.

With the shelves still in the same position as in step 2, place a left and a right shelf support on the shelf and attach with (2) 1 ½ Hex Drive Bolts.



### Step 3. Assemble the Work Surface

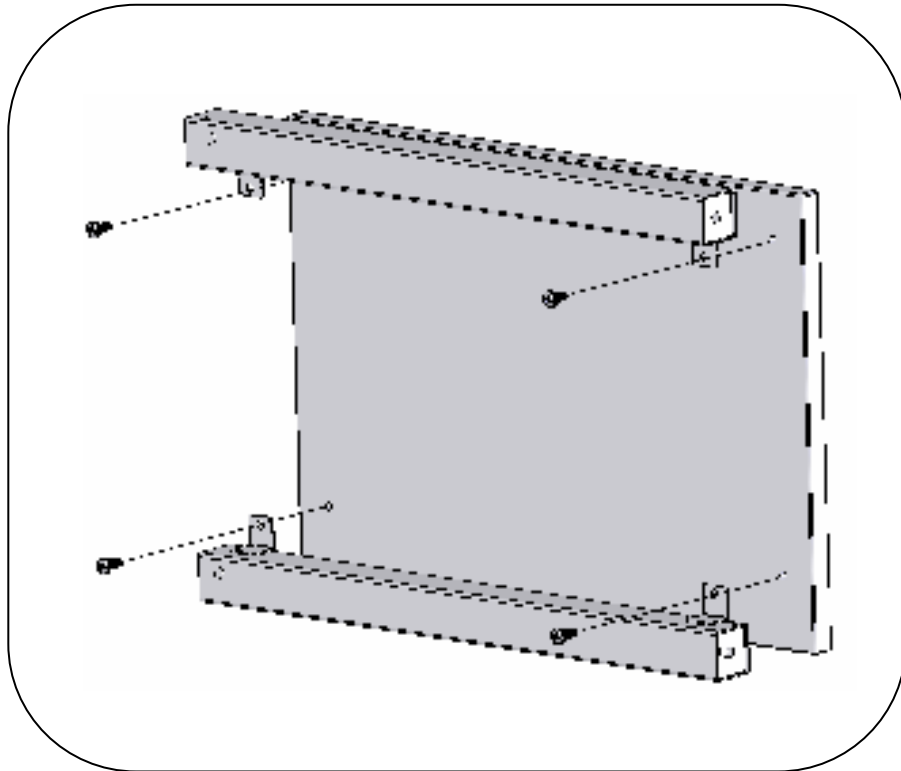
With the work surface placed with the hardware inserts facing up, attach 2 cross bars to the shelf with (4) cross head screws but **DO NOT FULLY TIGHTEN**. You will notice a small gap between the bracket and the shelf. This was designed so that after the bench is assembled, you will tighten all the cross head screws which will pull the shelf down tight against the frame.





## Step 4. Assemble the Lower Shelf

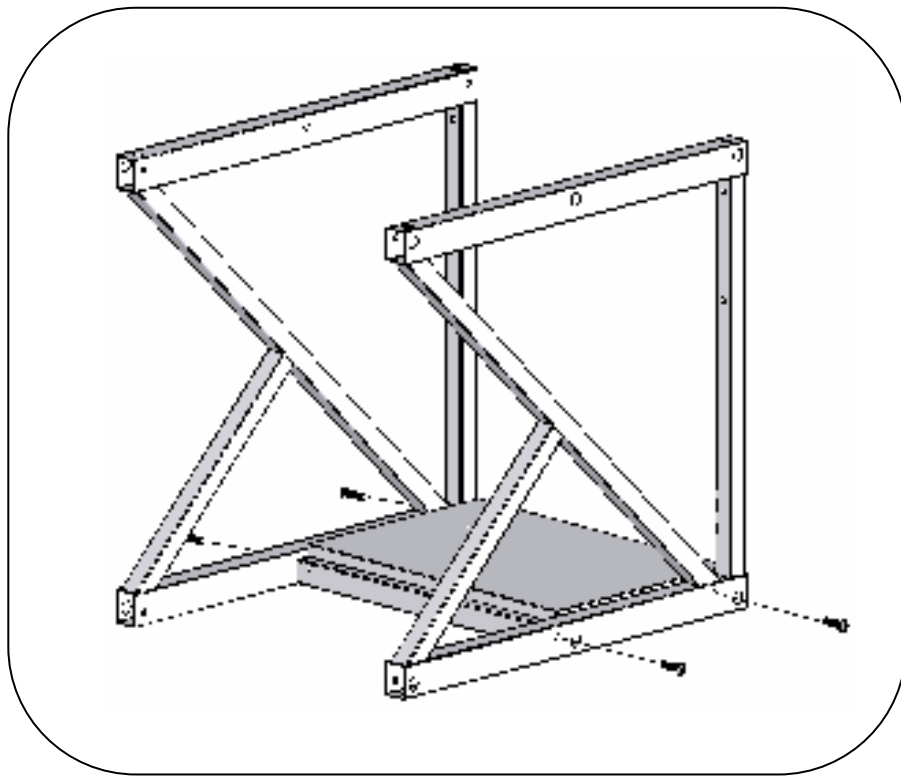
Place the lower shelf so that the hardware inserts are facing up. Next, place two of the cross bars on the shelf lining up the holes on the shelf with the brackets on the cross bar. Insert (4) cross head screws but **DO NOT FULLY TIGHTEN**. You will notice that one of the crossbars will overlap the shelf. This feature will be used if you purchased the bottom add-on shelf.



## Step 5. Frame Assembly

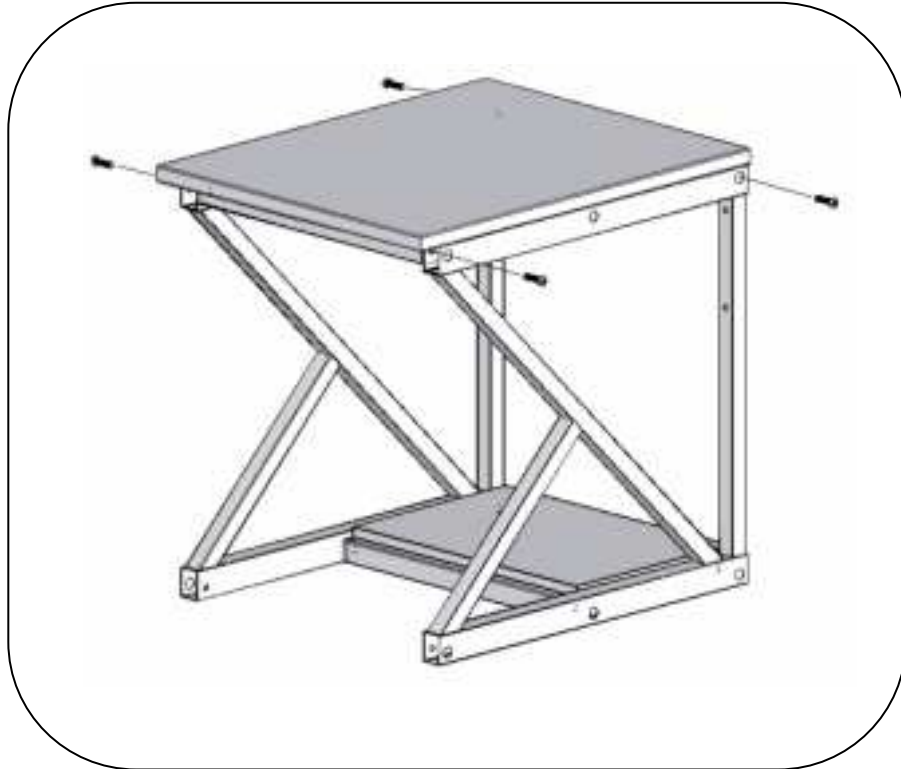
On this step you may want to have someone help you with the assembly. Attach the Lower shelf to left side with (2) 1 ½ Hex Drive Bolts. Next assemble the Right side in the same way. **DO NOT FULLY TIGHTEN YET.**

Screw in the (4) Levelers provided into the bottom of the frame (Not shown in the picture). If you purchased the optional caster kit, you may replace the levelers with the casters at this point.



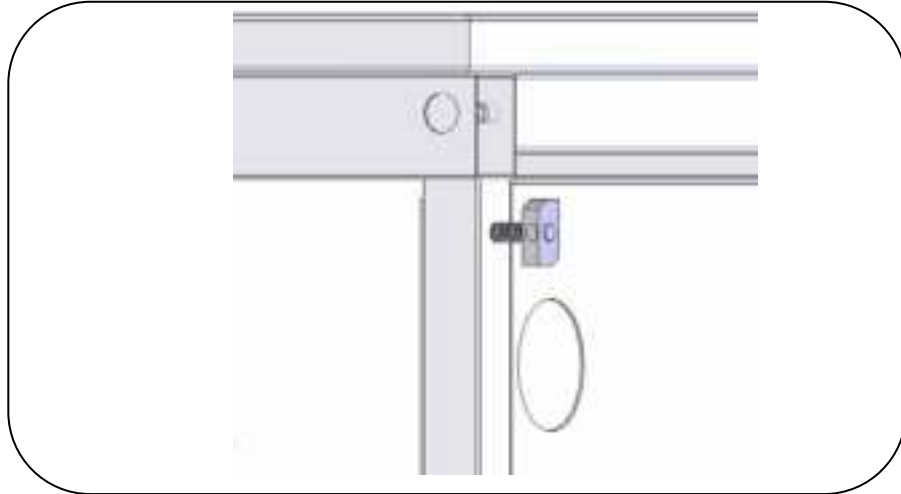
## Step 6. Attach the Work Surface

Stand the bench in its upright position and place the work surface on top of the bench. Attach work surface with (4) 1 ½ Hex Drive Bolts on each side. You may now tighten both the Hex Drive Bolts and the cross head screws on both the work surface and the lower shelf.

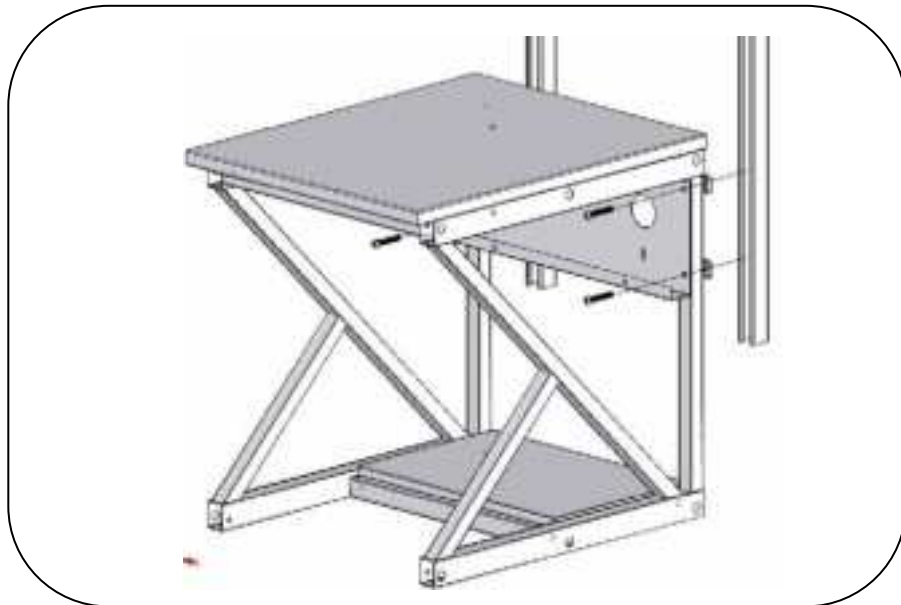


## Step 7. Attach Cable Tray and Shelf Channels

Place the Cable Tray/Shelf Support in the correct position and insert (4) 2 1/2" Hex Drive Bolts. Next, turn the Channel Nut onto each of the 4 bolts just until the nut is flush with the end of the bolt and pointing up. **IMPORTANT: MAKE SURE THAT THE GROOVES IN THE CHANNEL NUT ARE FACING THE BENCH.** There should be about 1" of space between the nut and the frame.

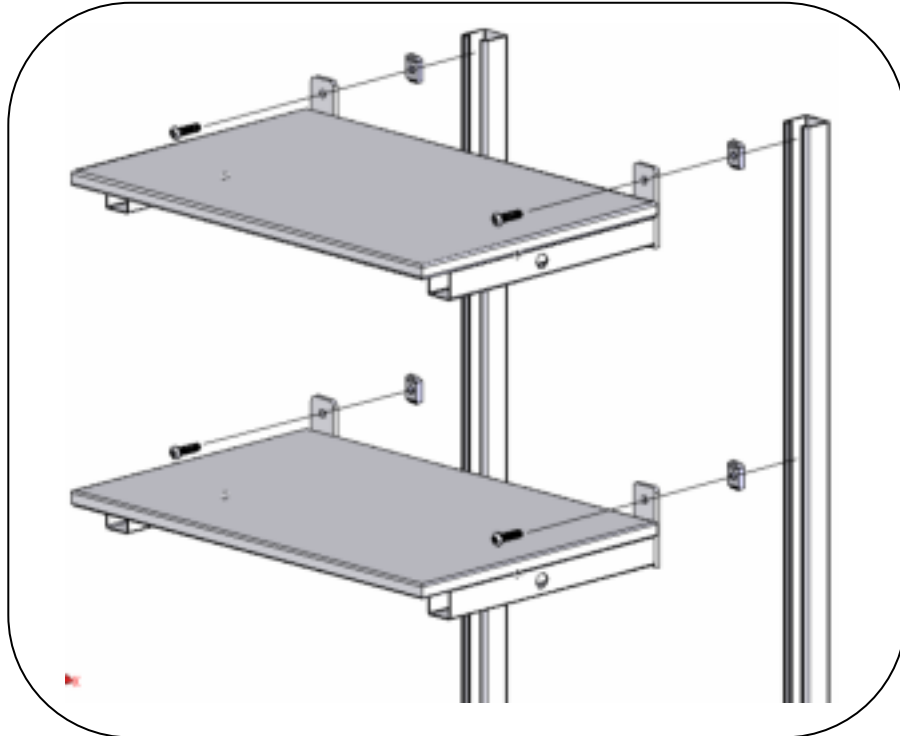


Hold the shelf channel over the (2) channel nuts while tightening the Hex Drive Bolts with T-Handle provided. As you tighten the bolts, the channel nuts will turn and lock into place. Make sure when completing this step that both channels are at the same height.



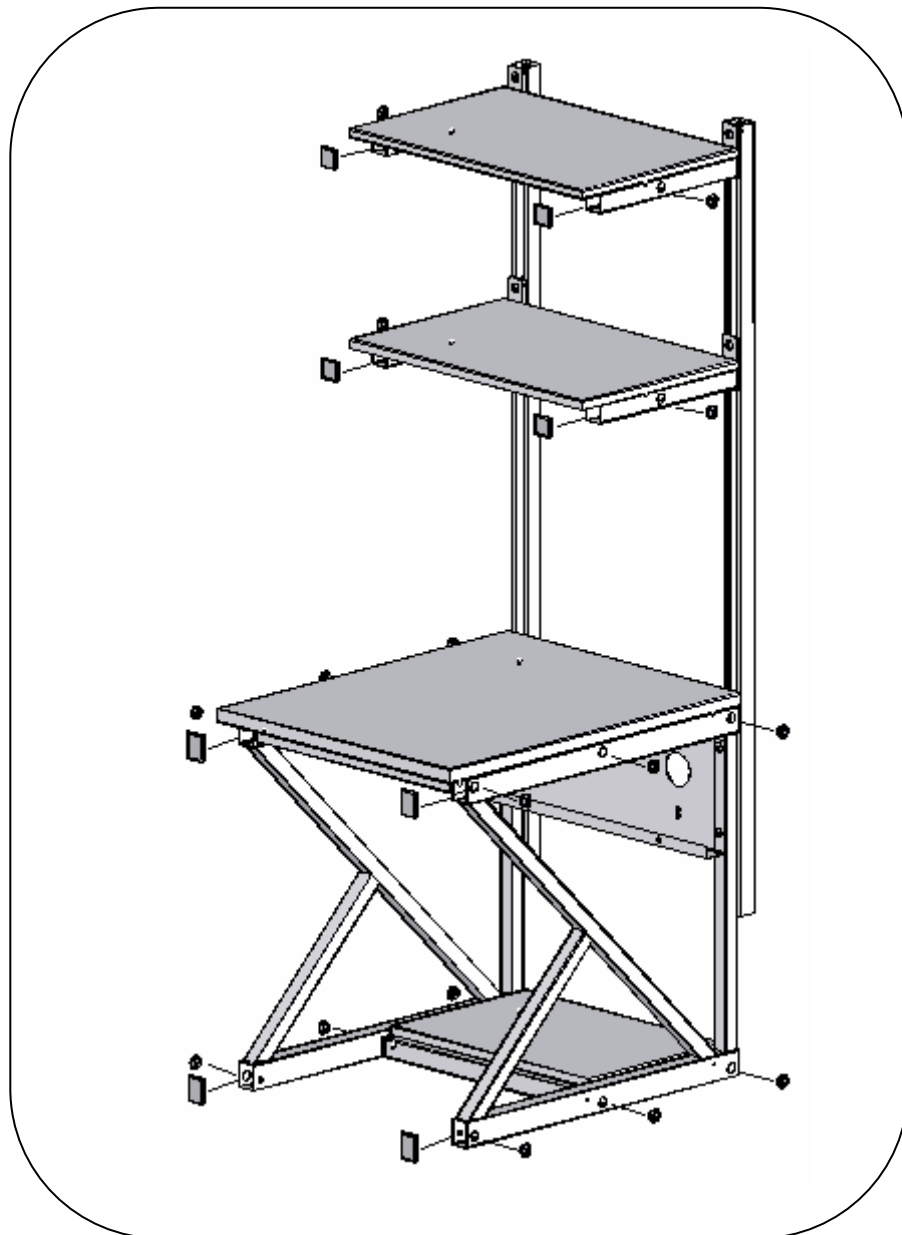
## Step 8. Attach Upper Shelves

Insert a 1 ½ Hex Drive Bolt into each shelf support hole and place a channel nut onto the bolt as you did for step 9. Remember to keep the hex bolt facing up and down. Place the shelf on the shelf channel with the channel nuts inside. Tighten the bolts and cross head screws. Make sure these bolts are very tight.



## Step 9. Add the Plastic End Caps

Insert the plastic end  $\frac{3}{4}$ " round caps into the left and right side frames as well as the upper shelf supports.
