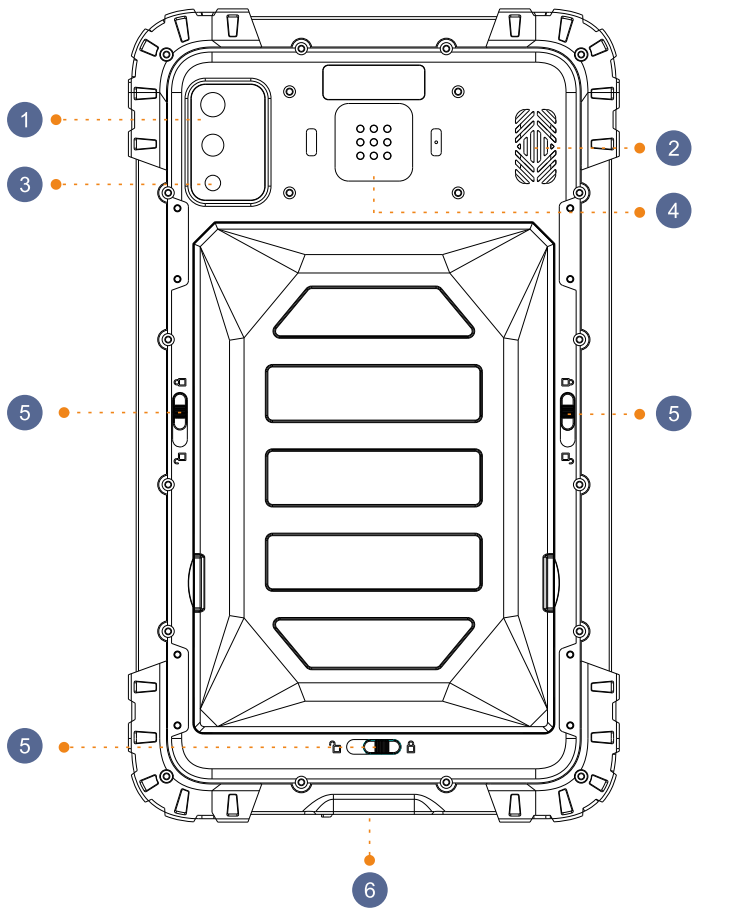

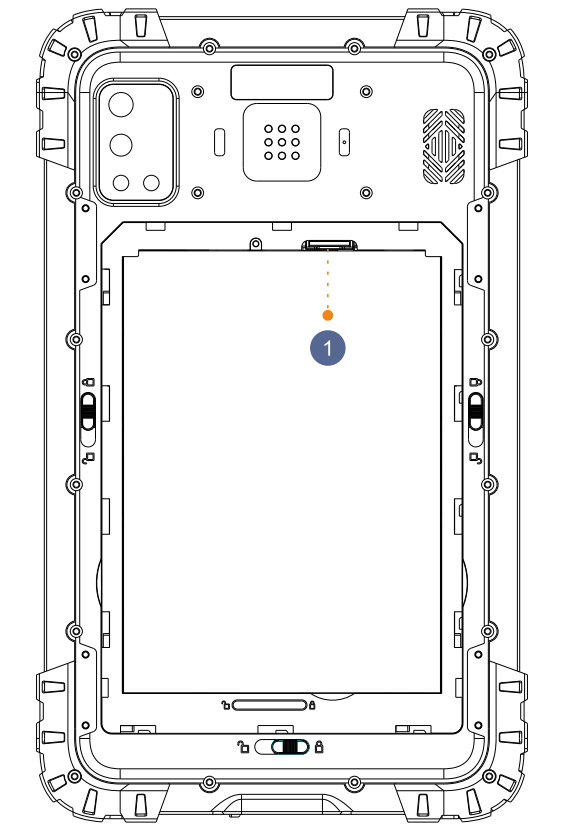
- 1 Sensor/Indicator

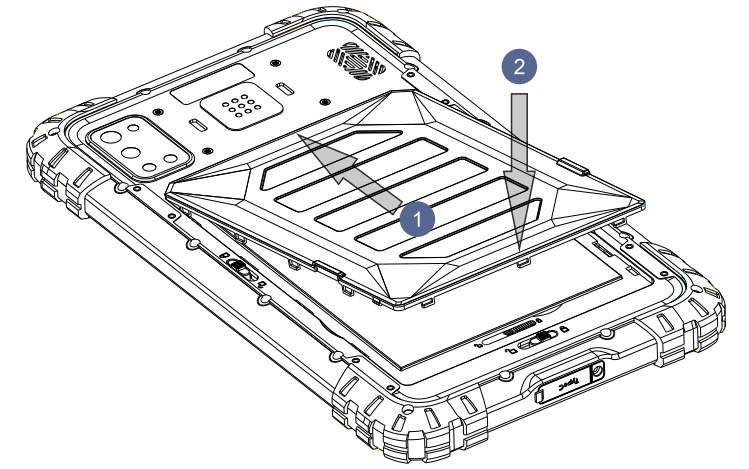
- 1 Rear Camera
