! WARNING

- DJI Action™ 2 contains magnets. Keep the camera unit away from magcards, IC cards, hard disks, RAM chips, implantable medical devices such as pacemakers, and other devices to avoid interference.
- All the holes on the camera unit have built-in waterproof material. DO NOT poke the holes. Clean the camera unit with a clean, dry cloth after using under water.
- DO NOT attach the camera unit to the front touchscreen module when there is any dust or water on the expansion ports. Otherwise, the camera unit may corrode or short-circuit.
- Put out any product fire using water, sand, fire blanket, or a dry powder fire extinguisher.
- The product should be used in temperatures from 0° to 40° C (32° to 104° F). Use of the product in environments above 40° C (104° F) can lead to a fire or explosion. Use of the product below 0° C (32° F) can lead to permanent damage.
- Never disassemble or pierce the product in any way or the battery may leak, catch fire, or explode.
