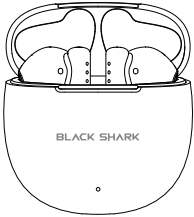

### Enter pairing mode

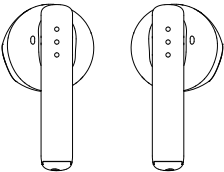
Open the charging case and take out the headphones and enter pairing mode
